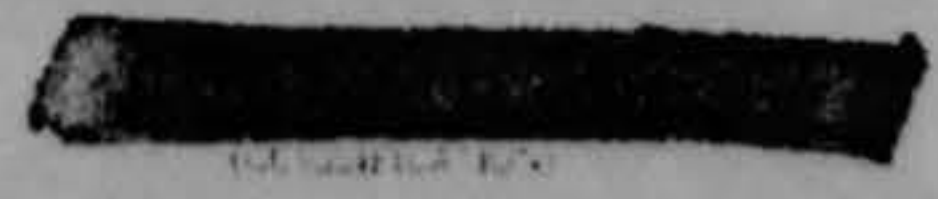

1. An unidentified aerial object was visually observed from the ground by a number of military personnel southwest of Pepperrell Air Force Base, Newfoundland, 21 June 1953, at 1545Z.

2. The object, described as a tiny silver-tan object, but not metallic silver, was at an estimated altitude of 30,000 feet. The object was semi-stationary and was not seen to carry out any maneuvers. Object did not emit an exhaust trail or sound.

3. The object was still visible at 1630Z, or a total period of observation of 45 minutes. The object was observed and first reported by Major [redacted] (Senior Pilot), commander of 6610th Air Base Sqdn., McAndrew AFB, Newfoundland, and six other personnel from the same location (baseball field).

4. No GCI or GCA contact was made with the object. Weather sequence was: 3000 broken, 15 miles visibility, surface winds NW, 22K plus to 34K, winds aloft 30,000 feet 330 degrees at 120K.

COMMENTS of the Preparing Officer:

1. It was first believed that the object was a weather balloon. Checks were made with the various weather offices in Newfoundland, and it was learned that Ernest Harmon AFB released a balloon 45 minutes prior to the time of sighting. Winds over Harmon were: 28,000 feet, 320 degrees at 188K. Pepperrell AFB is approximately 230 miles ESE of Ernest Harmon AFB; these extremely high winds were traveling in the general direction Harmon to Pepperrall. However, the balloon was tracked for a period of 34 minutes at Harmon. Contact was lost with the balloon when it was 30 miles distant at 27,300 feet. Since the balloon was of the radiosonde type, a positive burst could not be determined, although analysis of returns indicated a probable burst. Moreover, the balloon, having consumed 34 minutes and gone only 30 miles, would have to travel the remaining 200 miles in 11 minutes, thus eliminating the possibility that the Harmon balloon accounted for the sighting.

2. A balloon was also released from McAndrew AFB, approximately 90 miles southwest of Pepperrell AFB. This balloon was released the night before the sighting, on 20 June 1953, and from an analysis of winds, it was determined that this balloon also could not account for the sighting.

3. It is considered very unlikely that the object was an aircraft because of the long duration of the sighting and the hovering nature of the object. The possibility of celestial or meteorological conditions causing the sighting does exist.

4. The Director of Intelligence, NEAC evaluates this incident as an unidentified aerial object.

The San Antonio 16 June is clearly a meteorological phenomeon and one that would warm the heart of Menzel. This was undoubtedly as suggested, namely the light of the setting sun on a high cloud.

Referring to the follow-up statement on the 10 June Detroit case, both Jennie and I still think this was a landing light and agree it could not have been a meteor.

Business is a little slow. Jen is going ahead with requesting cooperation from the air control tower operators. Her usefulness has increased in view of her temporary clearance and I hope that her full clearance will not be too long in coming.

I hope we can see you soon and wish you a bon voyage into Law School.
