ECLIPSES.

There will be two Eclipses of the Sun, and one of the Moon, this year.

I.—An Annular Eclipse of the Sun on Monday, June 6, invisible in this Island.

Begins on the Earth generally at 35m. past 1 p. m. in Longitude $156^{\circ} 48' W.$, and Latitude $23^{\circ} 23' S.$

Ends on the Earth generally at 35m. past 7 p. m. in Longitude $77^{\circ} 52' W.$, and Latitude $1^{\circ} 42' S.$

II.—A Partial Eclipse of the Moon on Tuesday, June 21, visible in this Island.

First Contact with Shadow 1 hour 41 min., a. m.

Middle of Eclipse 2 " 29 " "

Last Contact with Shadow 3 " 17 " "

At these times respectively the Moon will be in the Zenith of the places whose positions are:—

In Longitude $78^{\circ} 32'$	Latitude $24^{\circ} 29'$
90 6	24 32
101 39	24 34

The apparent position of the Moon with regard to an observer in St. John's will be identical with that of the sun at half-past two p. m., on the same day.—Magnitude of the Eclipse, 1-5th of the Moon's Disc, on the Northern limb. The first contact with the shadow occurs at 33° from the Northernmost point of the Moon's limb towards the East. Last contact at 21° towards the West.

III.—A Total Eclipse of the Sun on Wednesday, November 30, invisible in this Island.

Begins on the Earth generally, November 30th, at 5m. past 12, (noon), in Longitude $153^{\circ} 56' W.$ Latitude $19^{\circ} 47' N.$

Ends on the Earth generally, November 30, at 20m. past 6 p. m., in Longitude $57^{\circ} 49' W.$ Latitude $7^{\circ} 35' S.$

This Eclipse will be central and total on the Meridian, in Longitude $110^{\circ} 18' West$, and Latitude $11^{\circ} 20' South$, at 3h. 38m. in the evening.

EQUINOXES AND SOLSTICES FOR 1853.

Spring Equinox (Sun crosses the line) March 20d. 0h. 53m. p. m.

Summer Solstice (Sun farthest North) June 21d. 9h. 51m. a. m.

Autumn Equinox (Sun re-crosses the line) Sept. 23d. 0h. 4m. a. m.

Winter Solstice (Sun farthest South) Dec. 21d. 5h. 40m. p. m.

The above is given in St John's mean (civil) time, and the Longitudes are all reckoned from Greenwich.

Description of the Lights.—Fort Amherst—This is a Stationary Light, on the Southern head of the entrance of St John's Harbour. Cape Spear—This is a powerful Revolving Light burning at an

elevation of 275 feet above the level of the sea, and showing a brilliant flash at intervals of one minute; in clear weather it may be seen from sea, in any direction, at the distance of 30 miles.

Harbour Grace—This is a powerful Fixed Light situated on Harbour Grace Island, in Conception Bay, extending Eastwardly or seaward in a direction by Compass from North-east to South-west. Bonavista—This Light revolves every two minutes, showing a red and white flash, alternately; and is elevated 150 feet above the level of the sea. St. Peter's—A Light House has been erected by the French Government on Gallantry Head, near Cape Noir; the light is a fixed one, it burns at an elevation of about 210 feet above the level of the sea; it may be seen (in passing by the S) from WNW to NNE, at the distance of 18 or 20 miles in clear weather; in passing by the N., it is shut in by high land from NNE to WNW.

Cape Pine—The character of this Light is that of a Brilliant Revolving Light, of which the greatest intensity will be apparent in every direction seaward *twice in a minute*; it will burn at an elevation of 302 feet above the level of the sea, and will be visible in clear weather at a distance of 30 miles; the erection is a Round Tower 50 feet high, painted with Bands of Red and White (horizontally) alternately. Cape Race Beacon—The total height of this Beacon is 65 feet; it stands on the rising ground 140 feet high, immediately behind Cape Race Rock, so that the top of the Beacon is at an elevation of 205 feet above the sea level; it is of hexagonal shape, 22 feet in diameter at the base, and 11 feet on each face; it tapers upwards to a height of 56 feet, where its diameter is but 2 feet 9 inches, and is then surmounted by a Skeleton Ball 9 feet in diameter—making the total height 65 feet; it is constructed of timber framework with exterior clap-boarding, and its faces are painted alternately White and Red (vertical) and the Ball at the top Red.

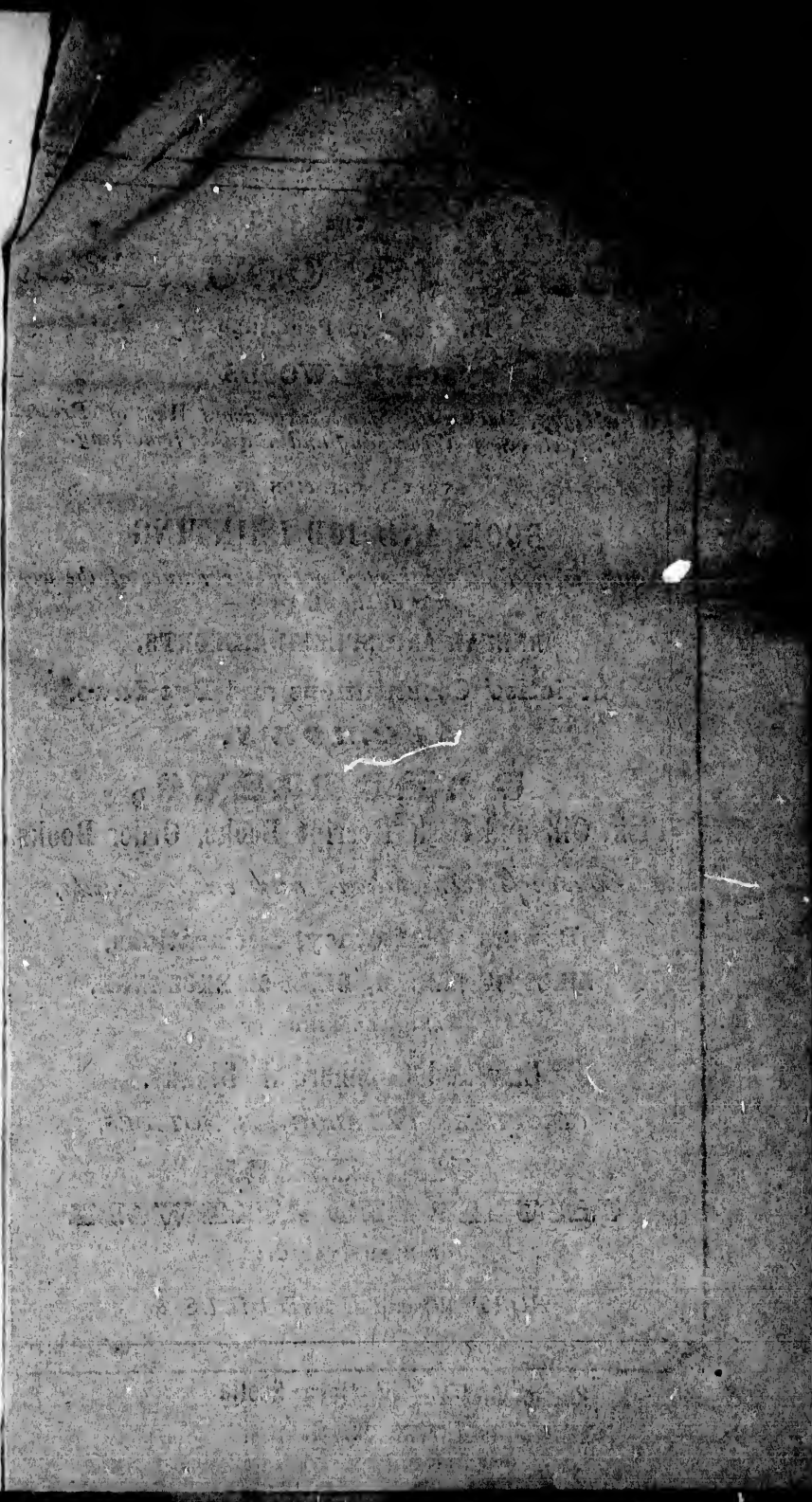
