Subject : Re. execution of the suspension of the publication against the "Voice of Peace" and disposition taken against the violation of the Government Ordinance No.325

The special investigation bureau of the Attorney-General's Office has, on January 23, executed the suspension of the publication against the "Voice of Peace" (HEIWA NO KOE), which was designated as a substitute for the "AKAHATA", Communist organ paper, and indicted the parties concerned in accordance with the directive contained in the letters of Gen. MacArthur of June 26 and July 18, last year, as the result of which 25 persons were arrested and the publishing office and 10 other places were raided for search and the items concerned were seized or sealed as below-mentioned:

Subject : Re. action taken against the violations of the administrative ordinance No.325 following the execution of the suspension of publication against the "Voice of Peace" (REPORT No.2)

As reported previously, we have, on January 23, executed the suspension of publication against the "Voice of Peace" published by the Heiwa-no-tomo-sha, which was designated as a substitute for the AKAHATA, now-defunct Communist organ paper and indicted the parties concerned, but we, further on January 26, seized 120,000 copies of the same and arrested 9 persons on the charges of forwarding them with the co-operation of the Special Investigation Bureau and police stations under jurisdiction. The following is the report in particular of the above subject.
