Community Gathering Discusses Incorporation and Nominates Its Own Candidates

If any argument were necessary to further and promote sentiment in favor of the incorporation of Carmel, it was supplied in large measure by the enthusiastic multitude of men and women who crowded into Carmel Hall last Friday evening in response to a call for a mass meeting to nominate candidates for the various city offices.

The meeting was called to order by Mr. Perry Newberry, who in a few well-chosen remarks explained the purposes of the meeting, at the conclusion of which the meeting was placed in the hands of the people, and nominations for a permanent chairman were called for.

Mr. George F. Beardsley was placed in nomination by W. L. Overstreet and their being no other nominees, Mr. Beardsley took the chair, with Mr. C. O. Gould as secretary.

The chairman was well equipped to answer the many questions regarding various angles of the incorporation scheme.

It was clearly pointed out that the fact that the neck of land known as the south end peninsula being not included within the limits of incorporation in no manner whatever interferes with the benefits to be derived from incorporation.

It is the opinion of many that the boggy of excessive and unreasonable taxes, which is groundless, because the tax is limited by State law—prompts the bringing forward of the

peninsula argument. It is the general belief that had this piece of territory been included the opponents of incorporation would have seized that fact upon which to base objection.

The particular business for which the mass meeting was called was then proceed with. Twenty-one candidates were placed in nomination for city trustee, of which the ten receiving the highest number of votes were put forward as the choice of the meeting, five of whom may be voted for on October 26.

There were also placed before the people two candidates each for city clerk and for city treasurer.

In addition to the list given herewith, voters may write in any name desired.

Election Proclamation

AN ORDER PROVIDING FOR the organization and incorporation of a certain described district of country, in the county of Monterey, State of California, as a municipal corporation, under an Act of the Legislature of the State of California, entitled "An act to provide for the organization, incorporation and government of municipal corporations," approved March 13, 1883, and the amendments thereto; to provide for a name therefor, establish the boundaries thereof, and call an election within said territory to determine whether the same shall be so organized, and to provide for an election of the elective officers of said proposed corporation.

WHEREAS, at a regular meeting of the Board of Supervisors of the County of Monterey, State of California, held on the 5th day of September, 1916, at its regular meeting room, in the Court House, in Salinas City, County of Monterey, State of California, there was presented to said Board a petition praying for the incorporation of the following described district of country in said County of Monterey, State of California, to-wit:

All that portion of the County of Monterey which is included within a line beginning at a point at the Southeastern corner of Addition Number Five to the Town of Carmel-by-the-Sea, running thence westerly along the southern boundary line of said Addition Number Five to the westerly side of Junipero Avenue; thence westerly along the southerly side of Twelfth Avenue to the easterly side of Mission Street; thence southerly along said easterly side of Mission Street four hundred fifty feet, more or less, to the intersection of the County Road; thence southerly along the easterly side of said County Road to a point intersected by the southerly side of Santa Lucia Avenue, projected; thence westerly along said southerly side of Santa Lucia Avenue to the Pacific Ocean; thence northerly along the line of the shore of said Pacific Ocean to the dividing line between the lands of F. H. Powers and the Pescadero Rancho; thence easterly along the southerly boundary line of the Pescadero Rancho to the westerly side of Lincoln Street; thence northerly along the westerly side of Lincoln Street to the northerly side of First Avenue; thence easterly along said northerly side of First Avenue to the westerly side of Dolores Street; thence northerly along said westerly side of Dolores Street to the northerly side of Vista Avenue; thence easterly along said northerly side of Vista Avenue to the westerly side of San Carlos Street; thence northerly along said westerly side of San Carlos Street to the northerly side of Alta Avenue; thence easterly along said northerly side of Alta Avenue to the easterly side of Junipero Avenue; thence southerly along said easterly side of Junipero Avenue to a point of intersection with the said southerly line of Pescadero Rancho; thence easterly along said southerly line of Pescadero Rancho, about fifty feet more or less to the easterly side of Junipero Avenue; thence southerly along said easterly side of Junipero Avenue to the northerly line of the subdivision of old Carmel City; thence easterly along said northerly line of Carmel City to the easterly line of Carmel City; thence southerly along a portion of the easterly line of old Carmel City and the easterly side of the subdivision of Paradise Park and a portion of the easterly line of the subdivision of Addition Number Five of the Town of Carmel-by-the-Sea to the place of beginning; as a municipal corporation of the class to which the same might belong under an act of the Legislature of the State of California, entitled "An Act to provide for the organization, incorporation and government of municipal

corporations" approved March 13th, 1883, and the amendments thereto, which petition was accompanied by an affidavit of three of the qualified electors of said Monterey County, residing within the limits of the territory described in said petition, that all of said persons who have signed said petition are qualified electors of the County of Monterey, State of California, and reside within the limits of said proposed municipal corporation, there being more than fifty signatures to said petition;

AND WHEREAS, on said 5th day of September, 1916, there was presented to said Board proof to its satisfaction of the publication of said petition, together with notice that the same would be presented at a meeting of said Board on the 5th day of September, 1916, which said publication was made for more than two consecutive weeks prior to and immediately preceding said presentation in the Carmel Pine Cone, a weekly newspaper of general circulation, printed and published within the boundaries of said proposed municipal corporation; and due proof having been presented to this Board showing that there is a resident population of more than five hundred (500) and less than thirty-five hundred (3500); to-wit: a resident population of five hundred and twenty-four (524) persons within the limits of the territory described in said petition.

WHEREUPON, said Board, after hearing said petition and the evidence adduced, finds and determines as facts the following:

1. That no part of the territory within the boundaries described in said petition is incorporated under any law or laws as a municipal corporation.

2. That said territory contains a resident population of more than five hundred (500) and less than thirty-five hundred (3500), to-wit: a resident population of five hundred twenty-four (524) persons.

3. That said petition was signed by fifty or more residents and qualified electors within the County of Monterey, State of California, and residents and qualified electors within the boundaries of the territory described in said petition.

4. That said petition, together with a notice of the time and place when the same would be presented to this Board, was published for two successive weeks prior to and immediately preceding the time when the same was presented in the Carmel Pine Cone, a weekly newspaper of general circulation, printed and published within the boundaries of said proposed municipal corporation.

5. That said petition was, at the time and place stated in said notice presented to this Board.

WHEREFORE, it is now ordered by the Board that the boundaries of the corporation in said petition prayed to be organized as a municipal corporation, under an act of the Legislature of the State of California, entitled "An act to provide for the organization, incorporation and government of municipal corporations," approved March 13th, 1883, and the amendments thereto, are established and defined to be the same described in said petition, to-wit:

All that portion of the County of Monterey which is included within a line beginning at a point at the Southeastern corner of Addition Number Five to the Town of Carmel-by-the-Sea, running thence westerly along the southern boundary line of said Addition Number Five to the westerly side of Junipero Avenue, thence westerly along the southerly side of Twelfth Avenue to the easterly side of Mission Street; thence southerly along said easterly side of Mission Street four hundred fifty feet, more or less, to the intersection of the County Road; thence southerly along the easterly side of said County Road

to a point intersected by the southerly side of Santa Lucia Avenue, projected; thence westerly along said southerly side of Santa Lucia Avenue, to the Pacific Ocean; thence northerly along the line of the shore of said Pacific Ocean to the dividing line between the lands of F. H. Powers and the Pescadero Rancho; thence easterly along the southerly boundary line of the Pescadero Rancho to the westerly side of Lincoln Street; thence northerly along the westerly side of Lincoln Street to the northerly side of First Avenue; thence easterly along said northerly side of First Avenue to the westerly side of Dolores Street; thence northerly along said westerly side of Dolores Street to the northerly side of Vista Avenue; thence easterly along said northerly side of Vista Avenue to the westerly side of San Carlos Street; thence northerly along said westerly side of San Carlos Street to the northerly side of Alta Avenue; thence easterly along said northerly side of Alta Avenue to the easterly side of Junipero Avenue; thence southerly along said easterly side of Junipero Avenue to a point of intersection with the said southerly line of Pescadero Rancho; thence easterly along said southerly line of Pescadero Rancho, about fifty feet more or less, to the easterly side of Junipero Avenue; thence southerly along said easterly side of Junipero Avenue to the northerly line of the subdivision of old Carmel City; thence easterly along said northerly line of Carmel City to the easterly line of Carmel City; thence southerly along a portion of the easterly line of old Carmel City and the easterly side of the subdivision of Paradise Park and a portion of the easterly line of the subdivision of Addition Number Five of the Town of Carmel-by-the-Sea to the place of beginning.

That when so organized said corporation shall be known by the name of "The City of Carmel-by-the-Sea."

That an election be held, and is hereby called to be held, within the limits described in said petition, and as herein fixed for such proposed corporation, on the 26th day of October, 1916, for the purpose of determining whether the same shall become incorporated as a city of the sixth class, under an act of the Legislature of the State of California, entitled "An act to provide for the organization, incorporation and government of municipal corporation" approved March 13th, 1883, and the amendments thereto.

That at said election the voters shall cast their votes "For incorporation" or "Against incorporation" and said voters shall also at said election cast their ballots for the names of persons to fill the various elective municipal offices prescribed by law for municipal corporations of the sixth class, to-wit: That at said election the following named officers for said corporation shall be voted for:—Five Trustees, to constitute a Board of Trustees; a Clerk, and a Treasurer.

That said election shall be conducted in accordance with the general election laws of the State of California.

That said election shall be held in the building known as S. J. Wyatt's store.

That the following named electors and residents within the limits of the proposed corporation shall be the officers of said election, to-wit: Inspector: I. B. Waterbury. Judges: John Williams, Emaline Harrington. Clerks: Helen Parke, C. O. Gould, W. N. Dingle.

The Clerk of this Board shall, by publication in the Carmel Pine Cone, a weekly newspaper of general circulation, printed and published within the boundaries of said proposed municipal corporation, give notice of the time and place of holding said

election, as required by law.

The foregoing order was passed by the following vote:

Strong Dry Argument

A set of tables taken from the United States census showing the relative increases in wage earners and in wages in the prohibition and license states, has been published. The fact is brought out that the prohibition states had an increase in the number of wage earners over 44 per cent greater than in the license states during the 10 years from 1899 to 1909. It also is shown that the volume of wages in the prohibition states increased 103 per cent in that time while the license states increased 61 per cent, a difference of over 68 per cent in favor of the prohibition states.

While the number of earners in the prohibition states increased 53 per cent, the volume of wages increased 103 per cent. In round numbers, therefore, half again as many men were making twice as much money at the end of the 10 years, while in the license states one-third again as many men were making once and two-thirds as much money.

This comparison is distinctly in favor of the prohibition states. The fact that the increase in number of earners of the prohibition over the license states is not as great in comparison as the comparative increase in wages bears out the contention, it is reasoned, that the wages per man increased more in the prohibition than in the license states. In those states, which are nearly and part prohibition, the increases are relatively the same.

Bear these facts in mind when you vote on the prohibition amendment next month.

If you read it in the Pine Cone, you may safely repeat it.

Delightful Musicale

By A Critic

A charming musicale was given by Mrs. Mabel Young at her home last Friday afternoon.

The program opened with the ever beautiful Beethoven Sonata, Op. 31, No. 2. Mrs. Young played this number without interruption, and gave an excellent and individual reading of each of the four movements.
