PARIS September 29. We hear that the government have given orders for the dismantling of 40 small vessels, 10 or 20 of which are at Toulon, advice vessels alone being excepted.

A commercial letter from Vienna of the 18th inst. mentions a slight fall of the bank actions, which was attributed to intelligence of a rupture in the negotiations, serious commotions at Constantinople, and the definitive march of the Russian forces on the Turkish capital.

A letter from Berlin expresses an opinion that Gen. Diebitsch, in listening to the proposition of the Porte for peace, is only endeavoring to gain time, as with a force not exceeding 70,000 men he cannot present himself before the walls of Constantinople.
