Against Traitors and Alien Enemies.

The following is an act passed by the last Legislature of California, which explains itself. :

An Act to exclude traitors and alien en emies from Courts of justice in civil Cases.

Section 1. Whenever any civil suit shall be pending in any court of record in this State, the defendant, or one of several defendants, or his attorney, may, | at any time after the commencement of the action or the filing of the complaint therein, serve upon the plaintiff, if a natural person, or his attorney, a w.itten notice, objecting to the further prosecution of said suit, on the ground of the disloyalty of the plaintiff; and thereupon all proceedings in said suit shall be stayed until said plaintiff shall take and subscribe, before some officer authorized to administer oaths, and shall file in said cause an affidavit in the following form, to wit:

"I, (here insert the name of the p'aintiff,) do solemnly swear that I will support the Constitution of the United States and the Constitution of the State of Cali fornia; that I will bear true faith and allegiance to the Government of the United States, any ordinance, resolution or law of any State or Territory, or of any Convention or Legislature thereof, to the contrary notwithstanding; that I have not, since the (here insert the date of the passage of this Act) knowingly aided, encouraged, countenanced or assisted, ncr will I hereafter, in any manner, aid, en courage, countenance or assist, the socalled Confederate States, or any of them, in their rebellion against the lawful Government of the United States; and this I do without any qualification or mental reservation whatsoever. So help me God." And if the said plaintiff shall fail to

take and file said oath within ten days after the giving of such notice, if a resident of the county, or within forty days, if a resident of the State and not of the county, or if not a resident of the State, then within such further reasonable time as the Court or a Judge thereof may determine, said case shall thereupon be ab solutely dismissed, and no other suit shall ever be maintrined by the said plaintiff, his grantees or assigns, for the same cause of action; provided that the time may, for cause shown, be enlarged by the Court or a Judge thereof, and that the Court may relieve, against the forfeiture or default arising from accident, surprise, or excusable neglect; and provided that where the plaintiff sues as a trustee, or to the use of another, the oath may be was attached. He presented it at the taken by the person for whose benefit the drug store of a gentleman, who, though action is prosecuted; and further provided that when the plaintiff is a foreigner by birth, who has never been naturalized, nor declared his intention to become a citizen of the United States, he may take and file the following oath: "I, (inserting his name) do solemnly swear that I will not, at any time, or in any manner, aid, encourage, countenance or assist the so called Confederate States, or any of them, in their rebellion against the Government of the United States, and that I will not, while a resident of the United States, knowingly commit or encourage any act tending to subvert the Constitution or Government thereof. So help me God." Sec. 2. If a counter claim shall be set up, or new matter be affirmatively pleaded by the defendant in any suit, the plaintiff may, at any time after the filing of the answer, give or cause to be given to the defendant, if a catural person, or his attorney, a similar notice to the one provided for in the preceeding section, objecting on like ground to the introduc tion of such counterclaim or affirmative matter, and thereupon, if the defendant tears your eyes out, feel your way to the shall fail to make and file a like oath, within the respective times within the said section above limited, such counter claim or new matter shall be disregarded by the Court, and the cause shall proceed as if the same had not been pleaded, and no suit shall ever be maintained by the said defendant, his grantees or assigns, for the same cause or matter. Sec 3. No attorney at law shall be permitted to practice in any court in this State until he shall have taken and filed in the office of the County Clerk of the county in which the attorney shall reside an oath prescribed in this Act; and for every violation of the provisions of this section the attorney so offending shall be considered guilty of a misdemeanor, and on conviction shall be fined in the sum of \$1.000.

A STRANGE FAMILY TALE .- An Eoglish paper narrates the following extraordinary story :

"It is said that James, the first Earl of Lonsdale, who from his arbitrary willand ungovernable temper, was nicknamed 'Old Thunder,' had a violent quarrel with his cousin and heir male, Sir William Lowther, Twillington, to whom he had bequeathed enormous estates and in whose favor he had obtained a remainder of the barony and viscountry. He drove in a fury to his lawyers, demanded his will from them, that he might destroy it, and set off in a paroxysm of anger for Lowther Castle. UNION MASS MEETING .- We see that bills are posted for a Union Mass Meeting, at the town of Woodland, on to-day, Saturday. 23d.

We would inform the NEWS that we were led to believe that n.gotions had been completed for the furtherance of this enter. prise, some time since, but have recently learned that parties disagreed in the details of the proposed arrangement, and the matter was dropped. We also learn that parties have gone to London, with a view of effecting a negotiation. Further than this we know nothing appertaining to the prospects of the construction of the road. Express..

What the probable result will be, we cannot say; but if we are to take the past as an indication of the future, it will be an easy matter to guess; but while we are fearful of a speedy resume of the work, we have no fear that it will be left in its present state for any considerable period of time. The advantages and necessity of the enterprise needs not to be repeated, for they are well known to every one, and we hope soon to see more earnestness in this matter.

C. quickly demanded to know who he was, his regiment, rank, etc., when the latter replied. Gen C., under the impression that Col. Kimball was drawing a pistol, instantly drew his own and shot him in the neck, and he died in a few minutes afterwards. Just then Quartermaster Cock rushed out and cried, "who fired that piece?" "Is that you" said the General. On receiving an affirmative answer, the General told the Quartermaster to look after the injured party that he was responsible for the occurrence. and passed on. The mortal wound was then found to have been given to Lieutenant Col. Kimball, of the 9th New York, who was in command of the Hawkins Zouaves. The Zouaves had just arrived as reinforcements.

The deceased was originally a printer, and was for many years editor of the Dem-ocratic paper at Woodstock, Vermont. During the Mexican war he was Captain of the 9th U.S. Infantry, one of the ten regiments, and distinguished himself during the battle between Vera Cruz and the city of Mexico. He has also seen hard and creditable service during the present war. He was strictly within the line of his duty when demanding the counter sign of Gen. Corcoran, and refusing to let him pass without it.

BLOCKADING .- A correspondent of the Philadelphia Inquirer, on board one of the blockading vessels off Charleston, writes service :

INDIAN WAR .- The Humboldt Times

From the best information we can gather, concerning the movements of the Indians, we are led to believe that they are fully posted as to the organization of the Mountaineers, and know well what work they have ahead of them. Neither do they seem to be dilatory in their preparations. They have not been neglectful in supplying their Commissary Department, as everything goes to show that they have been laying in bountiful supplies. They do not presume to catch a bullock here and there, as formerly, for their subsistence, but they now have good sized pack trains-horses and mules-which are used in transporting their supplies from one post to another. Last week a detachment of Diggers camped at Albee's place, built three temporary houses, drove a lot of Miner's beef cattle into the corral and slaughtered three of them, dried the meat and then moved on up Redwood with a train of ten or twelve animals, carrying their meat with them.

Information of a reliable character has also reached Trinidad, that a large body of Indians have fortified themselves on Redwood, obove the bald Hills, and are prepared for an attack from the whites. They are said to be a few miles below Albee's place, and are well fixed. They have a substantial log house, with port holes, and so arranged that they can make their escape, though it should be surrounded.

RED LEGS .- We take the following from the correspondence of the Express. By it we may see what is done with the "contraband" that escapes from Missouri into Kansas:

The absolute extirpatation of the "di-vine institution," is threatened in the Western portion of the State. Under the encouragement and armed aid which the slaves receive from the border coun ties of Kansas they are swarming across the line in droves, taking whatever moveable property, such as horses, wagons, cattle, furniture, belonging to their masters, that they can seize, and making their way without molestation. Circuit Court, at St. Louis, has decided that under the acts of Congress, and the President's proclamation pursuant thereto, all commercial intercourse with the insurrectionary States, or beyond the military lines of the United States forces, is prohibited without a license therefor from the President, through the Secretary of the Treasury, and that no military commander has any lawful authority to grant a license to any one to pass beyond his lines for commercial enterprises. A load of cotton and a steamer, together valued at \$113,000, were condemned and confiscated by this ruling. Permission had been given for the steamer to go beyond the Federal lines for cotton by the military authorities at Helena.

THE Appeal has the following dispatch dated Weaverville, May 17th :

Information has just reached here that the Indians, numbering 1,000, are in the vicinity of Cox's Bar. They burnt the ranch and other points, making sad havoe with all the houses and the other valuable property in those places. Several families are reported killed. Supervisor Mc-Campbell, of this county, who resides at Cox's Bar, was obliged to fly from his house to save his life. All his property is reported destroyed. We think it will be necessary for the military companies in this place, under Capt. Nebbett's command, to do something towards putting down this outrage.

WASHINGTON, May 19.

The official report of Colonel Davis, commanding a part of General Stoneman's expedition through Virginia, says: Our total loss in the expedition was two commanding officers and thirty three enlisted men. We brought with us one hundred mules and seventy five horses captured from the enemy. We captured in the course of our march a much larger number which we could not bring. The amount of property destroyed is estimated at over a million of dollars.

CHICAGO, May 19.

A Washington special dispatch says: Senator Wilson, who is now here, and who drew up the Conscription Bill, is understood to differ entirely from the decision of the War Department, ignoring the three hundred dollar exemption clause. The section relating to it is nearly a ver batim copy from the French law, which is executed as the present law was intended to be by its framer.

FORTRESS MONROE, May 19 -Two small boats-the Emily and the Arrowengaged in carrying mails, etc., from Norfolk through the Dismal Swamp canal to North Carolina, were captured yesterday near Currituck bridge, forty miles from Norfolk.







CINCINNATI, May 19 .- A general order was issued yesterday announcing the finding of the Court martial in Vallandigham's case. The court finds him guilty of the charges and specifications, and sentenced him to be closely confined in some fortress of the United States during the war. General Barnside approved the sentence and has selected Fort Warren as the place of imprisonment.

MAY, 18 .- A letter from Russellville (Ky.) states that on Wednesday, the 13, a party of sixty guerrillas fired on a train near South Union. The guard on the train returned the fire and routed the rebels, killing one and wounding four. The rebels are collecting a large cavalry force south of the Cumberland and a large infantry force in East Tennessee.

LOUISVILLE, May 19.- A rebel force is in Wayne and Clinton caunties, Kentucky, said to number 17,000, with forty four pieces of artillery. Four regiments of infantry passed through Jamestown on the 14th, and more regiments are reported at Morristown, East Tennessee. --Buckner is said to be at Clinton. The rebel pickets are on the Cumberland at every available point.
