DIRECT EXAMINATION OF ISHII, MASAMI, By Mr. Freeman.

27191 * The witness identified exhibit No. 3045 as his affidavit and verified it. The affidavit stated * that the instruction attached hereto was drafted by the witness by direction of General TERAUCHI. Commander of the Southern Army, and Lt.-Gen. TSUKADA, his Chief of Staff, and approved by them. On November 20 TERAUCHI called a meeting of all commanders under his command, including Gen. KAWAGUCHI of the attached corps, and transmitted this instruction. The commander read the instruction to them, and had it printed and handed to them afterwards. The witness was in attendance on the occasion.

27192 * The instruction states that TERAUCHI had been appointed Commander of the Southern Army, and was anxious to discharge the heavy responsibility, depending on the loyalty and bravery of his commanders and men. Officers and men should grasp the war's true meaning, impress their responsibility on their minds and do their best.

Both the Army and Navy have always been on good terms and in close cooperation, and should prove their true strength and accomplish the aim of the present campaign in the shortest time, never losing the belief that Japan can never lose the war. They should appease and enlighten innocent local peoples by showing the virtues and dignities of the Japanese army through their behavior, and should refrain from violence. They should especially exercise self-restraint and fight bravely in view of the hot climate and prevailing * pestilence at the front.

CROSS-EXAMINATION BY COLONEL MORNANE.

* The witness stated that he was a colonel, and staff officer in the Southern Army. The authority of the Commander of the Southern Army extended over FIC, Siam, Malaya, Sumatra, Java, NEI, British Borneo, and the Philippines. General YAMASHITA was then Commander of the 25th Army, which was part of the Southern Army.

* The work of the witness involved operations. In the course of his duty he never learned that 5,000 Chinese had been arrested in Singapore about February 21, 1942, nor had he ever heard it. At that time he was in Saigon, at General TERAUCHI's headquarters.

27197 Exhibit No. 3046, an amendment to Article 2 of the regulations concerning POW treatment, * dated April 9, 1942, stated that Article 2 of the regulations provides that the POW Control Bureau should transact business regarding POWs and internees. The scope of such business included matters concerning general plans for treatment, such as accommodations, discipline, exchange, release, punishment and general allowances of POWs and internees, matters concerning POW labor, correspondence, punishment, and labor and correspondence of civilian internees.

* Exhibit No. 3047, a notification from the Adjutant's Office to the POW Control Bureau, dated November 22, 1942, stated that it was sent to inform the Bureau that it had decided to entrust to the Chief of the POW Control Bureau the decision on matters of minor importance concerning * accommodation, handling, allowances, transfer, labor and punishment of POWs at the front.

Matters concerning correspondence, relief of POWs and internees and matters of minor importance concerning granting to foreigners entry of POW camps, and military detention houses, were entrusted to them. MEMORANDUM TO: Mr. D. N. Sutton

l. This Affidavit contains instructions drafted by the Deponent and approved and read to the Commanders serving under him by General TERAUCHI, Commander-in-chief of the Southern Army at the time of his appointment. (According to Exhibit 102, IPS Document 1606, he was appointed on 6 November 1941).

- 2. Although the above instructions were distributed to the various Commanders and printed for them (page 2 of the Affidavit), the Witness does not produce the document and apparently quotes it from memory.
- 3. The "instructions" are actually exhortations in the most general and abstract terms. The only sentences even remotely connected with any issue read as follows:

"Try to appease and enlighten the innocent local peoples by showing the true virtue and dignity of the Japanese Army through your own behavior and always refrain from resorting to violence. I especially wish you to exercise self-restraint and fight bravely in view of the hot climate and prevailing pestilence at the front."

(Last paragraph of the Affidavit)

Deponent: ISHII, Masami

Having first duly sworn an oath as on the attached sheet and in accordance with the procedure followed in my country, I hereby depose as follows.

- 1. My name is Masami Tahii
- 2. I live at Ichigaya, Ushigome-ward, Tokyo city.
- 3. I was born on Dec. 1, 1895
- 4. My brief career is as follows:

on sept. 19, 1941, I was appointed an attached officer of the Army Department of the Imperial Headquarters, and leaving canton, the place of my former post, arrived at Tokyo on Sept. 23, 1941.

on Nov. 6, 1941, I was appointed a staff officer of the Southern Army.

on Nov. 27, 1941, I left Moji to depart for the front. on March, 18, 1943, I was appointed a professor of strategy in the Army Staff College. On march 22 in the same year, I left Shonan (T.N. Singapore) and returned to Tokyo.

in-chief of the Southern Army, and Lt-general Tsukada, the chief of staff of this Army, and was approved by them. On Nov. 20, Commander Terauchi called a meeting in Tokyo of all the commanders under his command, including Major-general Rawaguchi, Commander of the Rawaguchi Detached Corps and transmitted the above-mentioned instruction. The commander himself read the instruction to them, and afterwards made it printed and handed it to them. I was in attendance on the occasion.

Instruction

At this critical moment of our national advancement, I, Terauchi, was unexpectedly appointed to the responsible post of the Commander-in-chief of the Southern Army. Nothing is more honourable and grateful for me. I am anxious to dischage the heavy responsiblity now placed on me, chiefly despending on the loyalty and bravery on the part of all our commanders and their men.

All the officers and men should grasp the true meaning of the present sacred war, impress your heavy responsib ilities on your minds and do your best with an indomitable will.

Both the Army and the Navy always on good terms and in close collaboration with each other should prove their true strength and accomplish the aim of the present campaign in the shortest length of time never faltering in the belief that the Japanese nation can never lese in the war.
