Captioned matter involves a large scale narcotics smuggling organization [redacted]

[redacted] This matter has been under investigation by the Tampa Division and a number of other Federal and local agencies for approximately three years, and a number of individuals have already been convicted or pled guilty to Federal drug smuggling charges in Texas, North Carolina, Michigan and Florida. At the present time, principal [redacted] [redacted] who has been indicted at Tampa along with [redacted] on CCE charges, has indicated a willingness to cooperate with the Government and he has been debriefed over a two week period as to his knowledge of drug smuggling operations involving not only American Nationals but also Colombians and Panamanians, many of whom are high-ranking political officials. He has also furnished some detail concerning his own personal assets which the Government anticipates forfeiting pursuant to a final plea agreement, the details of which have yet to be finalized in writing. A preliminary agreement has been worked out which established the ground rules for the detailed proffer which has been received, but a final agreement cannot be reached until the information [redacted] has furnished to date can be assessed and evaluated.

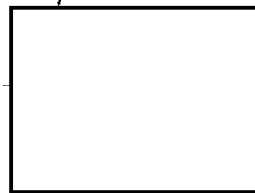

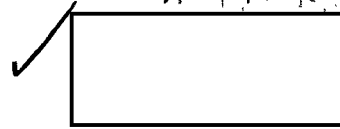

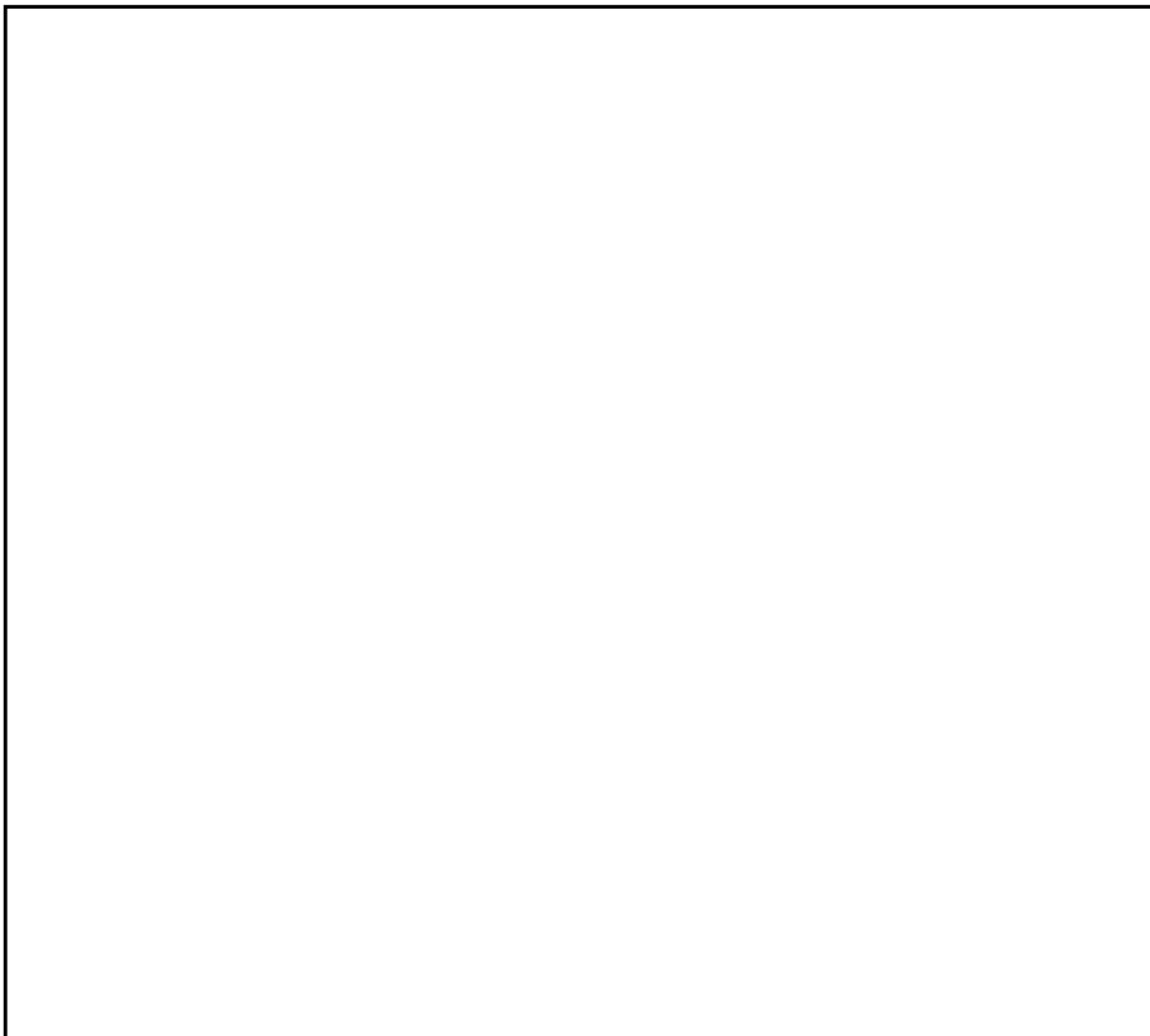

The purpose of the instant memorandum is to recommend that a new project be undertaken by personnel assigned to the FBI/DEA Joint Intelligence Working Group (Miami) (JIWG/M), the primary purpose of which would be the systematic identification of known and suspected primary United States Representatives (USREPS) of Colombian and other South American narcotics trafficking organizations.

The means by which this identification procedure will be accomplished will be the utilization of intelligence analysts to review all data collected by Special Agents assigned to the JIWG/M, particularly with regard to the debriefings of sources, informants and government witnesses. The analysts will then key on the identities of persons named as USREPS, initiate preliminary inquiries to determine basic biographic data, and then prepare summary profiles for review by the agents working the program.

By preparing such profiles, it is believed, the documents will serve as guides for both the analysts and the agents to determine whether the potential target is appropriate for additional investigation a.) by the JIWG/M to develop more information and b.) for possible assignment to a target squad or enforcement group of FBI or DEA Miami.

The analysts preparing the biographic summaries will be seeking to acquire the following basic information:

- a. The name of the organization which the target is reported to represent.
- b. The full name and aliases used by the target.
- c. Basic biographic data, including date and place of birth, physical description, address, INS and/or FBI identification numbers, vehicles registered, family

d. Method of Operation of the target, that is to say, is the target receiving cocaine shipments and turning them over to distributors or buyers, collecting the proceeds of the shipments and transmitting same to the principals in South America, or supervising some or all of the related functions in a number of US cities.

e. General Background of the target or his/her activities. Included in this could be the results of preliminary checks with other enforcement agencies, physical surveillances, etc.

f. Source Coverage

With the above data as the criteria which we will be seeking to collect as a minimum, it will be incumbent on the agent or analyst working on the target to perform the following types of inquiries:

1. FBI field office indices search (including OCIS)
2. DEA NADDIS/M204 check
3. FBI Identification Division search (civil & criminal)

5. Florida State Division of Motor Vehicles for drivers licenses (including photograph) and vehicles registered

6. Credit Bureau inquiry

Upon completion of the basic inquiries described above, the analyst or agent will, if appropriate, make a short assessment as to the viability of the target for further investigation. If, for example, the target cannot be identified adequately given the information provided, the recommendation might be to proceed no further. If, however, the target can be identified and located, the assessment might recommend either additional work by JIWG/M or the recommendation to open a case investigation by FBI or DEA Miami.

It should be noted that the analyst or agent participating in the PROJECT USREP will have the option, at any time, of calling upon the resources of the following agencies which are working with or in the JIWG/M:

1. Metro-Dade Police Department's Organized Crime Bureau, Criminal Intelligence Squad
2. U.S. Coast Guard District - Intelligence Office and Law Enforcement Specialists
3. U.S. Customs Office of Investigations, Miami
4. National Narcotics Border Interdiction System (NNBIS) including Department of Defense (DOD) representatives

It is further believed that both physical and photographic surveillances could be instituted on USREP targets with the intent being the identification of persons working under the target's direction or involved in some fashion in their narcotics operations.

Attached to this memorandum will be found a sample of what such a basic profile will look like once the project is ongoing.

Administrative

In regard to the administrative aspects of this project, the following is recommended:

A new subfile, , should be created, to serve as a repository for all data collected.

At an appropriate future date, the results of the project should be reviewed to determine whether the project is an effective utilization of resources and manpower.

[redacted] has provided reliable information in the past. This source [redacted] who has access to the leadership of a number of narcotic trafficking organizations within the interior of Colombia. The following information was acquired on March 4, 1986.

Identification

The source advised that General Manuel Noriega is the commander of the National Guard of Panama and has been associated with the Colombian narcotic trafficking groups headed by Pablo Emilio Escobar-Gaviria, [redacted] and others for over five years. Noriega is paid in cash by the heads of Colombian drug organizations in return for his providing of secure landing and refueling sites for their aircraft, as well as military escort/protection of their couriers transporting narcotic profits to financial institutions in Panama City. The source further alleged that Noriega was involved in the operation of clandestine cocaine processing laboratories which were established on military/air force installations within Panama.

The source has previously identified [redacted] as having had a corrupt relationship with General MANUEL ANTONIO NORIEGA, Commanding Officer of the PANAMANIAN DEFENSE FORCES.
