SUBJECT: School Use of Buildings held by the Japanese Government

THRU: Commanding General, I Corps, APO 301

TO: Commanding Officer, Wakayama Military Govt Team,
APO 25

1. Reference is made to October 1947 Monthly Activities Report, Wakayama Military Government Team, Annex E, item 3, which concerns efforts of the Japanese to secure government-held buildings for school use.

2. It is desired that detailed reports of specific cases of obstruction or lethargy be forwarded through both United States Army and Japanese channels as completed, in order to increase pressure for action.

3. A reply of CHQ, SCAP, to previous similar situation reports, is quoted for your information: "A Ministry of Education official states that the disposition of former military schools, munitions factories and uniform factories is a responsibility of the Japanese Finance Ministry and that disposition of prefectural regimental buildings and army hospitals, is a responsibility of the prefectural Bureau of Finance. Assurance has been given that negotiations are being conducted between the Ministry of Education and the Finance Ministry to obtain more favorable consideration of requests for the use of such facilities for school purposes."

SUBJECT: Request for Real Estate

THRU : Commanding General, Headquarters, I Corps, APO 301

TO : Commanding General, Headquarters, Eighth Army, APO 343

1. Request the issuance of a central procurement demand for the following land and buildings for use as a motor pool:

- a. vacant land----- 9462 sq ft
- b. storage building, wood, single story---- 432 sq ft
- c. stalls, masonry, open faced (3)----- 969 sq ft

Both land and buildings are owned by the Kyoto Prefectural Government and are located at Shimota-chiuri Kamanza, Kamikyo-ku, Kyoto shi, Kyoto fu.

2. Existing facilities consist of approximately 3,300 sq ft of land and 646 sq ft of shop space, open faced. Recently this headquarters was ordered to maintain and service the vehicles of Hq., Kinki Military Government Region and the IV Procurement District. Existing facilities are entirely inadequate, it being impossible even to park the vehicles in the space on hand. Vehicles are parked outside of the compound and cannot adequately be secured against theft and malicious mischief. We are advised that the authorized allotment of vehicles for military Government has been increased by at least two (2) more vehicles. Present authorization includes:

- a. Sedans----- 2
- b. Truck, $\frac{1}{2}$ ton C/R----- 28
- c. Truck, $\frac{3}{4}$ ton W/C----- 2
- d. Truck, $2\frac{1}{2}$ ton, cargo----- 5
- e. Trailer, $\frac{1}{2}$ ton----- 10
- f. Trailer, 1 ton, cargo----- 4
- g. trailer, water tank, 250 Gal----- 2

3. The open faced stalls will be used as a work shop and are particularly required during inclement weather. The storage building will be used for storage of automotive parts and tools, and driver's office. The motor pool is operated on a 24 hour basis and requires protective shelter for drivers awaiting call. No rehabilitation or new construction is required at this time.

4. Attention is invited to the fact that the Japanese are using

part of the present enclosed compound and must pass thru the Military Government area to reach their section. This situation not only interferes with efficient operation of the motor pool, but also makes it hard to maintain adequate security for supplies and equipment.

TO: CG, I Corps, APO 301,

1. Recommend approval and issuance of a central procurement demand.
2. Motor pool facilities for the joint use of this headquarters, the Kyoto Military Government Team and the 4th Procurement District are inadequate. Basic communication and inclosures request the minimum that is necessary to provide adequate service and security.
3. Land requested is vacant and is not under cultivation. The storage building has not been used by the Japanese for some time. Open faced stalls are used during business hours for the parking of Japanese civilian vehicles, an unsatisfactory situation in that these vehicles enter through the area used by United States forces. Since there is but one entrance to the motor pool and many Japanese persons use it, there is a constant danger to the security of United States property.
