Enclosed herewith to the Bureau are two Xerox copies of an undated report directed to JOSE CERRUTTA, Mexican Minister of Foreign Affairs, by the Acting Secretary of Gobernacion (Interior), which was made available to SA JOSEPH B. GARCIA on 5/11/64, by Informant MEX-192 on a highly confidential basis. (R)(u)

Informant advised that the enclosed report, with 17 pages of exhibits, constituted the official reply of the Mexican Ministry of Interior to the request from the President's Commission for an official report of investigation conducted by the Mexican Government with respect to the travel and activities of LEE HARVEY OSWALD in Mexico. Informant pointed out that the report had been transmitted to the Ministry of Foreign Affairs on 5/9/64, and possibly would be revised or changed at the Ministry of Foreign Affairs before final transmittal to the United States Embassy for forwarding to the President's Commission. (R)(u)

From an examination of the enclosed report, it appears that it contains no information which has not been reported previously to the Bureau, and from references to the exhibits which are annexed thereto, it also appears that copies thereof have been furnished to the Bureau previously. (R)(u)
