[WF NINE EIGHT FOUR DASH S ASTERISK] REPORTED APRIL TWENTYONE FIFTYEIGHT ONE GEORGE DE MOHRENSCHILD PAREN PEDNETIC PAREN [TOLD BEATRIZ RODRIGUEZ, DOMINICAN EMBASSY, HE WAS FROM DALLAS, TEXAS, HAD SPOKEN TO THEN DOMINICAN AMBASSADOR TO THE U.S. MANUEL DE NOYA TWO DAYS PREVIOUSLY. [DE NOYA] TOLD FORMER COULD SEE HIM FOUR TWENTYONE FIFTYEIGHT. DE MOHRENSCHILD THEN AT AIRPORT, WONDERED WHEN [AMBASSADOR] WOULD SEE HIM. [RODRIGUEZ] STATED [AMBASSADOR] GONE FOR DAY AND DID NOT MENTION ANY SUCH APPOINTMENT TO HER; WOULD CALL [AMBASSADORE] RESIDENCE; FINALLY DECIDED THAT DE MOHRENSCHILD WOULD CALL [THE AMBASSADORE] RESIDENCE AFTER SETTLING IN A HOTEL.
