

RESOURCE CONSERVATION AND RECOVERY ACT OF 1976

Intent to Develop Rulemaking

The Resource Conservation and Recovery Act of 1976 (Pub. L 94–580) mandates the Administrator of the Environmental Protection Agency to develop and promulgate a number of regulations, guidelines, standards, criteria, and reports related to the effective management of discarded materials. Such rulemaking covers the recovery and reuse of such discarded materials as well as, in partnership with the States, the control of all land disposal of such materials and the careful management of all hazardous wastes.

The purpose of this notice is to advise interested members of the public, including but not limited to, Federal, State, and local government agencies; industries who generate wastes as well as those who treat, store, and dispose of them; labor organizations; consumer, agricultural, and public interest groups of the Agency contact point for the development of these rulemakings and reports. Exhibit I lists the sections of the Act and the responsible person in EPA to contact for those persons interested in providing data, case studies, and other information related to the development of the rulemaking. Such contact persons may also be consulted regarding the status of progress of the development of each action. The mailing address for each contact person is:
