I hereby certify that the greater part of the building of Navy Department was burnt down by the air-raid of the American air forces from midnight of May 25th, 1945 to early dawn of 26th of the same month, and at that time the Minister's secretariate and the office of each section of the Military Affairs Bureau were entirely burnt down and almost all the documents in the custody were reduced to ashes. The file of the documents and telegrams concerning the treatment of P.O.W. were also completely destroyed, and since the office of the Telegraphic Section was burnt down, the file of the telegrams in the same office were also reduced to ashes.
