SUMMARY OF RELEVANT POINTS

This document consists of answers by AMAU, Eiji to various questions regarding his activities. Extracts or significant items are summarized below for whatever evidentiary value this information may have.

From 1931 to 1944, AMAU traces his career as a diplomat and official of the Foreign Office. He was President of the Cabinet Information Bureau from April 1943 - July 1944. He states that in his official capacity in above position, he "may have nominally been made a member or an official of the Imperial Rule Assistance Association".

Political Societies of which he admits membership are: Japanese-American Society /NICHU-BEI KYO KAI/; Japanese-Italian Society /NICHU KYO KAI/; Nippon Club; National Policy Investigation Society /KOKUSAKU KENKYUKAI/ and Great Japan-Asia Developing Association /DAI NIPPON KOAKAI/.
