

1. In a message W 92480 (Tab B) DA requested the following information be submitted:

- a. Estimate of civilian supply requirement to include North Korea, in the same format contained in CINCFE msg C 65110 (Tab C). This information is to be followed with details to support justification in budget hearings.
 - b. Cost of supplies already supplied to Korea by Army.
 - c. FY 52 estimate.
- d. List of requirements for Korea in detail, phased by month, to permit immediate supply action on the portion required from Unified Command, Washington.
- 2. The CG Eighth Army has been directed in CINCFE msg C 66092 (Tab D) to prepare a revised estimate of requirements for Korea, phased by month, in sufficient detail to permit immediate supply action. A proposed message to CG Eighth Army and CG X Corps forwarded for CofS approval on 19 Oct, assigns responsibility for North Korea to CG Eighth Army. The estimates from CG Eighth Army are not expected to arrive in this Hq until the early part of November 1950.
- 3. In view of information contained in para 2 above, the provision of information required in para 1 above to DA will be accomplished by Technical Services in coordination with ESS and ECA. This process is time consuming, requiring a list of items in detail with target delivery date, and desired destination, thus an interim reply to DA is considered necessary.
- 4. Revisions of the program to be prepared by General Hq for submission to DA (para 3 above), will be completed as firm information is received from CG Eighth Army.
- 5. Therefore, it is recommended that the attached interim reply to DA (Tab A) be approved and returned to G-4 for dispatch.

1. In response to CofS question to General Eberle regarding the differences, if any, which exist between KORCIV 40, 3 October 50, (Tab) "A") and directives of this headquarters, the following is furnished:

- a. KORCIV 40, Tab "A", was received by airgram by ECA, Tokyo. This headquarters had not received this directive in this form by electrical transmission. Therefore, G-4, with concurrence of AG, reproduced the airgram and made distribution to interested staff sections.
- b. Msg 290548 Z, 30 Sept 50, State to SCAP (USPOLAD) (Tab "B), contains the identical information transmitted in KORCIV 40 (Tab "A"), but neither did it have a KORCIV number nor rescind KORCIV 41.
- c. HORCIV 13, Tab "C", infers in paragraph 5, B, (3) and (4) that CINCUNC should procure from the Japanese economy, within its ability to furnish, as many of the requirements as possible.
- d. In contrast, paragraph B, 1, Tab "A" states that total requirements for relief measures will be submitted to the Unified Command, Washington, with an indication of those requirements of great urgency which the Unified Command, Tokyo, is undertaking to fill on an emergency basis.
- e. Msg W 93158 (KORCIV 41), 3 Oct 50, (Tab "D") states in paragraph 2, E, "Requirements will continue to be handled under present KORCIV 13 system modified to provide for the supply responsibility placed upon Army".
- f. Msg W 94280, 17 Oct 50, (Tab "E") infers in part 2, paragraph A that DA plans to initiate immediate supply action on requirements for the next three months and endeavor to obtain maximum UN donations for 4th and succeeding months.
- g. Up to the present time practically all procurement of supplies has been made locally due to the urgency for meeting emergency needs in Korea.
- h. As requested in W 94210 (Tab "E"), G-4 is now preparing for submission to the DA, the estimated civilian supply requirements for FY 51 together with a list of requirements with sufficient detail, description, and estimated cost to permit immediate supply action by DA.

- 2. In view of the conflicting provisions contained in DA directives, as set forth above, it will be necessary to establish the policy to be followed for local procurement of relief supplies for Korea. In view of the plans of the DA to initiate necessary supply actions on the next 3 months requirements for civilian supplies for Korea and the order and shipping time required to obtain needed supplies from the ZI, it is recommended:
- a. That for the next 3 months, which can be considered an emergency period due to time element involved, maximum procurement of required
 relief supplies be made locally within the ability, as determined by SCAP
 (ESS), of the Japanese economy to supply same;
- b. That local procurement during the 4th and subsequent months be limited to those supplies urgently required for emergency purposes;
- c. That DA be informed of the above actions when requirements are submitted as required by Tab "E".

- 1. The purpose of this Conference is two-fold:
- a. To orient interested staff sections concerning plans, policies and procedures.
- b. Assemble information to provide basis for reply to DA Msg w 94280 (Inclosure 1)
- 2. Attached as inclosure 2 is a list of references which apply to this program including messages issued by CINCFE and message received by General Headquarters from the State Department and DA, plus CINCFE publications.

 - (4) Submit FY 52 estimated requirements.

- (5) Reports of emergency procurement of civilian type supplies which have not been included in requirements and programmed.
- 5. In order to assemble information required to reply to W 94280. it is requested that Tech Services and PH&W take the following actions:
- 2. Refer to para 4a(1) Rescreen requirements for South Korea listed in CINCFE C65110 and prepare separate estimate for North Korea. Prepare estimate in same format as C 65110 and submit to G-4 attn: KEAD by 25 Oct 1950. Tech Services and Ph&W are responsible for calculation of requirements by item as outlined at this Conference. As an example: There are several areas of responsibility which require the use of the item coal, i.e. transportation for railroads, Ph&W for homes, Engr for heating public buildings, etc. In this example, the Engr is responsible for assembly of the entire coal requirement in coordination with other technical services and agencies.
- b. Refer to para 4a(3). Submit detailed justification to support information in para 5a above, to G-4 Attn: KEAD by 27 Oct 1950. The format contained in letter CINCFE, AG 400 (29 Sep) GD, 1 Oct 1950, subject: Non-Military Aid to Korea, will be used for this report

a form subject: Civilian Supplies Provided Korea within UNC Area of Responsibility. It is requested that this form be completed for North and South Korea separately as of 25 Oct and forwarded to G-4, Attn:

KEAD by 27 Oct 1950. Submit second report for period 26 Oct - 10 Nov by 14 Nov 1950. Thereafter report emergency procurements as they occur.

d. Refer to para 4a(4).

Submit estimate for FY 52, indicating requirements for North and South Korea separately to G-4 Attn: KEAD by 1 Dec 1950.

- e. Refer to para 4b(1) (2) (3). Attached as inclosure 6. are Forms 1 and 2 to be completed and forwarded to G-4 Attn: KEAD by 1 Nov 50. a. In accordance with the instructions contained in reference 1 b(2) above, the Commander-in-Chief, United Nations Command is responsible for the provision of minimum necessary civilian type supplies and equipment to Korea to prevent disease and unrest and to further military

- The instructions contained in this letter constitute the basic directive for the implementation of the responsibilities assigned the Commander-in-Chief, United Nations Command, stated in 2a above.
- c. Specifically, General Headquarters, United Nations Command is responsible for providing:
 - Direct civilian relief assistance, in the form of food, clothing, fuel, shelter, and medical supplies to prevent disease, starvation and unrest among the civilian populace in Korea.
 - The minimum necessary civilian type supplies and equipment for construction or reconstruction essential to the military operations of the United Nations Command, including such facilities as public utilities, transport and industry, so long as these facilities are controlled or utilized primarily by the United Nations Command.
 - Civilian type supplies and equipment required by the Republic of Korea Army.
- d. KORCIV 39, reference 1 b(2) above, charges the Economic Cooperation Administration with the responsibility for provision of supplies and equipment and advisory aid for long range rehabilitation, economic stabilization, and assistance to United Nations Command within limits

- essary raw materials or supplies should be submitted as a requirement for the production of required end products. When raw materials are included as a requirement sufficient time must be available in order that the end item may be utilized for the stated purpose. This will reduce the required dollar outlay for relief, and will assist in stabilization of the Korean economy.
- d. Prior to submission of requirements, the Commanding General. Eighth Army, will coordinate with the Economic Cooperation Administration in Korea to determine eligibility for Economic Cooperation Administration funding. Percent of ECA participation will be determined in each case. General Headquarters will be informed of such agreement by item. Differences which cannot be resolved will be referred to this headquarters.
