


HOUSE OF REPRESENTATIVES TOKYO October 23, 1951. Dear Mr. Rizzo, I am profoundly grateful to the United States and GHQ for their goodwill in dispatching to the United States the Chairmen and members of the Standing Committees for Fishery in both Houses of our country in order to make inspection and study thereon. The party consisting of 4 persons, namely KINOSHITA Tatsuo; CHIDA Tadashi, Members of the House of Councillors, and TOMINAGA Kakugoro; SUZUKI Zenko, Members of the House of Representatives, left here for the U.S. at the end of August and is now expected to be shortly on the way back to Japan, after finishing their trip. In view of the fact that the Diet is now sitting, and in particular of paramount importance of the current session intended for approval of the Peace Treaty, I should like to ask your favor for providing them airplane facilities, if possible, by contacting with the quarters concerned so that they may be able to return to Japan as early as feasible.
