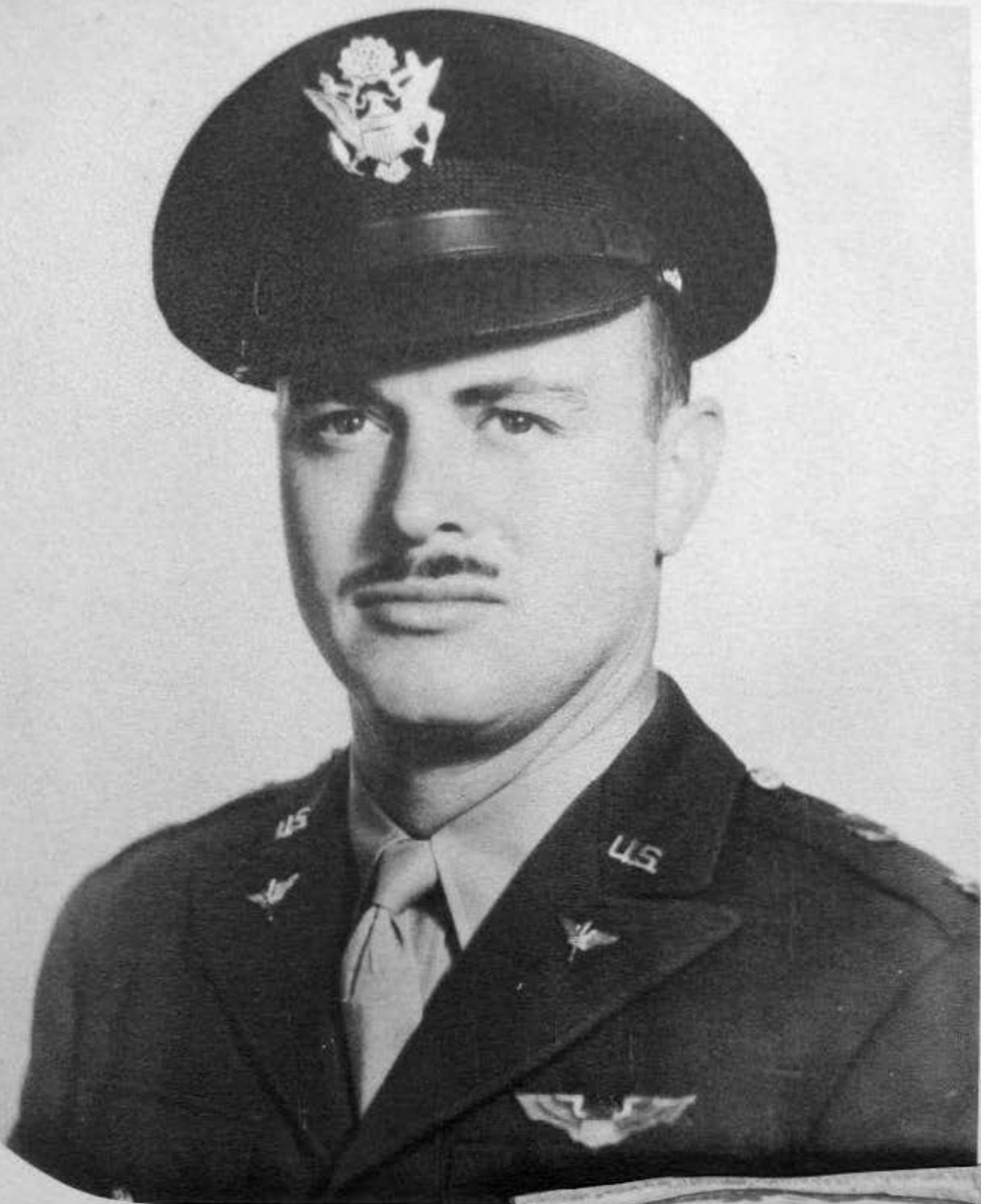
TO THE DEPARTED AIRMEN
