# Movement Charter: what and why

A charter is a document that sets out **rights, authority, and privileges**. The Wikimedia movement doesn't have one.

The Wikimedia Movement Charter aims to document the **values, rights, relationships, and mutual responsibilities of all participants** in the shared mission of this movement.

# Why do we need a Charter?

As part of Movement Strategy, our movement adopted a strategic direction in 2017, that:

***By 2030, Wikimedia will become the essential infrastructure of the ecosystem of free knowledge, and anyone who shares our vision will be able to join us.***

The Charter will serve as a **guiding compass**, helping us move towards the strategic direction, and implement the Movement Strategy recommendations.

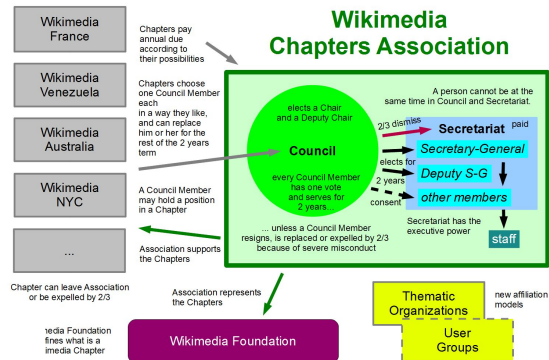

- ➔ 2005 - Purpose of the [WikiCouncil](#) proposal to act as a representative body for all Wikimedia projects and work alongside the WMF's Board of Trustees.
- ➔ 2010 - [Movement Roles](#) project aimed to define various roles within the Movement.
- ➔ 2012 - [Wikimedia Chapters Association](#) was discussed to coordinate better across the affiliates. It was never established.
- ➔ 2014 - [Chapter's Dialogue](#) was a major effort to listen to the needs, goals, and experiences of Wikimedia chapters.
- ➔ 2017 - [A strategic direction](#) was created to guide our movement into the future:

***By 2030, Wikimedia will become the essential infrastructure of the ecosystem of free knowledge, and anyone who shares our vision will be able to join us.***

# Overview: introduction

- **Defines Wikimedia** as “an international, socio-cultural movement whose mission is to bring free knowledge to the whole world”
- **Defines the Charter** as “a formal agreement document to state the values, rights, relationships, and mutual responsibilities of all participants towards the shared mission of this movement”
- **The scope of the Charter** “applies to all individual and institutional participants, movement entities, projects, and online and offline spaces officially associated with Wikimedia”
- **The goal of the Charter** is “to make it easier for movement stakeholders to collaborate with each other”



# Overview: values



**Free knowledge:** use open licensing to share all content it produces, all its software, and access to all its platforms

**Autonomy:** operate independently, guided by its free knowledge mission, and not obstructed by bias or favoritism

**Subsidiarity and self-organization:** decisions should be made at the most immediate or lowest possible level of participation, starting with volunteers; and online and offline communities should make decisions for themselves

**Equity:** take active measures to promote and achieve equity in knowledge, and establish provisions to allocate resources through decentralized governance and community empowerment.

**Inclusivity:** provide a common space where everyone who shares in the mission and values can participate and co-create with others

**Safety:** prioritizes the well-being, security, and privacy of its participants to ensure a safe environment (online and offline) to participate and contribute

**Accountability:** implement transparent decision-making, dialogue, public notice, reporting of activities, and upholding the care responsibility (supplemental); and through community leadership on projects and movement bodies

**Resilience:** pursue effective strategies and practices, and use meaningful metrics-based evidence to support and drive changes

# Overview: volunteers

- Acknowledges that **“volunteers are the human core of the Wikimedia movement, and have autonomy as individuals to contribute to the Wikimedia vision”**
- Defines volunteers as **“a person who donates time and energy to Wikimedia activities, either online or offline, and does project editing, administrative duties, committee engagement, event organization, and other activities”**
- Responsibilities of volunteers
  - Follow Wikimedia and project policies while contributing
  - Accountable for their contributions to the projects and responsible for their individual actions

# Overview: volunteers → Wikimedia communities

- Defines Wikimedia communities as “groups of people who contribute online and offline to build and advance the Wikimedia mission” (mainly made up of volunteers, but includes other)
- Project communities have autonomy over the policies within their projects, in alignment with global policies
- Rights of communities
  - Full editorial control of the content in their individual projects
  - In charter of their own dispute resolution and moderation processes, as long as they’re not in violation of global policies
- Responsibilities of communities
  - Be open to participation by the community, and in its governance; anyone who adheres to the policies and has sufficient time and skills should be allowed, and encouraged, to participate
  - Ensure fairness and equity in governance and policy enforcement
  - Responsible for providing truthful and honest information about the project’s state of governance

# Overview: Wikimedia Movement Bodies

- Defines Wikimedia Movement Bodies as “organizations that support and coordinate” the activities of the Wikimedia volunteers and communities
- These bodies are: affiliates and hubs (known collectively as “Wikimedia movement organizations”), the Global Council, and the Wikimedia Foundation
- All bodies have a care responsibility (supplemental)
- And in case of conflicts that cannot be resolved by existing mechanisms, there is an independent dispute resolution function (supplemental)

# Overview: WMB → Wikimedia Movement Organizations

- Defines Wikimedia Movement Organizations (WMO) as:
  - Chapters
  - Thematic Organizations
  - User Groups
  - Hubs
- Composition and governance for the WMO is left to the body itself to decide, depending on their context and needs; decision-maker of WMO is the org's board or a similar body
- Responsibilities of WMO
  - Promote the sustainability of communities that they support
  - Facilitate DEI within their communities
  - Uphold the Universal Code of Conduct
  - Develop partnerships and collaborations within their areas of interest
- “WMOs may choose to develop their financial sustainability through additional revenue generation, coordinating such efforts with other WMOs when necessary”
- The Global Council needs to consult an WMO when there are new proposals for WMOs in the same area of operation (theme or region)

# Overview: WMB → Global Council

- The four functions of the GC are:
  - Strategic planning
  - Administration of the Wikimedia Movement Organizations and Communities
  - Technology Advancement
  - Resource Distribution
- The Global Council is composed of the Global Council Assembly and the Global Council Board, each with their unique responsibilities
- There are also Committees of the Global Council that operate at the discretion of the GC (similar to how the committees of the WMF Board of Trustees work)
- There will be advisor and liaison roles, as deemed appropriate for the operations of the GC, supported by the WMF
- At least one Global Council meeting shall be held annually...and at the Global Council meeting, the GCB shall present its annual report on the affairs of the Global Council and the carried out activities. It submits the activities with an explanation to the meeting for approval.

# Overview: WMB → GC → GC Assembly

- 100-150 members
  - Members will be elected, elected, or appointed to bring forward a diverse range of perspectives and experiences from the movement
  - Global Council Membership Policy (supplemental)
  - Terms are 3 years, with a max of 2 consecutive terms
- The three responsibilities of the GCA are:
  - Making high-level decisions within the scope of the GC's purpose and functions
  - Holding the GCB accountable for their work
  - Taking seat in the GC's subcommittees

# Overview: WMB → GC → GC Board

- “The GC Board shall be in charge of coordinating and representing the Global Council, and for this, derives its mandates from the GCA decisions.”
- 5-15 members (coming from the GCA)
  - Global Council Membership Policy (supplemental)
  - Terms are 3 years, with a max of 2 consecutive terms
- The five responsibilities of the GCB are:
  - Drafting the initial Wikimedia Movement strategic plan, subject to approval by the GCA, as part of its strategic planning function,
  - Supervising and overseeing the processes of electing, selecting or appointing members to the GCA,
  - Serving as the representative of the GC in stakeholder engagement activities,
  - Coordinating the annual GC meeting,
  - Maintaining accountability for the execution of the functions of the Global Council, encompassing both the GCA and the GCB.



# Overview: WMB → Wikimedia Foundation

- “Wikimedia Foundation is the nonprofit organization that serves as the main steward of the Wikimedia Movement’s free knowledge platforms and technology.”
- WMF governance is established in its bylaws
- Responsibilities of WMF
  - Operating the Wikimedia projects
  - Supporting programmatic activities
  - Legal obligations

# Overview: amendment

Category	Process	Approval Body	Notes
1 – minor corrections to spelling and grammar that do not change the meaning/intent of the charter	$\frac{2}{3}$ support for proposed change	GC Board	
2 – affecting only the GC working processes	$\frac{2}{3}$ support for proposed change, community consultation recommended	GC Assembly	
3 – affecting the GC responsibilities and membership	$\frac{2}{3}$ support for proposed change, mandatory community consultation	GC Assembly	
4 – affecting the movement values; responsibilities of movement stakeholders and bodies	Majority support using a movement-wide vote	Wikimedia Movement	Vote methodology similar to ratification vote
5 – changes proposed by the movement	Majority support using a movement-wide vote, but proposals need to meet criteria (supplemental)	Wikimedia Movement	Vote methodology similar to ratification vote

# Overview: ratification

- 3 groups must be in support of ratification for the Charter to be ratified
  - Wikimedia affiliates: more than 50% in support
  - Individuals: more than 50% in support
  - WMF Board of Trustees: via their normal process per their by-laws
- The English language version of the charter is the official (over other translations)

Glossary	Terms and definitions of specific words in the charter
Movement Body Membership Policy	Accreditation criteria for the existing affiliate landscape
Future Affiliate Landscape	Proposal for a future landscape of affiliates and hubs
Care Responsibility	Responsibility for all movement bodies to the communities they support
Principles of Decision-Making	At whatever level decisions are being made, they should adhere to these principles
Independent Dispute Resolution function	Process to escalate disputes that are not able to be resolved in existing processes that are local; also, acknowledging that conflicts are context-dependent

Hubs: definition and scope of work	Scope, set-up, governance structure, and responsibilities of hubs
Hubs: revised piloting guideline	Proposed updates to the existing piloting guidelines, based on the Charter text
Hubs: revenue generation & funds distribution guidelines	How hubs can generate revenue and distribute funds, in accordance with policies that the GC will create
Global Council (x3 supplementary docs)	Procedure and processes for the GC workings; the Global Council Membership Policy; and recommendations for selection of GC
Amendment Process	Process for how amendments can be made, and criteria for amendment proposals coming from the movement
Ratification Methodology	Process for the ratification vote
Implementation of the Movement Charter	What happens after the successful ratification of the Movement Charter, during the implementation phase

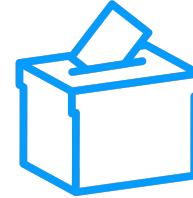
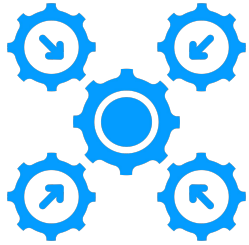
