
TO MR. BARRY:

The undersigned requests that Dr. Hsu Chuan-Ying, 7 Ohmay Road, Kaoloumen District, Nanking, China, be a witness for the purpose of testifying to the following effect:

1. Atrocities committed by Japanese soldiers at Nanking following the fall of that city on December 13, 1937. For the statement see "Report From China - Atrocities Against Civilians, 23 April 1946," pages 31-35.

2. He can also testify as to the effect of the economic aggression by Japan in China and the increase of the opium and narcotic trade in Japanese controlled territory in China.

Dr. Hsu, a Chinese citizen, holds a P.H. Degree from the University of Illinois. He will make an excellent witness.




