

Articles in the Warrant for the Annual Town Meeting, March 3, 1919

Article 1. To choose a Moderator.

Art. 2. To choose a Town Clerk.

Art. 3. To hear and act on all reports presented at said meeting.

Art. 4. To choose all necessary Town Officers to serve the town the ensuing year.

Art. 5. To vote "Yes" or "No" on the question: "Shall License be granted for the sale of intoxicating liquors in this town.

Art. 6. To take action in regard to the highways.

Art. 7. To raise and appropriate such sums of money as may be necessary to defray town charges the ensuing year.

Art. 8. To see if the town will raise and appropriate a sum for the observance of Memorial Day.

Art. 9. To take action in regard to the collection of Taxes.

- Art. 10. To see if the town will vote to authorize the Treasurer with the approval of the Selectmen to borrow money in anticipation of the revenue of the current financial year.
- Art. 11. To see if the town will raise and appropriate \$50 for the support of the Hampshire County Farm Bureau and elect a director of that organization who will be the official town representative for the county board of trustees as per Chap. 273 of the acts of 1918.

Other articles may appear in posted warrant.
