NEW IMPORT LIST

The following is a translation the list of the new import goods and articles announced by the Ministry of Economic Affairs on September 2, 1955.

Cotton manufactured goods:

(under the cotton manufactured goods, to be understood 100 per cent cotton tissue).

Particulars:

GROUP I

TEXTILE.

- 1) Sateen drill, made of fivethread sateen (socalled bastard sateen) is considered as drill.
- 2) As common cotton or mosquito tule (netting), to be considered only unbleached or bleached tule of which the chain or woof threads are single yarn or twined thread with 5 or 6-cornered mesh of the same width over the whole piece without adorns in lanes of 180 cm or more wide.
- 3) Socalled lenos-shirtings to be considered as a lenos-binding, thus if of cotton to be categorized in Golongan I (Category I) unless it can be considered as curtain-or upholstery cloth (in cases of doubt on the categorizing upholstery cloth applies to curtain as decisive factor, the width more than 36 inches).
- 4) Under shirting to be understood;  
Smooth onethread evenbound closely woven cloth made of untwined almost equal thick chain-and woof threads. As tissue of almost equal thick chain-and woof threads, to be considered those tissues of which the number of threads in one direction is less than  $1\frac{1}{2}$  times of threads to the other direction.  
Shirting with crepe effect caused by pressing, calandering or locally worked in with chemicals to be under the shirting regulations.
- 5) Under imitation to be understood;  
Smooth onethread evenbound unclosely woven cloth made of untwined almost equal thick chain-and woof threads.  
Under unclosed to be understood;  
Those whereby the space in between the chain threads as between the woof threads mutually is bigger than the threads themselves.



6) The adornment, ornamentation of imitation voile such as "checked", "dotted", "sprayed" etc. does not decide the categorizing of this article.

7) In cases of doubt or if it concerns cloth, as well as curtain- or upholstery cloth the width is decisive for instance width 36" or less to be marked as clothing; by broader width as curtain- or upholstery cloth.

- 1) sheet iron, steps sheets, black sheet iron, ship sheet iron, galvanized sheet, not corrugated steel sheets.
- 2) profile iron, angular iron not separately mentioned, beam iron, tie-beams, channel iron, U iron, T iron.
- 3) cast iron, cast iron in blocks.
- 4) hoop iron of all kinds.
- 5) iron staves (iron for espanjolettes), level iron, square iron, round bar, concrete iron.
- 6) building cement of all kinds.
- 7) non-ferreous metals  
aluminium in blocks, blades not corrugated or staves, antimonium, cadmium, chrome, yellow copper/red copper in blocks, blades, sheets or staves, lead in blades, blocks or staves. Nickel in blocks, blades/sheets or staves. Zinc.

Woodboard, grey or greyboard, strawboard, turfboard, feltboard and other coarse boardpaper, glossyboardpaper, packing etc compact, resilient, glossed boardpaper, as well as vulcan-fibre, papermache etc made of paper material products viz in so far its hardness equals that of wood or surpassed it; and as far as not mentioned elsewhere.
- 12) Triplex, multiplexwood.

- 13) glass sheets, in so far not coloured, cut, polished, ribbed, silvered, gilded, painted, as well as decorated or design cut, (Note.) frostered glass = coloured glass.
- 14) voliere wire, harmonica wire, sheep wire and other special fence wires, mosquito wire, cupboard wire, ticket window wire and similar wire as well as metal deploy
- 15) roof covering, also gutters, gutter pipes and dormer windows of iron and aluminium.
- 16) fastening material:  
bolts and nuts, rivets, clamping screw and plates, roof bolts, bridge nails, bridge bolts, contra nuts, rivet bolts, screw bolts, screweyes, screwnails, screws, lockers, polescrews.

not mechanically driven machines for the working of metals, stone or glass, as well as wood, horn, bone or other cutting materials also artificial (celluloid etc) not separately mentioned such as wirenets and cutting machines etc.



18) butcher knives, tannery knives, cobbler's knives, pruning knives, occulation knives, cutting knives, with the exception of the socalled "parangs", draw knives and other knives with two handles, rubber tapping knives, blades for safety razors, sheep scissors, tailor's scissors, tinplate scissors etc which by their particular function are characterized as working tools, handled by hand not separately mentioned scissors, pruning shears (garden shears), whether or not nickelplated as well as hedgeshears; hairclippers, also for animals, and spareparts thereof (knifeblades and springs etc) whether or not mechanically driven; razors, barber scissors; knife-sharpener in so far the handles are not made or partly made of amber, tortoiseshell, mother of pearl, ivory, horn or imitation of it, deerfeet or similar products, bone, ebony, faience, glass, nickel, new silver, alpacca, and similar metals.

(Note) scissors, formed as tailor's scissors, but which have a length of no more than 25 centimeters, as well as covered or decorated with precious metals, will not be clasified as tailor's scissors for itemizing.

In case of doubt whether it is butcher's knife or kitchen knife (such as the socalled bush knife and pisau belati), the length of the blade of the knife, measured from the implantation in the handle will be desicive as follows:

a) 5" (12.7 cm) or less to be marked as kitchenknife (Category II) (Golongan II).

b) more than 5" to be marked as butchers knife (Golongan I)-(Category I).

- 33) Paint clay in so far not packed or in tablet form.
- 34) Soldering material of all kinds whether or not combined with other independent elements or metals.

- 42) Angular iron supplied with oblong grooves at regular paces similar to the mecanoboxes so as to simplify the fastening of bolts and nuts into a construction work: such as daxon angular iron.

equipment for rontgentphotography and X-ray and rontgentheraphy, as well as parts thereof, such as clearly belonging to them, X-ray screens and cassettes under this category included (see tariff No. 848); and also drying and development apparatus clearly meant for rontgentfilms.

Rontgentfilms and photographicpaper for Rontgent photography; cardiographs and the additional pastes, anaesthesia apparatus for slaughter cattle as well as slaughter pistols.

- 3) Examination and operation tables and chairs, instruments and dressing material tables etc., furniture for medical and surgical purposes, not separately mentioned also sectiontables and corpse wooden couches, as well as boncholders and pelvis supporters etc. for operational purposes articles and splints (see tariff No. 849) also for disinfectionbowls, instruments sterilisers, bandageboxes etc.

- 9) Canvas of all kinds.
- 10) Carbon plates and carbon points.
- 11) Accumulators not separately mentioned.
- 12) Amplifiers, loudspeakers, microphones and earphones.

- 13) Motorboats clearly in use for shipping.
- 14) Compasses of all kinds with the exception of ship's compasses.
- 15) Cork in blades, cork in pieces, or grain and cork waste, whether or not with kiezelgoer; lime, clay, cement, pitch, tar or other adhesivematerial and whether or not with the addition of resin, vegetable fibres, formed into stones, tiles, plates, tubes and parts of tubes etc. for construction or isolation purposes articles
- 16) Machines, apparatus and equipment for the preparation of flour-paste wares (dough, mixing-kneading, pressing-distributing-and cutting machines and similar machines, apparatus and equipment), which have a weight of 50 kilogramme or more.
- 17) Controll clocks.
- 18) Material in accordance to their construction meant to serve for the illumination and ventilation of rolling-railway-tramway material.
- 19) Gasoline-and machineoilpumps for the street, automobile garages, carparks etc.(for filling automobilereservoirs etc. as well as airpumps and aircompressors in accordance to their make destined for the pumping of tires of automobiles and other transport means and tractors.
- 20) Measuring and counting apparatus, whether or not registering, for the measuring of steam-and or gaspressure or tensions, vacuum, pull, liquidlevel in boilers, number of rotation of axles, produced quantities, and similar not separately mentioned company auxiliaries such as manometres, indicators, vacuummeters, compound meters, carbonoxyde testers, calorimeters, strokecounters, fluidtankcounters etc. also for watersupplyoilometers.
- 21) Instruments and apparatus for observation, measuring, gauging, controlling, registering or testing or demonstration purposes not separately mentioned one or other in so far for scientific purposes or aimed as auxiliaries for industrial or technical companies and enterprises or agriculture.

- 22) Milkseparators, butter churers, and butterkneadingmachines, curdlechurners, curdlewheel and separators and cheese presses, and similar machines and other equipment for dairing not separately mentioned which have a weight of 20 kilogrammes or more.
- 23) Iron traffic bridges and piers, as well as parts screwpoles, screwblades, etc., parts, as well illuminationpoles (such as poles for arclamps) and not separately mentioned other masts, lanternpoles of metal.
- 24) Sprays, watering-spraying, and dusting equipment which are used for the caring of flowers, the combatting of destructive insects or parasites etc as well as machinedriven pumphmotors for the watersupply of houses, hotels etc. parks, gardens etc.
- 25) Handsprays for the lubrication of machines and of other tools and instruments and equipment; also paintsprays and other tools working automatically by compressed air and other equipment belonging to them (aircompressors, etc.) for powersupply.
- 26) Micrometers, slidemeasures and other not separately mentioned instruments for determining the thickness or the calibre of goods; also speedometers for screws and similar instruments; and clamps etc. tools for the measuring of the thickness of trees.
- 27) Electric installation for the prevention again thefts or fire, the opening of door and other similar purposes and not separately mentioned, part of the apparatus, tools and equipment (tariff No. 795) and the signallamps belonging to them.
- 28) Upholstory (manchons, feltsleaves) for machinerollers, of felt or feltlined woollen or cotton tissues, as well cotton or woollen velvet, also velvet or puchelike tissues of particular structure, such as woven in endless lanes, for paper and other factories (tariff No. 386) as well as for other technical purposes such as isolation.
- 29) Washingmachines (machines for washing and trimming mangling and ironing) of domestic clothes, body-linen etc. not separately mentioned, pressing machines for clothes and presses (trouser presses tie presses and other similar toiletrequisites used

Plate-glass (mirror- and window-panes, and other glass in plates or sheets) regardless of manufacturing method and irrespective of form, polished (glass which, by cutting, polishing and alike workings, is free of unevenness and impurities and therefore shows reflecting surface), ribbed (fluted), gilt, silver plated, painted or provided with ornamental grinding or designs; including coloured window-panes.

(Note) Glasses tinfoiled or other provided with reflecting layer serving for mirrors are not included under this.

Under coloured glasses, also to understand so-called milk glass and "flatted" glass (uncoloured glass covered with thin layer of coloured glass), but not ground glass.



### Small wares

1. Perfumery and make-up articles including tooth-powder, mouth-wash, baby-powder, medicinal powders and alike articles.
2. All kinds of soap, soap-substitutes and not separately mentioned washing-means with exception of medicinal soaps.
3. Glass and glassware for household use provided with ornamental-grindings and/or designs gilted as well as silver-plated.
4. Air-pressure pistols and rifles and their ammunition.
5. All kinds of clocks ordinarily used to indicate time including stop-watches and alarm-clocks, and their accessories.
6. Napkins, table cloths, table-centres, carpets, wall-carpets, and alike also in piecework or in rolls or other also if made of artificial plastic material.
7. Cutlery, including table and dessert spoons and forks, soup-spoons, sauce spoons, tea spoons, tart-and fish-server and other similar utensils usually used at eating and drinking.
8. All kinds of combs.
9. Cigar- and cigarette lighters.
10. Kitchen-knives, like potato-knives, haricot bean knives, not separately mentioned cabbage- and cucumber planes, chopping knives etc., including tin-openers, cork-screws, soap planes and similar articles.  
Table-knives, dessert knives, bread-knives (also bread-sawknives), penknives, hunting-knives, erasing-knives and other not separately mentioned knives which can be handled with the hand.  
Carving-knives, oyster-, fish-, and fruit-knives, cheese and butter knives and alike special knives, small knives for table- and alike uses, also fruit knives in standard and cheese planes for table use.  
Electric razor or safety razors; perforating wheels and not separately mentioned tweezers; craving scissors, egg-clippers knives and scissors, grape-scissors and alike table utensils including nut-crackers, implements to peel nuts and areca-nut (pinang) scissors (katjips); pocket- and toilet scissors, nail

- files, nail-scissors and nail-pincers, manicure- and pedicure utensils including corn cutters and -planes and other combinations. Cigar cutters, and cigar scissors and cigar box openers; envelope openers and paper knives (writing desk articles); including post-stamp tweezers and so-called universal scissors, (scissors which beside as an ordinary scissor, can also be used for various other purposes, for instances as cigar clippers); knife-sharpener.
11. Music instruments and their accessories.  
(Note) Harmonicas with less than 7 holes, are specified as toys.
  12. All kinds of gramophone needles.
  13. Kitchen-machines for household use (not electric).
  14. Fire-arms and ammunition so far not imported by or in behalf of Government agencies.
  15. Tuning-forks.
  16. Thermometer for room; window; and bathroom.
  17. Wicker work and tissues of artificial plastic material, not measured.
  18. Toilet articles of caoutchouc or plastic material (articles for toilet purposes), like air cushions, ice caps and alike.

### Technical articles

1. Bicycle accessories not separately mentioned.
2. Race-cycles and tandems.
3. Strong boxes and strong-room doors.
4. Outboard motors less than 7½ horse power.
5. Radio-receiver sets in so-called furniture-form built in chests, boxes or bags, with f.o.b.-value of Rp.550 per set at the utmost.  
(Notice) Under this, also to include:
  1. Loose accessories to make complete set (so-called radio-assembling set).
  2. radio-receiver sets built in cases, which from their appearance are apparently not suitable in residence regardless of their value, with exception of auto-mobile-radios.



Sundries

1. House articles of porcelain and crockery.
2. All kinds of Christmas tree ornamental articles.
3. All kinds of assemblage-games, hazard games and dexterity games.
4. All kinds of personal ornaments for personal use.

10. All kinds of writing inks and inks for stamping.

All kinds of calendars, advertising-printed matters, whether or not in book-form, year-books and annuals, forms, posters and leaflets, advertising- blotting papers, time tables, price-lists, blue-prints, hutplans, colour-cards, admission tickets and alike tickets whether or not in rolls, coupon books, rail- and tram tickets, sign boards, poster stamps, labels, (also so-called tax-transfers), printed veneers and edges for cigar-cases and cigar bands, furthermore wage and alike badges.
12. Gutji tanah (earthen kitchen utensils)
13. All kinds of tents.
14. All kinds of stretchers.
15. Hospital beds.
16. Scotchlite reflective materials and alike light reflecting materials.
17. All kinds of camouflage nets.

1. All kinds of propelling pencils and fountain pens not entirely of precious metal, including their parts.

AMENDMENT IN IMPORT LIST

DJAKARTA, September 23 (PIA).- The Minister of Economic Affairs in a decree has decided that beginning September 20, 1955, the following additional import goods will be included under Group I:

- a) mass wine, sundries No.76; and
- b) basic and expedient raw materials, not separately mentioned, needed by glow lamp factories, breweries, paper mills, tire factories, battery factories, sundries No.77.

The decree further announced that the following articles have been taken out from Group I (Sundries No 23) and placed under Group II (Sundries No.2): tobacco juice (extract), tobacco essences or tobacco souce, also mentioned tobacco perfume, whether or not mixed with other substances, Sundries No.23.

IMPORTED GOODS WITHOUT TPI

DJAKARTA, September 20 (Antara).

The Economic Minister to-day has decided that imported goods to be exempted from the new TPI (Additional Import Payment) include the following:

1. All kinds of rice.
2. Baby milk listed in group I Pharmacy No. 8.
3. Gasoline, particularly used for airplanes Grade 115/145 listed in group I sundries No. 19.
4. Newsprint.
5. Educational and cultural reading materials selected by Jajasan Lektur (Foundation of Reading Materials) in accordance with provisions decided upon by the Minister of Education.

The above decision is effective as from September 16, 1955.
