**CHARGE II: Violation of 10 U.S.C. § 950v(b)(25), Providing Material Support to Terrorism**

**Specification:**

**In that from on or about October 2001 to on or about 22 July 2002, at or near Khowst, Afghanistan, OBAIDULLAH, a.k.a. Bertola, Baitullah, Ubaidullah Haneef, and Abajdullah, a person subject to trial by military commission as an alien unlawful enemy combatant, in the context of and associated with an armed conflict, did provide material support and resources, to wit: stored and concealed anti-tank mines, other explosive devices and related equipment in preparation for an act of terrorism, and that OBAIDULLAH knew or intended that said material support and resources were to be used in preparation for and in carrying out a terrorist act.**
