## FOREWORD

The printing and distribution of this publication is authorized by sections 36-2402 to 36-2405, Oregon Code 1930.

Only the names of those candidates for nomination for the various state and district offices to be voted upon at the Primary Election May 20, 1938, who have submitted statements and portrait cuts and paid the prescribed charges therefor, appear herein. Many candidates have not taken space in the pamphlet.

As directed by law, the statements are grouped alphabetically with reference to each office, and arranged in the general order in which the candidates' names will appear upon the official ballots.

Chapter 347, Oregon Laws, 1931, as amended by chapter 152, Oregon Laws, 1933, requires the nonpartisan nomination and election of judges of the supreme court and judges of the circuit court. Statements of those candidates for judicial offices who have paid for space appear in the back part of the pamphlet.

**The pamphlet is mailed only to registered voters whose names have been furnished to the secretary of state by the county clerks of the several counties.**

The official ballots for the several counties containing a complete list of the names of all candidates for the various state, district and local offices are prepared and printed by the respective county clerks, who also assign the candidates' ballot numbers.

Willis Mahoney is 42 years of age, born and reared on a farm, married and has two children, and a college graduate. He was elected to the Washington State Legislature where he was Democratic floor leader, serving in the same session with United States Senator Homer T. Bone.

He was twice elected Mayor of Klamath Falls by an overwhelming vote. As Chief Executive of that City he attracted nation wide attention. In announcing my candidacy for the nomination for Representative in Congress, I have done so only after giving the matter careful thought and fully considering the responsibilities of the office.

I was born on a farm in Indiana 52 years ago. I am not a lawyer. I have engaged in business and I have been a farmer. I know what it means to work all day in the fields and I have followed the plow in the days before tractors were known. Hard work is not strange to me. Because of this I feel that I know the problems of our farmers, and others who toil in shops or in the open.

I shall not make any rash promises, for no one knows what measures may come before the next Congress. World events are moving and changing rapidly today and governments abroad are torn with internal strife, while thousands of innocent men, women and children who have done no wrong are starving and dying amidst the bloody wreckage.

This nation does not want war. I do not want war. But I am in favor of adequate protection of our coasts and harbors and a navy and army strong enough to insure our safety against the attacks of any foreign aggressor. This is not jingoism. It is only plain, common sense and I am for it.

I am in accord with President Roosevelt's general policy of public improvement and conservation of our natural resources for the benefit of all the people. To give employment to an army of idle men I am in favor of a program calling for the construction of footpaths for pedestrians and bicyclists along the principal highways of the country, the costs to be shared by the federal and state governments.

Upon the subject of old age pensions, a start has been at last made. The forerunner of this was the Townsend plan. Much remains to be done and this matter will not be settled right until the applicant is no longer required to file a pauper's oath and the federal government takes upon itself the entire responsibility of distributing fair and just pensions to the aged. I shall work with this end in view and will welcome an opportunity to vote for H. R. 4199.

For the past five years I have served the people of Marion county as sheriff, being first elected in November 1932 and re-elected in 1936. During these years I have contacted the people of every county in the First District and believe I am better acquainted with western Oregon than any other candidate on either ticket. It will be my earnest desire at all times to work harmoniously with other members of the Oregon delegation in Congress for the safeguarding and promotion of the interests of our state.

**OCCUPATION:** Farmer and carpenter; a resident of Oregon for 36 years, and a taxpayer. Born on a farm in Minnesota August 11, 1877, and came to Oregon in 1901. The legislative records at Salem show that I lead the fight for property tax reduction; old-age pension; work for the unemployed and legislation in the interest of the farmer and wage worker. The records also show that I lead the fight against special privilege legislation for corporations and big business. My opponents have refused to accept my challenge to meet me in a series of 15 debates to compare their 4-year state legislative record with my three terms in the state legislature. They prefer to campaign on a new set of promises to gather votes, but what assurance have the people that they will fulfill them any better than their past record shows? Anyone who aspires to be Governor should at least be willing to compare his record with that of

his opponent before the court of public opinion that authentic information may be given to the voters. Promises and misleading statements are now being made in political advertisements by hired campaign managers to cover up past records of aspirants to public office. In order to mislead the voters the political gang has constantly sent statements to the press for publication that I would withdraw in favor of their candidate for Governor. I submit my candidacy to the voters in the primary election on my achievements and legislative record in the Oregon legislature.

**RECOMMENDATIONS:** Only state representative elected three times from Columbia county, which formerly was a Republican stronghold. Elected the last time with the largest majority vote received by any county or state candidate in Columbia county having an opponent. It is often said in Columbia county that more people know Oleen than any other person in the county. I have letters signed by the presidents and secretaries of farm and labor organizations, taxpayers' leagues, pension organizations, school teachers organizations, and real estate men, all voicing approval of my work in the legislature. I have served on the following committees: Chairman, Assessment and Taxation; member Agriculture, Forestry, Utilities, and Counties and Cities.

**LEGISLATIVE RECORD 1933, 1935, AND 1937 SESSIONS:** Worked for and helped put over \$5 auto license; supported economy program which reduced state expenditures more than \$5,000,000 in two years; marshalled the support of the lumber industry and the taxpayer leagues against the timber speculators (House Bill No. 20) which would have exempted timber owners more than \$4,000,000 a year in taxes. I lead a six-weeks battle in the legislature against the strongest lobby at the thirty-seventh session, and House Bill No. 20 was defeated, so that the people who own improved property are saved \$4,000,000 a year in taxes. Introduced and secured the passage of House Bill No. 11 extending time for payment of delinquent taxes; House Bill No. 264 providing for the

nonpartisan nomination and election of county school superintendents, thereby taking schools out of politics; lead a successful fight in the House for the old capitol site with a saving of \$550,000 in cost of capitol building. After a careful check of the legislative records I find that my work in the legislature has saved the property taxpayers in Oregon more than \$14,200,000 up to January 1, 1938. Sponsored and supported a tax program which would have replaced \$6,500,000 property tax a year with income, inheritance, and other taxes, based on ability to pay; and a \$45 a month old-age pension for each person eligible. All these bills passed the House with substantial majorities but were killed in the Senate. I voted against every sales tax bill in the legislature, and my stand has been overwhelmingly approved by the vote of the people. I have always supported state legislation that will permit Oregon to receive full benefit of federal laws on pension, farm program, social security, labor legislation and development of hydroelectric power.

**CONFERENCES ON LEGISLATION:** As Governor of the state I shall use the same courteous contacts and leadership that gave me a majority vote on important bills in the House. On the following legislation I shall hold conferences with the members of the House and Senate until satisfactory bills have been agreed upon by the progressives in the legislative assembly: Forty-five per cent property tax reduction in two years by revision of Oregon tax laws, based on ability to pay, and at the same time made in such manner that all state and federal officials and employes who are exempt from income taxes would be required to pay their portion of taxes. Also all others who have by certain legal methods exempted themselves from taxes should come under the new revised tax law, including all who have invested in tax exempt securities.

**HYDROELECTRIC POWER:** Federal and state development of hydroelectric power in Oregon. A state power commission that will have authority to contract with the federal government for Bonneville power and transmission lines. Also to have surveys and estimates made on cost of a distribution system and submit same to legal voters of the state or utility district for their approval. To issue revenue certificates, payable only from the receipts of sale of power. Utility districts and cities to be given first right to purchase power. Distribution of Bonneville power to all users at cost of generation and distribution within practical distances from Bonneville. State of Oregon to pay half of the salary of public grade school and high school teachers. State of Oregon to match federal old-age assistance in full, and also provide for medical care when needed for each pensioner 65 years of age and over, and repeal law requiring a county property tax for old-age assistance, and to eliminate pauper's oath. Legislation based on human welfare that will promote a better understanding between wage workers, farmers and employers in Oregon. Legislation that will provide work for the needy unemployed rather than charity or a dole. The delay in law enforcement until just before the primary election for political purposes is not the kind of law enforcement the people want. I stand for law enforcement without delay, with fairness and justice to all.

In conclusion I wish to say that my home has been my campaign headquarters and the friends that I have made in public service, working for the welfare and prosperity of the common people, have acted as my campaign committee. Farmers, wage workers, home owners, pensioners, and unemployed, let us cooperate and work together for better living conditions in Oregon. The time has come for all progressives to work together for a new deal in Oregon. My pledge is to continue my work for the general welfare of the common people in Oregon.

In 1915-16 he served with the old 3rd Oregon Infantry, and in 1918 he was a soldier in the World War.

Mr. Leonhardt is a Mason. He belongs to the American Legion, the Grange, and Phi Delta Kappa national honorary educational society.

Mr. Leonhardt was nominated by Oregon Democrats in 1934 for Superintendent of Public Instruction. His home county gave him the greatest proportional majority won by any Oregon candidate. In the general election he received over 118,000 votes. Between May and November he gained over 85,000 votes, the largest gain made by any state candidate. The Oregon Voter commented: "The widespread support he received was from school teachers who knew him as an educator and were active in campaigning for him among Democrats all through the state." The rank and file of Oregon teachers, the younger school administrators and superintendents, and many thousands of Oregon Democrats are working for the re-nomination of Mr. Leonhardt. I am a candidate to fill the vacancy in the Supreme Court caused by the death of Judge Campbell last year, and now held by appointment by the Governor until filled at the next general election.

I am now completing eighteen years as attorney-general of Oregon following many years as assistant in that office. This position has given me wide experience in construing the statutes and constitutional provisions of the State and United States, and has required a thorough familiarity with the law and procedure in the courts. The questions considered in the legal opinions and oral advice of this office include practically the entire field covered in the duties of a Supreme judge. The interpretation involved in such questions requires the exercise of judgment for their solution similar to that of the court. My opinions upon such questions very rarely have been reversed by the courts.

My duties as attorney-general have also required me to represent the State in a very large number of cases in all of the state and federal courts, including the United States Supreme Court, many of them of great

importance. This experience cannot be otherwise than most helpful in the discharge of the duties of the office to which I aspire.

I was born and reared on a farm near Halsey in Linn County, Oregon, and am a graduate of Willamette University, in both the Colleges of Law and Liberal Arts, having earned my own way while a student there. I was for many years an instructor in the College of Law of Willamette, in addition to the active practice of my profession, and was Dean of that College from 1913 to 1927, and am now Dean Emeritus.

I have vigorously, but fairly, enforced the criminal laws when assigned to such duty by the order of the Governor, as provided by law, in cases where the local law enforcement agencies have been inadequate, or, for any reason, prevented from acting efficiently. I procured the enactment of the law requiring payment of royalties for the taking of sand and gravel from navigable streams, resulting in the increase of the common school fund by over half a million dollars up to now, without increasing taxation on property, and such income will continue indefinitely. I secured title to more than 20,000 acres of land for the common school fund.

I materially aided in the enactment of the laws providing for soldiers' bonus and loans, and successfully defended them when attacked in court. I have always construed such laws so the veterans could receive the benefits intended for them, also the fish and game laws granting special privileges to veterans. I wrote the original law granting veterans and their widows exemption from taxation of their homesteads, or other property selected, to the value of \$1,000, and have always construed such statute liberally.
