II. POLITICO-MILITARY PROBLEMS IN THE FAR EAST (SWNCC 16/3).

Appendix "A" of SWNCC 16/3 was reviewed by the Working Committee to ascertain the number of procedural papers still to be written on the topics in the Appendix.

It was agreed that the Department of State representatives will undertake to submit a procedural paper on Item IV-1 which will indicate the areas which, from a political point of view, should be occupied in the Japanese Empire and any other Far-Eastern area.

Colonel HARLOE stated that a draft of Item V-4 - "Proclamation of the Allied Commander-in-Chief (Assuming supreme authority in the absence of an Unconditional Surrender)" had been prepared and is available. Dr. BLAKESLEE agreed to undertake the preparation of Item V-5 - "Proclamation of the Allied Commander-in-Chief (Assuming supreme authority in the event of capitulation or unconditional surrender of Japan Proper and continued organized resistance elsewhere)"; both items to be submitted to the Subcommittee at the same time. Colonel HARLOE will undertake at the proper time to find out from the SWNCC Secretariat whom to consult as to the legal aspects of Japanese unconditional surrender in accordance with the recommendation of the Subcommittee at its 9th Meeting.

The following procedural papers prepared by the State
Department members were then considered, discussed and approved
by the Working Committee:

- (1) "The Post-Surrender Military Government of the Japanese Empire: The Policy with respect to Armament Production and Facilities".
- (2) "The Post-Surrender Military Government of the Japanese Empire: Policy with respect to Heavy Industry in Japan".
- (3) "The Pest-Surrender Military Government of the Japanese Empire: Policy with respect to the Aeronautical Industry".
- (4) "The Post-Surrender Military Government of the Japanese Empire: Policy with respect to the Shipbuilding Industry".
- (5) "The Post-Surrender Military Government of the Japanese Empire: Extent of Regulation of Foreign Commerce".
- (6) "A Temporary International Supervisory Authority in Korea: Relationship with Military Government."

The above papers will not be presented to the Subcommittee for the Far East until after SWNCC action is published on SWNCC 16/3, (Revised list of problems in the Pacific and Far East).



II. FORM OF COVERING PAPER.

The Sub-Committee appointed at the last meeting to develop a standard form for submission of papers to SWNCC submitted its form. Lt. FOWLE submitted a further proposal. In the meantime, a standard form for all SWNCC papers was received from the Secretariat of SWNCC. Mr. BORTON brought up the point in reference to Appendix "A" of Colonel HARLOE's draft that in order to avoid unnecessary channels in the Department of State, it would be advisable to address the draft letter to a specific office or person such as "THE DIRECTOR OF THE OFFICE OF FAR EASTERN AFFAIRS" instead of "THE SECRETARY OF STATE". This change was tentatively accepted subject to approval by the Department of State.

III. SWNCC MINUTES - 11th Meeting - 23 February 1945.

Captain PENCE read certain pertinent paragraphs of SWNCC minutes to the Working Committee. It was noted that 3 additions were made by SWNCC to Appendix "A" - SWNCC 16/2 (List of Topics prepared by the Working Committee), viz: e. The nature and extent of industrial control; f. Education; g. Control of public information (Paragraph VI.10).

Paragraph 2 b of the SWNCC Minutes was discussed and clarified by Lt. FOWLE who attended the SWNCC meeting. Lt. FOWLE stated that SWNCC desired the Sub-Committee to clear informally all papers with the appropriate committees and representatives of the Joint Chiefs of Staff on the working level. Formal approval is to be obtained by SWNCC from the Joint Chiefs of Staff in appropriate cases.

IV. COLLAPSE OF JAPAN.

Colonel COLLIER submitted the covering paper for the Draft Proclamation of the Commander-in-Chief, United Nations Armed Forces (In Absence of Unconditional Surrender) which was discussed and revised in the 7th Meeting. THE COMMITTEE considered the paper, and after full discussion and revision, it was agreed to redraft the proposed covering paper and re-submit to members for consideration at the next meeting to be held Wednesday, 28 February 1945, at 0930.


The heading and lst paragraph of the paper were redrafted. The new draft was to be submitted to the members for consideration at their next meeting.

1. SWNCC 16. Politico-Military problems in the Pacific.

After discussion it was agreed that the immediate problem of the Sub-Committee consisted of the following:

- A. To prepare an initial agenda on the politico-military problems which are anticipated in the Pacific Far Eastern areas.
- B. To establish priority for necessary action thereon.
- C. To indicate who should initiate the work on such problems (J.C.S. agencies, agencies of the State, War, Navy Departments, special ad hoc committees with members from State, War, and Navy Departments, and other appropriate agencies.)

There was considerable discussion as to whether or not the PFESC should limit its consideration to politico-military problems arising during the post-Japanese surrender period. Several members expressed the opinion that the PFESC should so limit its activities and that a strong recommendation to this effect should be made to SWNCC.
