OCT 50, ON UNIDENTIFIED FLYING OBJECTS.
ITM REGARD TO INCIDENT OF 13 SEP.
O, IT WAS POINTED OUT IN CONVERSATION
WITH AMC PERSONNEL THAT THE ORIGINATOR
AS A CESSNA TEST PILOT. SINCE THIS IS
NOT STATED IN CSAF ITEM 9 TT-658-AM
DATED 3 OCT 50, THE TELECON ITEM IN
QUESTON WAS NOT ASSOCIATED WITH THE
REPORT BY MR. [REDACTED] THE INCIDENT REPORTED
BY MR. D. D. FRYE WAS REVIEWED BY AMC
HEN RECEIVED.

THE NATURE OF THE INCIDENT TOGETHER
WITH THE DETAILS FURNISHED WERE SUCH
THAT THEY DID NOT CONSTITUTE A BASIS
FOR A COMPREHENSIVE TECHNICAL INVESTI-
GATION. THIS COMMAND HAS HAD SEVERAL
REPORTS OVER A PERIOD OF YEARS ON WHICH
THE DETAILS WERE SIMILAR TO THIS INCIDENT.
IT IS SIGNIFICANT TO NOTE THAT THERE
ARE NO OTHER REPORTS OF SIMILAR OBSER-
VATIONS FROM PEOPLE IN THE VICINITY
OF EFFINGHAM, ILLINOIS AT THAT TIME.

CHECK OF WEATHER DATA REVEALED
SCATTERED CLOUDS AT 4,000 FT AND VISI-
BILITY OF 15 MILES AT 1930-1940
OURS. NO ASTRONOMICAL PHENOMENA WERE
REPORTED BY OTHER PILOTS IN THIS AREA.
IT ALSO IS NOTED THAT THE TELECON IN
QUESTON CONTAINS NO ESTIMATE BY
MR FRYE AS TO THE SIZE AND DISTANCE
INVOLVED OTHER THAN THAT THEY WERE
VISILE FOR SEVERAL MILES. CONSIDERING
ALL AVAILABLE FACTORS IT IS THE
OPINION OF AMC THAT THE REPORT IN QUEST-
ION CAN BE ATTRIBUTED TO SEVERAL
POSSIBILITIES. WHILE THE DATA PRE-
SENTED DO NOT PERMIT THE ISOLATION
OF POSSIBILITIES AS TO THE DIRECT
CAUSE, IT APPEARS THAT THE INFORMANT
MAY HAVE SEEN OR IMAGINED HE SAW
SEVERAL LIGHTS, BUT THE CONDITIONS
ARE SUCH /IN FLIGHT AT NIGHT/ THAT
OPTICAL ILLUSIONS ARE COMMON. THIS
COMMAND CAN CARRY THIS INVESTIGATION
TO GREATER LENGTHS IF DESIRED,

CHECKING ON THE POSSIBILITIES OF
OTHER AIRCRAFT BEING IN THE AREA AT
THAT TIME AND WHETHER THERE WAS ANY-
THING ON THE GROUND IN THE BELIEVED
TO BE WARRANTED IN THIS CASE.

SUBJ: REPORTING OF INFO ON UNCONVENTIONAL AIRCRAFT.
MR. ██████████ WAS INTERVIEWED TO SECURE INFORMATION ON AN

UNIDENTIFIED OBJECT SIGHTED BY MR. ██████████ AT APPROXIMATELY 1930 - 1940 HOURS, 13 SEP 50. INTERVIEWING OFFICERS WERE LT. COL. M. D. WILLIS AND MAJOR A.J. BOOGS.

THE FOLLOWING INFORMATION WAS SECURED ABOUT HIS OBSERVATIONS.

TIME - 1930-1940 13 SEP 50

PLACE - (88° 36'W) (39° 03'N)

5 MILES SW OF EFFINGHAM, ILL.

ALTITUDE - 8000 FT.

MR. ██████████ AND PASSENGER OBSERVED A SET OF THREE LIGHTS ON A COLLISION COURSE WITH THEIR PRIVATE AIRPLANE. A SHARP TURN WAS MADE TO THE RIGHT AFTER A SLOW CLOSURE. MR. ██████████ HAD FLASHED HIS LANDING LIGHT SEVERAL TIMES.

AFTER THE TURN, MR. ██████████ SAW THAT THERE WAS PLENTY OF CLEARANCE AND MADE A CLIMBING TURN TO THE LEFT TO SEE WHAT THE OBJECT WAS.

AT THIS TIME, THE LIGHTS APPEARED AS A DIM ROSEY RED ARRANGED AS A TRIANGLE. DUE TO THE DARK NIGHT, NOTHING ELSE COULD BE SEEN.

BEFORE THE OBJECT COULD BE CIRCLED, THE LIGHTS DISAPPEARED. MR. ██████████ THEN TURNED ON COURSE TO TERRE HAUTE, IND., LANDING THERE AT 2010 CST.

MR. ██████████ IS A PILOT WITH APPROXIMATELY 6000 HOURS FLYING. HE HAS FLOWN ABOUT 500 HRS AT NIGHT., HE IS CONSIDERED RELIABLE AND ACCURATE.

STEADY LIGHTS EVENLY SPACED.

INFORMATION SHOULD BE HANDLED ACCORDING TO AIR FORCE LETTER, "REPORTING OF INFORMATION ON UNCONVENTIONAL AIRCRAFT", DATED 8 SEP 50.
