The Las Vegas Office advised on 3/29/65 that LV-ten-C furnished information that ROSSELLI checked into the Desert Inn Hotel on 3/27/65 for an indefinite stay. On 3/29/65 the Los Angeles Office ascertained that ROSSELLI's automobile was parked at Valet Parking at the Los Angeles International Airport and that it had been brought in on 3/27/65 at 12:25 p.m. Inquiry at Valet Parking revealed that someone left ROSSELLI's car at Valet Parking at 12:25 p.m. on 3/27/65 without leaving a name or stating how long the car would be there. Valet Parking is immediately adjacent to Trans World Airlines (TWA) terminal and it is surmised that ROSSELLI probably took TWA Flight 199 for Las Vegas at 12:25 p.m. on 3/27/65.

Information was received from the Los Angeles Police Department Airport Detail that ROSSELLI returned to Los Angeles on 3/31/65 at 10:35 p.m. arriving on TWA Flight No. 57, and he picked up his car at Valet Parking.

GEORGE HOPKINS, Manager, Glen Towers Apartments, advised on 3/31/65 that he had not seen ROSSELLI for several days. On 4/1/65 HOPKINS advised that ROSSELLI was observed by him on that date leaving the apartment alone at about 12:15 p.m. HOPKINS said that during the time that ROSSELLI was gone, there was no mail received at the apartment and no telephone messages were left for him.

LA 4468-C-TE advised on 3/31/65 that on the evening of 3/18/65 he went to Tracton's Restaurant on La Cienega Boulevard in Los Angeles and observed JOHN ROSSELLI and HAROLD MELTZER seated with three unknown men at a booth away from the rest of the customers, and it appeared that these men were having a conference. It is noted that reliable informants advise that MELTZER is currently engaged in shylocking operations in the Los Angeles area. MELTZER is the subject of a current Anti-Racketeering investigation by the Los Angeles Office.

Review of EMANUEL ROTHMAN's Trustee Account at the Union Bank, which account has been used in the past for financial activities of ROSSELLI, revealed that the account was used during the past month to pay ROSSELLI's rent and to pay for the purchase of some stocks through Hayden-Stone, Inc.

The Department of Motor Vehicles, State of California, Sacramento, California, advised that the registration of ROSSELLI's automobile is being held up until a certificate is received from ROSSELLI showing the price he paid for the car so that the California Use Tax can be accurately assessed.
