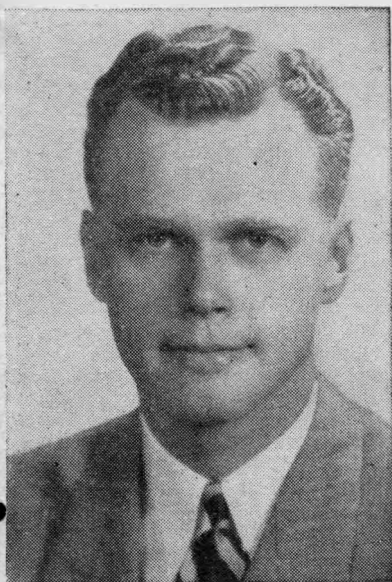

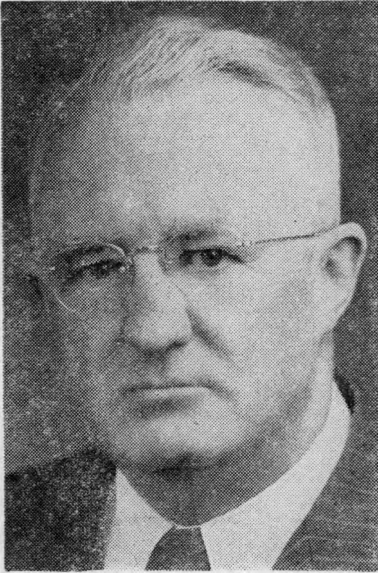

Mr. Epperly has had abundant business experience and background for this delegate responsibility.

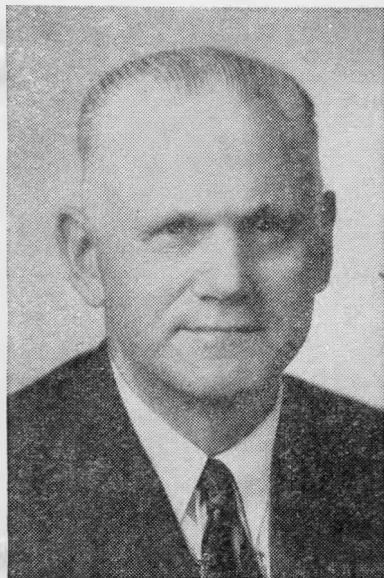

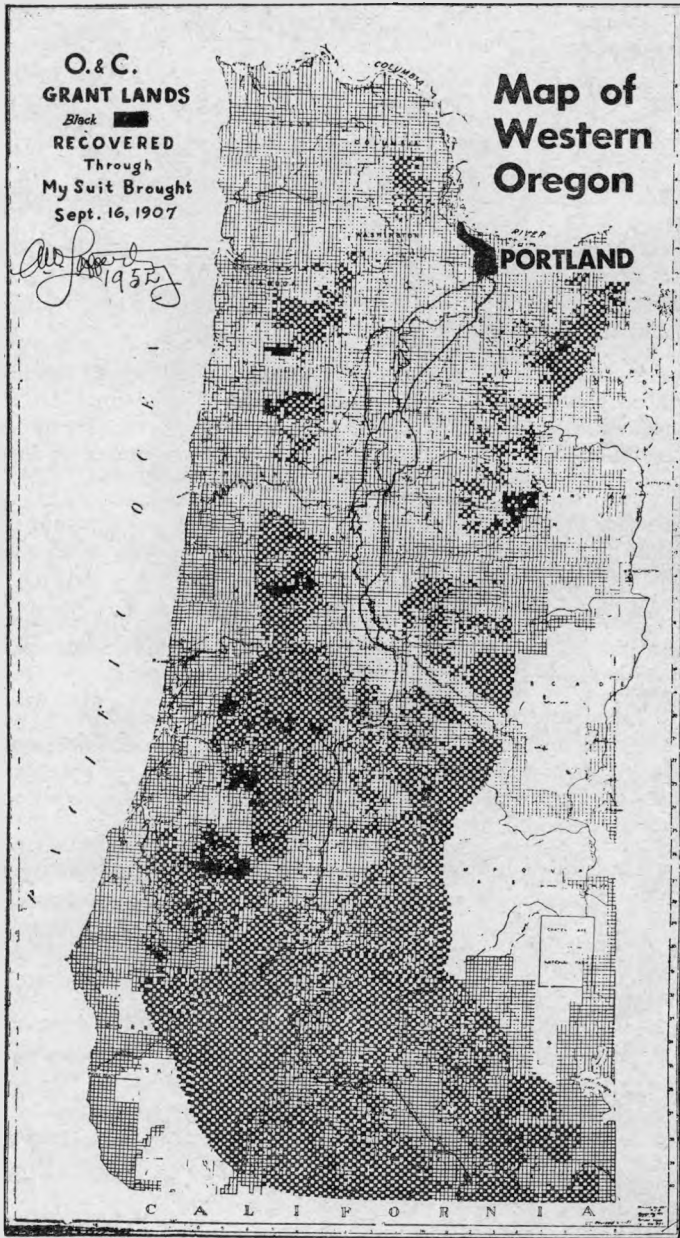

The lands (2,500,000 acres in Western Oregon) are worth a billion dollars. They will yield to Oregon's state treasury forever at least 5 per cent net, or 50 millions a year to reduce state taxes. Eastern Oregon—all Oregon, will participate alike in the benefits, Multnomah county very heavily since Multnomah citizens pay 35 per cent of the state's taxes. Of course the land grant counties will each year be paid their real estate taxes lost by reason of the lands not being taxable, but that is a bagatelle compared to their income value.

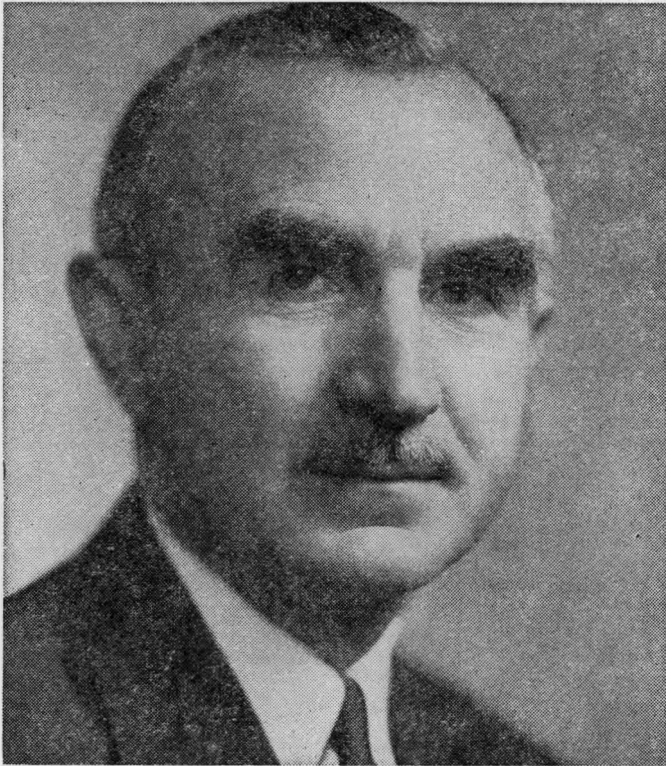

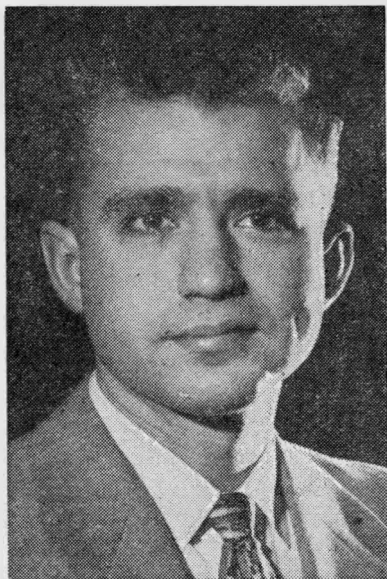

that with my background and experience, I understand pretty well what is going on in the mind of the ordinary citizen. I was born and raised on the farm in a family of thirteen, attended country school, made my own way through college and law school, graduated from North Dakota University Law School in 1909, and was admitted to the bar that year.

Some law business left unfinished by another attorney took me into the Western part of the state then recently opened to homesteading. Once there, I soon got the fever and filed on a 160 acre homestead, 45 miles from a railroad and 20 miles from the county seat. My neighbors helped me build a sod shack in which I opened my first law office. This sod shack also served as campaign headquarters from which these same neighbors and a lot of other good neighbors made me State's Attorney for Dunn County. Two saddle horses solved my transportation problem.

On doctor's advice on account of the wife's hay fever and asthma, we came West in 1923. Thanks to the Oregon climate she completely recovered in a short while. After roaming, more or less, the first six months, the wife fell completely in love with Silverton. It was my hope and ambition to practice law in Portland. The wife argued it would be better for our four kiddies to grow up in Silverton—she was right.

Wife and I are not much on the joining order. I belong to the Chamber of Commerce, the Izaak Walton, the Bar Association and the Justice Association. I am very much interested in the work of the Prison Association. The wife belongs to the Ladies Aid, Home Extension, Women's Federation, etc. We belong to the Trinity Lutheran Church where the wife is organist and the daughter is choir director.

I am now serving my seventeenth year as Justice for the Silverton District, a position I had never dreamed of holding until I was appointed by Governor Charles Martin. I protested to the Governor that it would not look good for him, a stalwart Democrat, to appoint a Republican. He made it perfectly plain that it was AN ORDER.

Now back to the delegate business. I believe that to win in November we must nominate candidates who stand the best chance to win at the polls. Above all they must be God-fearing men possessing the faith and fortitude of the founding fathers. They must be men of wisdom, ability and courage sufficient to stamp out corruption and drive the Reds and Rascals out of the Government. 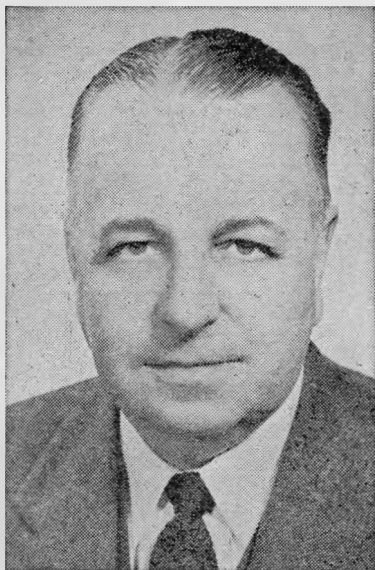

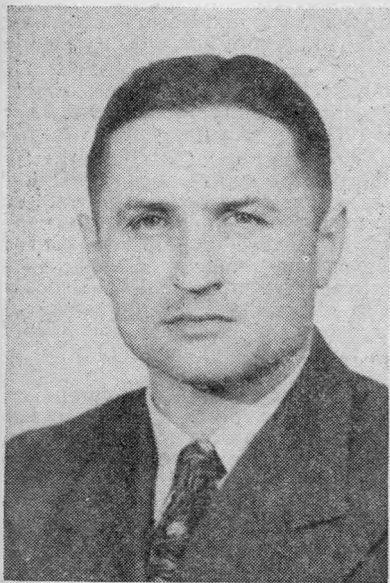

Son of the late State Senator Sam H. Brown, long time member of the Oregon Legislature, twice candidate for Governor and once for United States Senator.

A graduate of Oregon State College; occupation, farming; married, two children; Presbyterian; age 43.

My introduction to politics began early, having grown up, so to speak, in Oregon's old capitol building. During those years my father, long known as the Gervais Farmer, was first a representative, later, and for several terms, a state senator. Many times, as a legislator, my father stood alone, if need be, to defend the cause of the common people. His decisions were based solely

upon his concept of what was right as opposed to what was wrong in the conduct of government—a concept never clouded by yielding to selfish pressure groups, by legal retainerships, vote bargaining or by aspirations of personal advancement. Throughout his legislative career he established a matchless record of honor and integrity. His was a reverence of oath of office unique in his day, virtually unknown in this.

In 1934, basing his campaign upon his legislative record, he became a candidate for governor; narrowly missed the Republican nomination. Curiously enough, and in concert with other devices, it was the corrupted leadership of a farm organization which was utilized to beat him down in that election.

My father became a candidate for U. S. Senator in 1936, and again for Governor in 1938. The political machine, that insidious undercover force which reaches its controlling hand into both political parties, Republican and Democrat alike, was taking no chances in these campaigns. My father was victimized by practically every device known to the manipulators of elections. In addition, he was ridiculed, misquoted and misrepresented and made the object of slanderous whispering campaigns, to the end that political compromisers and yes men were once more elevated to high office.

Having assisted my father during the course of these three state wide campaigns, and having experienced first hand the corrupt devices employed to beat down and destroy a man that could not be controlled, all this in our supposedly free elections; it became apparent to me that national disaster must surely befall a nation where candidates for high office, if they were men of uncompromising honor and integrity, were subjected to such brutal and unprincipled attack.

From all of this I came to learn why it was that men of truly high principle had practically disappeared from public life; and in their place were the compromisers, and the cheap political hacks, men of great greed and

ambition and low moral value. These were the men whose campaign statements were generously played upon by the press; whose character was loudly extolled and whose families graced the society pages. To such men as these are chargeable the present decadence of government; the involvement of this nation in three great and needless foreign wars; and now, in the wake of other great and exhausting European and Asiatic conflicts, its foreseeable bankruptcy and destruction.

During the course of those three campaigns I came to know and understand the corrupt political structure of this state and nation, and the force behind that corruption, as only the political reformer can know it.

By 1940 a great national issue emerged—the question of participation in another foreign war. Versed as I had become in the subterranean workings of American politics I realized that the talk of war for freedom, of war for peace, of war to guarantee the territorial integrity of Poland; and other so-called lofty ends generously identified with the cause of God, was but a magnified repetition of the propaganda, hypocrisy and treachery of 1917. Also, still smarting from the unprincipled going-over my father had received in the election years of '34, '36, '38, I resolved to personally enter the campaign for Congress in Oregon's first district; exposing the complete and sordid political picture, and the move being made, and by whom, to involve us in the European conflict, and to what end.

In four pages of the Voters' Pamphlet, and subsequently in my campaign, I denounced the propagandists and the politicians who talked of freedom and peace through war as instruments in the hands of international and alien manipulators. The "steps short of war" I labeled as direct steps of involvement. I further, and most importantly prophesied that the great gains from the war, once entered, would gravitate to the SPONSORS OF WORLD COMMUNISM—That, be reminded, was in 1940, nearly two years before Pearl Harbor. And I identified by name that secret undercover and conspiratorial force, international by nature, which manipulates our elections, controls our press, our radio, our motion pictures—that same force which was propagandizing our people; pushing around the kept politicians and front men, and forcing the country inexorably into that war to serve the secret objectives of world communism and international finance.

Strangely enough, for pulling back the curtain upon this sordid picture of international intrigue, so soon to claim its thousands of American dead, I became the villain. I shall not dwell upon the savage and near hysterical attack which was hurled against me. Among a host of other implications and false accusations, including treason and sedition, I was definitely established as "radical". Now I ask, in retrospect, and in light of the ghastly price which has been paid, and is being paid, and will be paid to the very destruction of this Republic and the entire Christian world: WHO WAS THE RADICAL IN 1940? Was it I, for exposing this criminal conspiracy and its ultimate, wasteful and disastrous conclusion—or was it the "respectable" politician, the editor, or the minister who went along with the propaganda and the "steps short of war"?

Significantly, a sequel to my campaign, the 1941 Oregon legislature established by law a censorship upon the Voters' Pamphlet. By this outrageous act certain politicians in office are empowered to censor campaign statements, even those of rival candidates—despotic, un-American, unbelievable, but true.

The hidden hand had moved once more; this time closing a last loop hole, as it were, through which the most deadly and the most vital truth of the day might be carried to the people. . . . A truth of such overwhelming import that its knowledge or lack of knowledge in the public mind means the life or death of this Republic. . . . A truth which I cannot here discuss, as I did in 1940, by reason of this imposed censorship. Quite a commentary of the times when one considers the number of American boys who have just been sacrificed to establish, among other "freedoms", freedom of speech "everywhere in the world".

Ask yourself: Who, or what requires this screen of censorship? and why? Truth needs no shield of secrecy.

Multiply, if you will, this censorship by virtually every newspaper, every magazine, columnist or radio commentator throughout the nation—a censorship sly and cunning and vigorously policed and backed up by threats, advertising pressure and intimidation. . . . A censorship that slants news; that can play one item out of all proportion to its value or suppress it completely.

Small wonder it is that the American public, drawing its political opinions from the slanted news and tainted outpourings of these controlled and censored publications, columnists and commentators has been led like sleep walkers through useless wars and depressions and today, though aware that great danger threatens, swings blindly in the dark not knowing who or where to strike.

#### WE PREPARE A PHONY WAR ON COMMUNISM

The propagandists leading us into this newest war in the making are the very same that told us of peace and freedom through war in 1940. . . . They are supported by many of the very same politicians and front men.

This is the leadership which caused us, in the name of freedom, to destroy Germany so as to open Europe to Communism; and who, before the smoke of battle cleared, betrayed Poland and other European states to Communism. This is the leadership which held back American armies to permit the ancient European centers of Christian culture to be ravished and despoiled by Mongolian hordes of Asiatic Russia in 1945. This is the leadership which led us to foment war with and destroy Japan so as to open Asia to Communism; and which then promptly and callously betrayed China to Communism. This is the leadership which, to further build and strengthen Communist power, opened the American Treasury and poured out countless billions of American dollars to Russia and Russian satellites long after the war had ended. This is the leadership which has supported socialist and communist infiltrated governments, with a prop of American dollars, in so-called free Europe. . . . Hollow shells in the coming conflict.

Yes, this is the same leadership, the very same; many of the identical politicians and front men which claims NOW to be leading us in a world wide crusade against Communism. . . . When did these leopards change their spots? Have these liars and hypocrites of the forties become tellers of truth in the fifties?

Here, if you will, in these obvious and brazen contradictions of the day, is proof undeniable of the greatest and the blackest conspiracy in the history of all mankind. A conspiracy which has attained the sinister ends of world Communism through the debasement of our government and the mass murder of our youth.

And they have already committed us to this next conflict. . . . Into the endless quicksands of Asian warfare; into the bottomless pits of European battlefields; into the agony of Asiatic prison camps will disappear the flower of American manhood, your son, mine—a series of wars that can be made to last a quarter of a century, or longer if we prove that durable—wars that can siphon off and submerge the entire fighting force of the nation. And will it end Communism? Not at all! Were we to destroy Russia completely it would make no difference, for Russia, though employed as a powerhouse of intrigue and aggression, is a VICTIM of Communism, not its source.

This is not a war designed to end Communism. . . . This is a war to strangle Constitutional government; and a war that will bring to its very end the hope that was born with the Christian era. . . . A continuous state of warfare in the name of "peace" and "freedom". Yes, they at last will give you peace after this war—the peace that comes to the prisoner in the compound. . . . And freedom—the freedom of the totally dispossessed.

I submit herewith a partial list of imminently urgent reforms:

1. There must be no land armies to continental Europe or Asia. We have built on worthless allies; our high command is honeycombed, and treason has done its work. Those areas are prepared death traps for American forces. We should maintain a strong perimeter defense of naval and air power where our technical superiority can retain an advantage without sacrifice of life, or gross expenditure of resources. Disengage our Korean

- forces; replace them with willing Orientals, or not at all. Assist worthy Europeans to defend themselves.
2. Expose by investigations the fountain head of world Communism, largely resident in the U. S.; prove its linkage with international finance, and its infiltration of our government, our army command; and its control of all sources of public information. . . . Ruthlessly purge the operatives and front men of this conspiracy.
  3. Break relations with all Communist nations. Stop diplomatic immunity for spies.
  4. Assist only those nations which purge themselves of socialists and communists.
  5. Throw out the United Nations—it is a beach head of foreign control; already it has overridden domestic law. It is an agency of treason.
  6. Seek out and punish American war criminals.
  7. Clean house in government; dredge through the muck and slime of official Washington; let flow in the clean air and pure water of truth and righteous purpose.
  8. Oppose any universal military training.
  9. Restore the control of American money to the American Congress.
  10. Uphold Christian traditions and principles in the Administration of government.

The way of the political reformer is rocky, hard and beleaguered. He is set upon. Adroitly he is made the object of ridicule. . . . He is victimized by whispering campaigns with their poisonous lies fed into all organizations: farm, labor, fraternal, social. Frequently he becomes an outcast; and too often bears his burden of vital truth alone, all alone. This I know for I long have travelled that lonely road.

I would not today be entered in the fifth Brown campaign of political reform did I not feel that present governmental insanity demands that someone take a stand. . . . That someone rise to say: "Let's stop this plunge into disaster—let's stop the senseless slaughter of foreign warfare with its terrible cost and its proved futility—let's throw out the crooks, the thieves and the traitors."

To point up the gravity of the hour I am impelled to say: "I told you so in 1940". That war of "peace and freedom" became a harvest for the sponsors of world Communism. . . . Quite as I said it would, those twelve years ago. No, I am not boasting; merely attempting to impress upon you that national disaster is already upon your doorstep. I am telling you so again, in 1952 . . . This time of a far greater peril, of treachery compounded with treason. If you are going to stop this trend you will have to support reform now; for 1952 is perhaps the most fateful year in American history. . . . And as America goes, so goes the world.

To those solid and patriotic Americans who believe in Constitutional government; who wish to save our youth from the anguish of warfare; who wish to conserve our vital resources to make abundant their own lives and those of their children; who wish to preserve this magnificent heritage of commonwealth: this campaign is offered. To make this campaign effective you will have to support it with such fervor and force that the professional politician, Republican or Democrat, and the newspaper editor will be brought to understand that patriotism is required of them as well as of the widow's son in the foxhole. A smashing victory could start a trickle through the dike of censorship, treachery and treason.

To the cynics and the doubtful I say: I would rather tend my plow in the field than enter public office burdened with the obligations my campaigns would entail. But I also know, that if no one takes the stand, I soon will have no plow to tend.

If you support this reform campaign, I will not break the faith.

I say to do this first, and then tackle the problem of securing replacement revenues. If we do not, we will just be subjected to added taxes and our problems will be compounded. Let us first secure our homes. Other states have done this and are very happy and prosperous under the arrangement. There are tremendous timber resources of the state that could easily and painlessly assume all the taxes that are now provided by small farms and homes. And the practical part about it is that people outside of Oregon would pay most of the taxes as the incidence would fall upon them. It would amount to a huge revenue from outside the state and give everyone in Oregon more money. It would benefit the merchant and the working man and woman.

It is time that the people of Oregon speak for their own benefit. If we do not, the only prospect is for more taxes and heavier spending. We have the power to determine our own welfare, so why not use it?

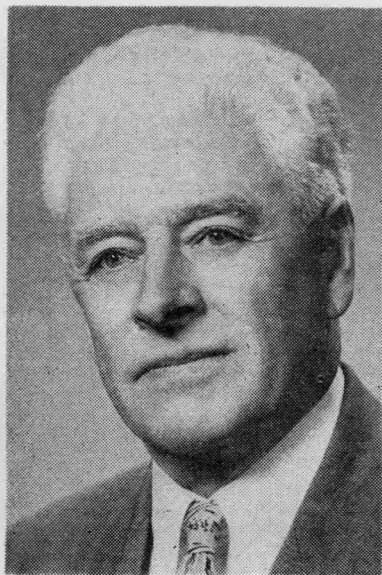

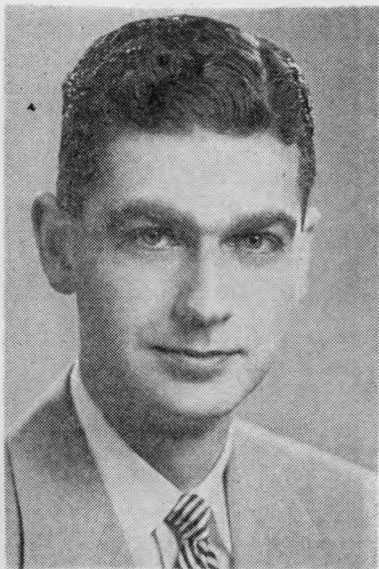

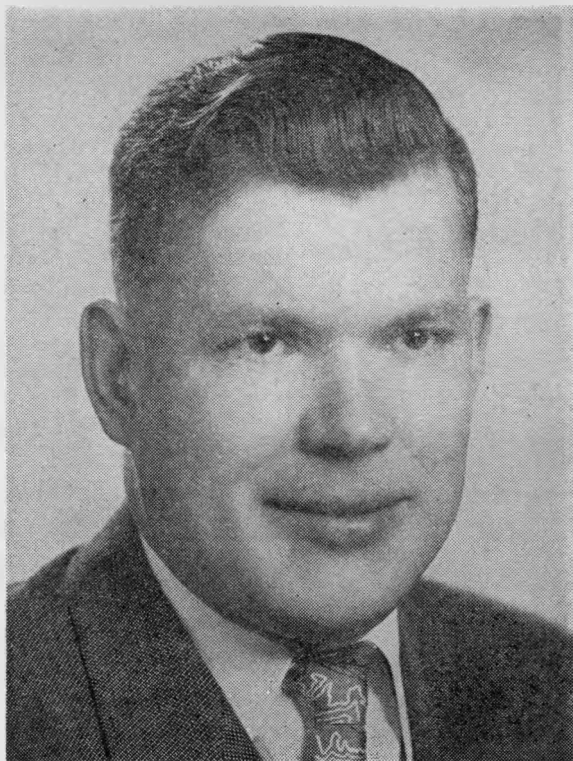

Integrity and service have been my prime business assets. If re-elected, I will continue to apply the same principles in representing the people of Marion County and the State of Oregon.

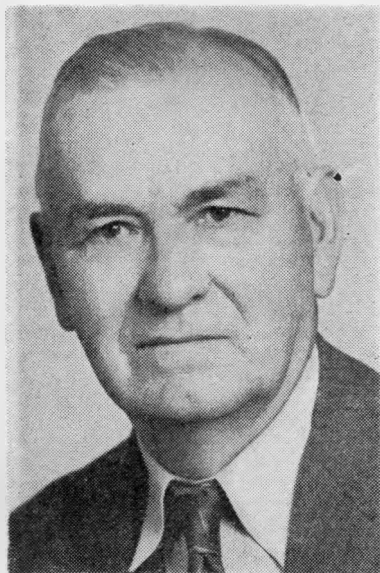

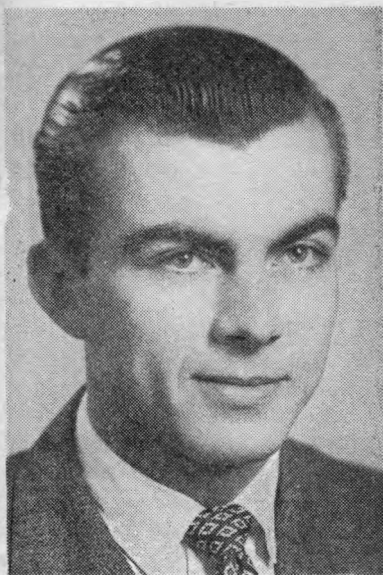
In 1951 he received the top Marion County Bar Association endorsement for a district judgeship.

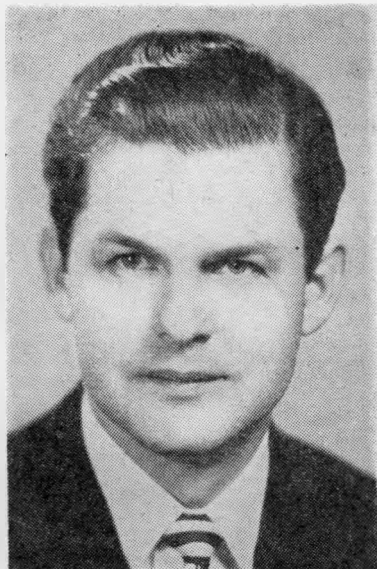
