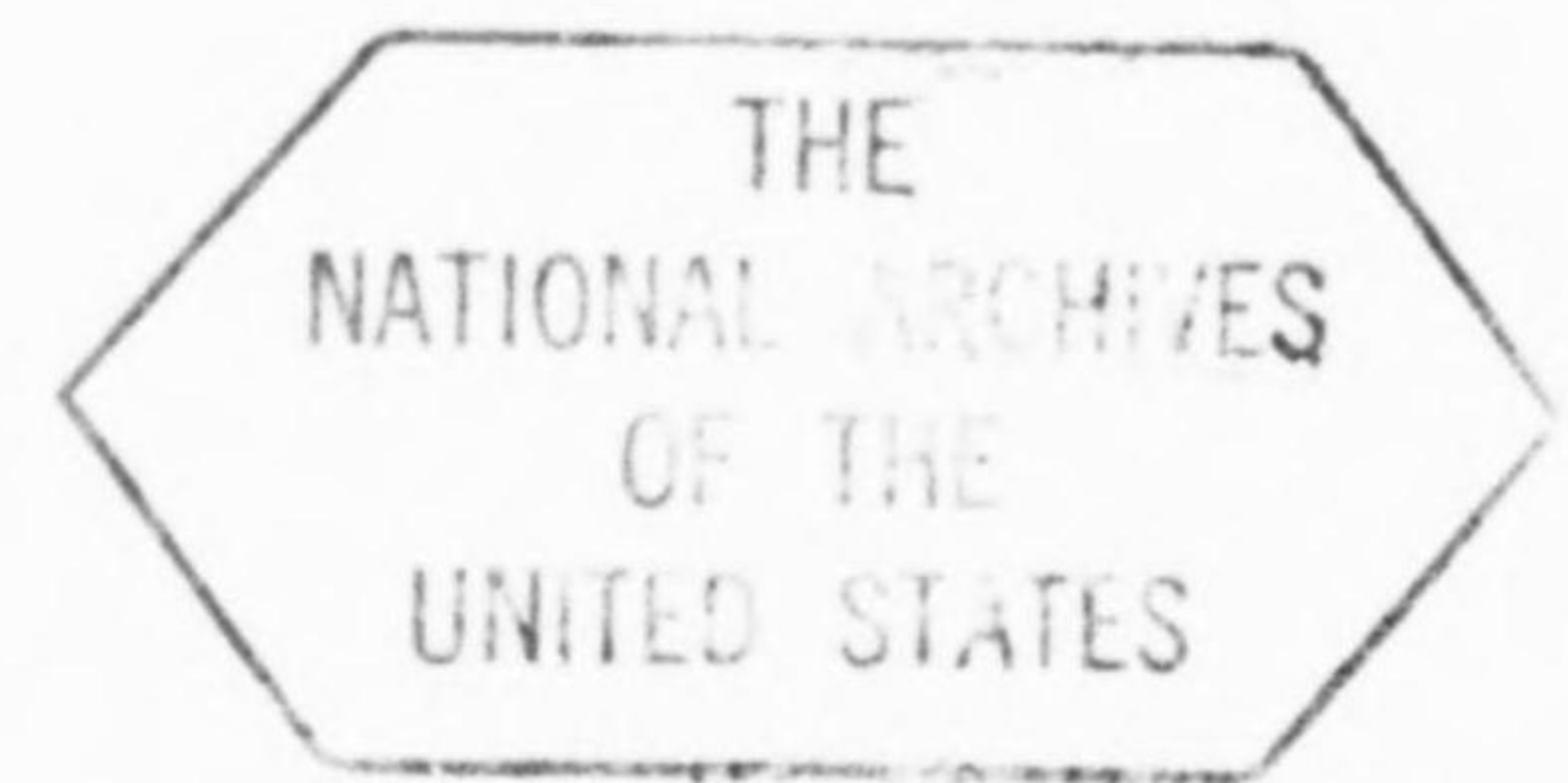

Established as the dormitory (1 storied building, 3 ken X 8 ken) attached to the school for the blind, deaf and dumb 1926, at the same time when the school building was constructed, this building was extended to 3 ken X 20 ken with the fund donated by Mr. Tetsutaro Yoshioka 1940 because of being too narrow, the business was carried on with activity. But sometime in 1945, 3 ken X 8 ken 1 storied building was broken off in accordance with the national policy of prevention of and evacuation from the war damage. It is expected that there will be enough room when a two storied building (3.5 ken X 9.5 ken) be constructed November this year. Therefore, in this occasion, this establishment is expected to be converted to an institution for the blind, deaf and dumb 1 November this year.

1. The purpose and policy of the management of this institution is to make the circumstantial conditions bright and healthy in order to bring up children healthily both in body and mind so that they may meet the request of the society.

2. Midday meal service:

The cooks are making efforts to give the children as much nutrition as possible with the minimum food stuff in close relation with the parttime doctor and nurses.

3. Health & Hygiene:

The parttime doctor gives the children physical examination once a month, nurses do the same when necessary, and nursery teachers pay attention to the health of children by observing their complexion every morning.

6. **Education is given to the inmates in the morning and in the evening and whenever necessary in relation with the Blind, Deaf and Dumb School.**
