IS PREPARED OFFICER. COMMENTS FOLLOW: A PERSONAL INTERVIEW WAS CONDUCTED AT 2130 Z, 6 MAR 67, WITH MR. [REDACTED] AT HIS HOME. HE APPEARS TO BE NORMAL IN ALL RESPECTS. HIS RETELLING OF THE UFO VIEWING DIFFERED ON A FEW SMALL POINTS FROM THE ORIGINAL REPORT, HOWEVER, IN THE MAIN IT REMAINED THE SAME. MANY OTHER PHENOMENONS WERE MENTIONED SUCH AS ALL THE DEER STAMPEDING OUT OF THE IMMEDIATE AREA DURING THE VIEWING PERIOD OF TIME, COYOTES AND WOLVES HOWLING

AREA GOING ON FOR THE PREVIOUS TWO WEEKS (VERIFIED WITH THE DISTRICT FOREST RANGER), THE HIGHLY CONCENTRATED MINERAL DEPOSITS OF PLATINUM, MERCURY, AND VANADIUM IN THE AREA, AND THE STRANGE HIGH PITCHED VOICE IN A FOREIGN LANGUAGE PICKED UP ON HIS WALKIE-TALKIE PLUS ITS FLAMING OUT WHEN HE TRIED TO CALL HIS WIFE FROM THE SCENE AT THE TIME. MR. [REDACTED] HAS REQUESTED NO PUBLICITY ON THIS MATTER AS IT MAY HURT THE POSSIBLE SALE OF STOCK IN HIS MINE.
