At the request of the Commander of Squadron #16, you are to circulate the following:

ABEL<sup>a</sup> and ANTONIO DIEZ<sup>a</sup>, average height, 120 pounds, between 20 and 25 years of age, have been linked to the assassin ROLANDO MASFERRER and they had infiltrated into the Rebel Army. During a search of [1 wd G] residence several 30-6 caliber bullets were found, along with a uniform of the Batista Army, a [1 wd G] Regiment #75 of Holguin, [1 wd G] of the Army, and a notebook with names of people wanted by the dictatorship.
