Explosives Burning Area at Osadano.

TO:

Governor of Kyoto Prefecture.

THRU:

Kyoto Liaison Office.

- 1. In response to your petition dated April 22, 1946 in which you requested release of the explosive burning ground at Osadano for agricultural purposes, you are advised that this request cannot be granted at this time. This area was located after considerable searching to find a burning ground which would be sufficiently isolated as to cause the least damage and inconvenience to all concerned during the burning and destruction of munitions of war. As yet, destruction of ammunition has not been completed, but every effort is being made to hasten its completion. The desirability of using this ground for farming purposes is well recognized, and considered highly desirable. At this moment, however, explosives are still being located by the occupation troops and no estimate can be made as to the date when the ground can be released. One factor which has hindered the completion of destruction of explosives is the fact that the occupation troops must search out and locate all of the ammunition which has been stored at various places. Your government can materially hasten the return of this ground to your control by informing this headquarters of accurate locations of all ammunition in the prefecture which has not yet been located.
- 2. Arrangements have been made so that all burning of explosives will take place during the afternoon at an hour to be determined by the officer in charge of the destruction. The name of this officer is Lieut. (jg) G. E. Metcalf, USNR, and it is suggested that local city officials contact Lieut. Metcalf at Osadano and after the hour has been determined, that all Japanese personnel be informed so that they may evacuate at the proper time. At all other hours of the day, the area will not be used by the occupation forces and cultivation of adjoining ground may be carried on with safety.

3. With reference to your request that the explosives be returned to the Home Ministry for conversion into fertilizer, certain ingredients of explosives have been returned to the Home Ministry for this purpose, but it is not felt that the completed product, such as gunpowder, is economically feasible to convert; consequently it will be destroyed.
