Lieutenant G. H. CONOVER in a PB4Y-1P aircraft of Fleet Air Photographic Squadron FIVE took off from Agana, Airfield, Guam, M. I. on 18 May 1945 at 0720 King to photograph enemy installations on Marcus Island. He arrived over his target at 1237 King and took good vertical photographs from an altitude of 15,000 ft. No enemy interception or antiaircraft fire was encountered. Lieutenant CONOVER returned to Agana at 1742 King.
