WAR DIARY

The First Provisional Antiaircraft Artillery Group, a unit of Fleet Marine Force, Pacific, was located at Camp Joseph H. Pendleton, Oceanside, California, at the beginning of the month. Headquarters Battery was the only unit of the Group.

1 - 4 December, 1945.

Continued making preparations for disbandment of the organization.

5 December, 1945.

Headquarters Battery, First Provisional Antiaircraft Artillery Group, Major Walter L. EDDY, Jr., U. S. Marine Corps, Commanding, was disbanded by authority of Area Special Order Number 354-45, dated 30 November, 1945.
