ABSTRACT OF FUR LAWS, 1948-49

Compiled by Frank G. Ashbrook, In Charge, Wild Fur Animal Investigations
Branch of Wildlife Research

The demand for all kinds of fur puts into the pockets of the American trappers millions of dollars a year. Until trapping begins these furs have not cost them a single effort. Speaking generally, fur animals transform uncultivated and otherwise useless materials into valuable peltries without expense or attention on the part of the tenants or land-owners. They are doing this throughout the United States. Moreover, several of the furry tenants of the land are useful in destroying farm pests. When the grain and hay have been harvested, farmers, their sons, and tenants take down their traps and set out to gather unearned increments of fur. This annual raw fur crop in the United States is worth from \$100,000,000 to \$125,000,000. About 15 percent of this amount, or approximately \$18,750,000, goes to the fur farmers who produce silver foxes and minks in captivity and part of it is also received by professional trappers. The greater portion 60 to 70 percent goes to farmers and farm boys.

There are some bad practices in the United States which have reduced the number and quality of fur pelts harvested. The use of poison, which kills many animals that are not found before the fur is spoiled; smoking animals out of their dens, which too often suffocates them instead of forcing them out; destroying dens, which either leaves the animals without suitable places in which to rear their young or drives them out of the locality altogether; trapping too early in the fall, which catches many animals having small, unprime pelts; trapping too late in spring, which destroys pregnant females and young as well as taking pelts which have become unprime or scarred. These are some of the more common undesirable practices.

Wild as well as domestic animals on the land require food and shelter, and while the farmer is providing as a matter of course for his domestic stock, he will, if wise, be mindfull also of the needs of his wild tenants. If he regards his barns as factories for producing milk, meat, and wool, he may as well consider the fox den in the hill pasture and the one in the big hollow sycamore by the creek as fur factories and preserve them accordingly. If he sells only his excess domestic stock, he also will cease trapping the wild "stock" while there are enough fur animals left on his land to insure another year's fur harvest.

The important point is to have people understand the possibilities of increasing their incomes in this way. When this is fully appreciated, they will uphold State laws that forbid the use of smoke, poison, or other chemicals in taking fur animals, and forbid the destruction of dens and trapping on the land of others without written permission. Such laws are already on the statute books of practically every State, but they need stricter enforcement.

Too many improperly handled furs are received in the raw fur markets. This results from the pelts being carelessly removed, either through lack of knowledge on how to skin the animals properly, or through wasteful negligence on the part of the trappers. Poor preparation of fur skins brings disappointing returns. Such waste can be reduced by following certain methods. To warrant the current, top-market price, the fur pelt should be prime, properly skinned, stretched, and dried, and free from dirt and excessive flesh and fat.

The tabulations in this leaflet of the open seasons in 1948-49 on fur animals and the summaries of the provisions of State and Provincial laws concerning possession, sale, shipment, export, and licenses have been prepared primarily to aid Federal officials in conducting investigations under the Lacey Act and enforcing its provisions and to answer inquiries of State game officials, trappers, and other interested persons. Every effort has been made to have the summaries correct, but the trapping seasons in many State and Provinces being subject to change by orders or regulations of the respective conservation authorities, it would be well for trappers and others concerned to apply direct to the proper agency for the latest information on State and Provincial laws, orders, and regulations before engaging in trapping or other activities involving fur animals or parts thereof.

The Federal Lacey Act is found on pages 41 and 42 of this leaflet.

ALABAMA

Open seasons

Possession and sale. Possession of furs, skins, or pelts by trapper, fur buyer, or dealer longer than 20 days after the close of the season is illegal, unless permission to keep furs longer has been granted by the Department of Conservation before the expiration of the 20-day period. No restrictions on sale of skins legally taken and on which State tax has been paid.

Shipment and export. No restrictions on skins legally taken and on which State tax has been paid.

Licenses. Resident, \$2.50. A nonresident is not permitted to trap. Fur buyers or trader must obtain a license based on gross sales of the preceding year, the minimum cost of license being \$25.

Trapping methods: Any means, except by means, aid, or use of set gun, a shotgun, artificial light of any kind, a steel bear trap or other trap with jaws having a spread exceeding 9 inches, poison, a dog (except polar bears in fur district 8, and wolves and coyotes in fur districts 5, 6, 7, and 8), a fish trap or net, or by setting any trap or snare within 25 feet of a beaver home or den or within 100 feet of a fox den, or by destroying or disturbing homes, houses, dens, or runways of such animals; provided that beaver may be taken only by means of a steel trap or snare and by persons over the age of eleven years, and wolves and coyotes may be killed by means of a rifle, shotgun, or pistol at any time, by any persons permitted to carry firearms.

Possession and sale: No restrictions on prime skins legally taken, except that beaver skins must be presented to an enforcement agent or other officer authorized by the Alaska Game Commission for sealing within 30 days after close of the season.

Shipment and export: No restrictions on skins legally taken, but no person who is engaged in fur farming or is a fur dealer shall possess or transport furs without a license. Packages containing furs must be marked to show contents in detail and the names and addresses of consignors and consignees, and shipper must deliver to freight or express agent or postmaster at shipping point, a statement showing contents of package and that no illegal or unsealed beaver skins are contained therein. Shipment of unsealed beaver skins is prohibited.

Licenses: Resident, trapping, \$3. Trapping license is not required of native Indians or Eskimos, nor of residents under 16 years of age.

Nonresident: General hunting, trapping, and game fishing, \$50.

Fur farm: \$2.

Alien: Special hunting, trapping, and fishing, \$100.

Fur dealer:(a) Resident, \$10; or association or co-partnership of residents organized under laws of the Territory, \$10 for each individual; (b) non-resident but citizen or national of the United States, or corporation, association, or co-partnership composed of citizens or nationals of the United States organized under the laws of the Territory or of a State of the United States, any member of which is a nonresident, \$100; (c) alien, or corporation, association, or co-partnership, not organized under laws of the Territory or of a State of the United States, any stockholder or member of which is an alien, \$500; (d) resident of the Territory and agent in charge of a station of a fur dealer of either of the classes (a), (b), or (c), or a resident itinerant agent of such dealer, \$10; (e) nonresident of the Territory but a citizen or national of the United States and agent in charge of a station of either of the classes (a), (b), or (c), or a nonresident citizen or national itinerant agent, \$100; (f) alien and agent in charge of a station of either of the classes (a), (b), or (c), or an alien itinerant agent, \$500: Provided, no license shall be issued to any agent whose principal has not procured a license in accordance with (a), (b), or (c).

Possession and sale: Open season, December 1st to January 31st, inclusive. Allowed to February 10th. to dispose of pelts.. Dealers may get permit to hold longer. Each dealer required to furnish Game and Fish Commission itemized list on or before the tenth day after the close of each season, giving number and kind and from whom all furs are purchased during season.

Shipment and export: Shipments must be plainly marked with name, address and license number of shipper, date of shipment, also the words "Fur-pelts."

Licenses: Resident using 12 or less traps, \$1.50; using more than 12 traps, \$20. Non resident, \$50. Fur dealer: resident, \$5; nonresident, \$50.

CALIFORNIA

Note-- Beavers, when damaging levees or canals may be taken under special permit issued by the Fish and Game Commission.

Coyote, opossum, raccoon, ringtail, skunk, wolf, wildcat, weasel, badger..... No closed season.

Pine marten (District 1 1/2 only)..... No open season.

Other fur animals (see exception)..... Nov. 16 - Feb. 28.

Exception-- No muskrat trapping on Colorado River lying within State of California.

Note-- Trapping license (license year, July 1-June 30) is required for trapping pine martens (except in District 1 1/2), minks, river otters, foxes, and muskrats for profit and cannot be killed during the closed season except when destroying property. Spike or sawtooth traps cannot be used.

Possession and sale--No restrictions on skins legally taken.

Shipment and export--No restrictions on skins legally taken.

Licenses-- Citizen, \$1; alien, \$2. Licensee must submit before July 1, a report of his catch, giving names and addresses of persons to whom pelts were sold or shipped.

Exception - There shall be no open season on weasel in the White River, Grand Mesa, Gunnison, Uncompahgre, Routt and San Juan national forest areas.

Possession and sale - Skins legally taken may be possessed during the open season and for 15 days thereafter. A permit is required for possession of skins by trapper and dealer 30 days after close of season. These permits expire on September 1 of the year of issue but may be renewed upon application on or before that date. The permit must accompany pelts sold by trappers or dealer whether sold within or out of the State. If the trapper or dealer disposes of only part of the pelts covered by the permit, the original permit must accompany the pelts disposed of and an application made for a new permit to cover the remainder.

Shipment and export - See Possession and sale.- Shipping tags provided by the State Game and Fish Commission must be attached to each bundle shipped, and each bundle must show name, post office address, and license number of shipper. Licensed trappers, dealers, and all persons must obtain a shipping permit from the Commission for each shipment of furs out of the State. The permit must be attached to each bundle shipped and must show the number and kind of each pelt in the shipment, names of shipper and consignee, and license number of consignor. Licensed dealers must furnish the Commission on or before June 30 next or at any time required to do so, a written report showing number and kinds of skins purchased from trappers and the amount paid. Fur purchased from other dealers shall not be included in this report.

Licenses.- Resident, \$3; nonresident, \$25. Fur dealer; resident, \$25; nonresident, \$50. The Commission may require licensees to submit such reports as it may deem necessary. Special resident trappers permits are issued without charge to children under fourteen years of age of a resident landowner or farm tenant when application is made to the nearest game warden or fur inspector in writing.

Licenses.- Resident: State-wide \$25.50; county, \$3.25; county other than that of residence; \$10.50. License is not required of resident Confederate veterans or of other residents 65 years of age or over. Nonresident: State-wide, \$100.50; county \$25.50. Applicants for licenses must report previous year's catch. Fur dealer; Resident, \$100, and \$5 for each agent or traveling buyer; resident local dealer, \$10; nonresident, \$500, or \$100 for each agent or traveling buyer or acting as agent for nonresident buyer. Dealers and buyers must report every two weeks the names of trappers from whom pelts were purchased, their license numbers, and the number and kinds of pelts purchased.

GEORGIA

Possession and sale - It shall be unlawful for any person to sell, exchange, ship, transfer, market, purchase, receive from another, or in any way deal with marten, mink fisher or otter pelts unless the same be officially tagged by an authorized officer of the Idaho Fish and Game Department. Tagging of all marten, mink, fisher, and otter will be done by conservation officers without cost to the trapper, with official fur tags of the Idaho Fish and Game Department.

It shall be unlawful for any person to have in his possession any marten, mink, fisher or otter pelts after fourteen days from the close of the respective trapping season for said marten, mink fisher, or otter, as set by the fish and game commission, unless the same are tagged with the official fur tags of the Idaho Fish and Game Department.

Licenses - Resident, \$5; nonresident, \$75; alien, \$150. Fur buyer; resident, \$5; nonresident, \$20.

Fur buyers and tanners of green hides of fur animals are required to keep a record showing name, address, and license number of each person, within or without the State, from whom such hides are received, date of receipt, and prices paid, which record shall be open to inspection by officers of the Conservation Department, sheriffs, constables, or other police officer.

Shipment and export. No restrictions on skins legally taken.

Licenses. For each 25 traps or fraction thereof -- resident, \$2; non-resident, \$10. Fur buyers, resident: wholesaler, \$50; retailer, \$10; traveling, \$10; fur buyer, nonresident, \$100; expiration date, January 31 of each year.

No other restrictions on skins legally taken.

Shipment and export. No restriction on skins legally taken, except that shipment must be labeled to show contents, and license must be exhibited to carrier.

THE FEDERAL LACEY ACT

An act of Congress of May 25, 1900 (31 Stat. 187) known as the Lacey Act, as amended by Public Law 772, 80th Congress on June 25, 1948, 18 U.S.C. sections 43 and 44, provides among other things, that -

§ 43 - Whoever delivers or knowingly receives for shipment, transportation, or carriage in interstate or foreign commerce, any wild animal or bird, or the dead body or part thereof, or the egg of any such bird imported from any foreign country, or captured, killed, taken purchased, sold, possessed contrary to any Act of Congress, or the law of any State, Territory, Possession, or foreign country, or subdivision thereof; or

Whoever transports, brings, or conveys from any foreign country into the United States any wild animal or bird, or the dead body or part thereof, or the egg of any such bird captured, killed, taken, shipped, transported, or carried contrary to the law of such foreign country or subdivision thereof: or

Whoever knowingly purchases or receives any wild animal or bird, or the dead body or part thereof, or the egg of any such bird imported from any foreign country or shipped, transported, carried, brought, or conveyed in violation of this section; or

Whoever, having purchased or received any wild animal or bird, or the dead body or part thereof, or the egg of any such bird imported from any foreign country or shipped, transported, or carried in interstate commerce, makes any false record or account thereof -

Shall be fined not more than \$500 or imprisoned not more than six months, or both; and the wild animals or birds, or the dead bodies or parts thereof, or the eggs of such birds, shall be forfeited.

§ 44 - Whoever ships, transports, carries, brings or conveys in interstate or foreign commerce any package containing wild animals or birds, or the dead bodies or parts thereof, without plainly marking, labeling, or tagging such package with the names and addresses of the shipper and consignee and with an accurate statement showing the contents by number and kind; or

Whoever ships, transports, carries, brings or conveys in interstate commerce any package containing furs, hides, or skins of wild animals without plainly marking, labeling, or tagging such package with the names and addresses of the shipper and consignee -

Shall be fined not more than \$500 or imprisoned not more than six months, or both; and the shipment forfeited.

§ 3054 - Any employee authorized by the Secretary of the Interior to enforce sections 43 and 44 of this title, and any officer of the customs, may arrest any person violating said sections in his presence or view, and may execute any warrant or other process issued by an officer or court of competent jurisdiction to enforce the provisions of said sections.

§ 3112 -Any employee authorized by the Secretary of the Interior to enforce sections 43 and 44 of this title, and any officer of the customs, shall have authority to execute any warrant to search for and seize any property used or possessed in violation of said sections and property so seized shall be held by him or by the United States marshal pending disposition thereof by the court.
