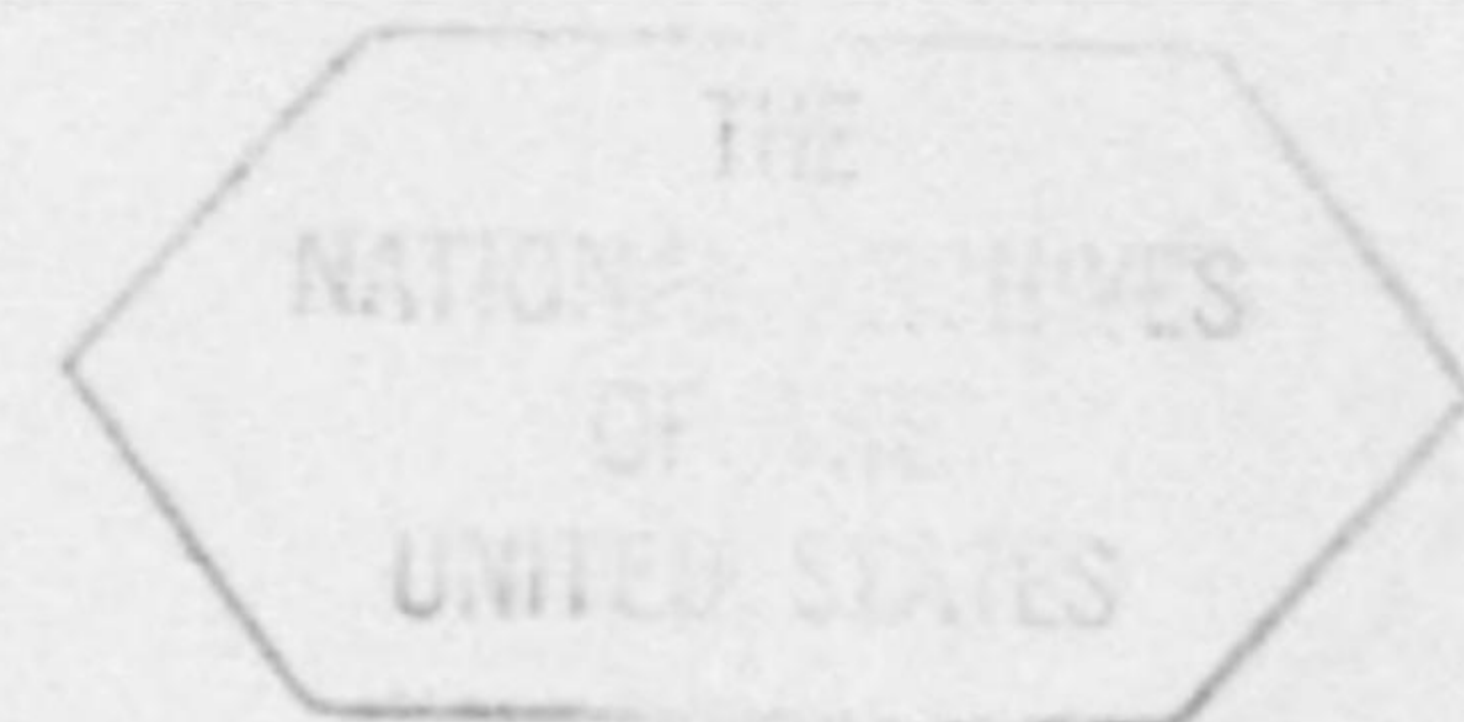

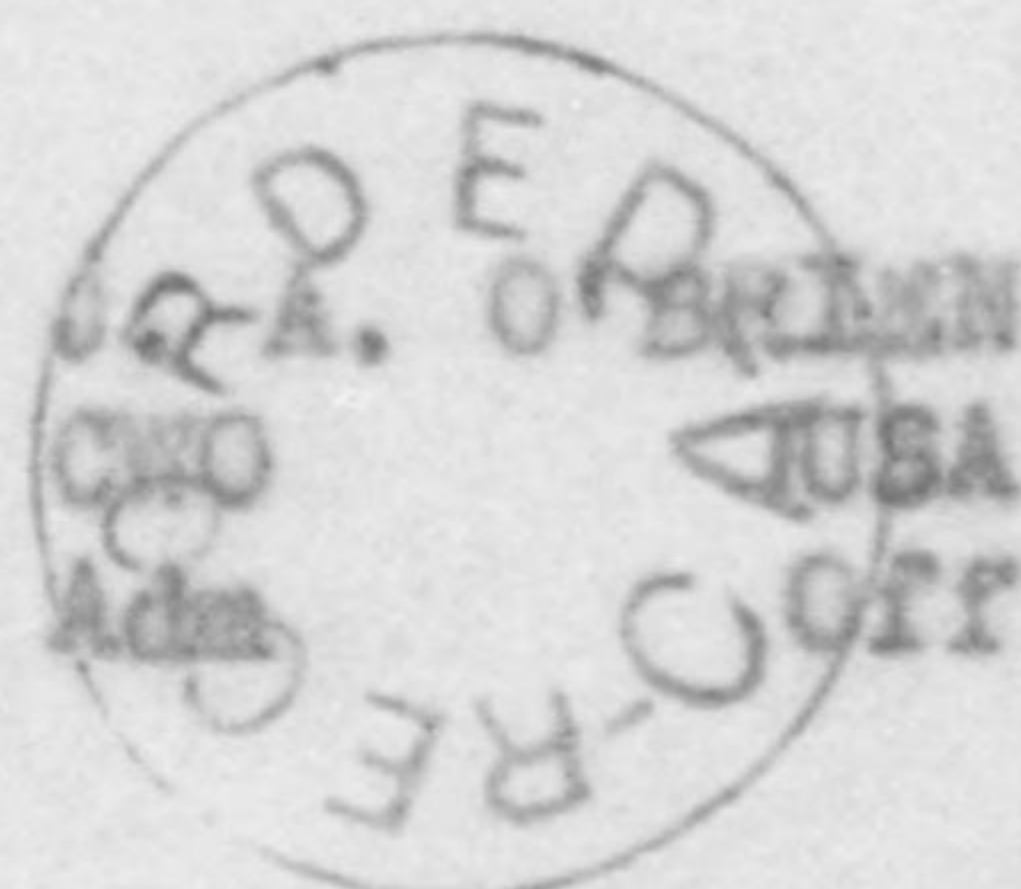

SUBJECT: Military Police Responsibility in Metropolitan Tokyo Area

TO: Commanding General, Eighth Army (Yokohama), APO 343
Commanding General, Headquarters and Service Group, General
Headquarters, Far East Command, APO 500

1. It is desired that, at a date mutually agreed upon by Commanding General, Eighth Army (Yokohama) and Commanding General, Headquarters and Service Group, military police responsibility in the following additional area of Metropolitan Tokyo be assumed by the Commanding General, Headquarters and Service Group: Itabashi Ku, Nakano Ku, Suginami Ku and Setagaya Ku. This action will give the Commanding General, Headquarters and Service Group military police responsibility in the entire area of Metropolitan Tokyo as outlined in heavy red line on the attached map.

2. It is further desired that Commanding General, Eighth Army notify this headquarters, the effective date of transfer of responsibility for the above mentioned area.
