SUMMARY OF CONTENTS

Japanese Courts-Martial Proceedings in Java
(Doc 2847)

This information was extracted from a file of records on military courts-martial proceedings by the Japanese Sixteenth Army against local residents in Java.

All available data is given on the defendants and witnesses in 34 proceedings, including name, nationality, race, age, birthplace, home address, present address and occupation. The date of arrest, charge and sentence are also given, as well as the date of execution for defendants who drew the death penalty. Most of the defendants are Indonesian or of mixed blood.

This material is preceded by a detailed summary of a specimen case. It illustrates the legal procedure employed by the Japanese in these courts-martial. They fall far short of "due process of law" by Western standards.

There is also a table listing Japanese personnel who participated in the courts-martial as presiding officers, members of the courts-martial, prosecutors, interpreters, clerks, jailers, etc. The table shows their rank, unit and duties and the proceedings in which they participated.

Part 1. A SPECIMEN CASE ILLUSTRATING JAPANESE COURTS-MARTIAL
PROCEDURE

(TN: This case was selected at random from Proceedings No 6, 1945. It is described here in summary form.)

The accused, J.A. Pieters, a retired lieutenant in the Dutch Army, aged 57, was arrested by the Bandung Japanese Military Police Unit, Saram, on 2 February 1945. His home address was given as Saparoa Village, Saparoa Island, Ambon.

During preliminary questioning on 3 December 1944, Pieters was accused of being a member of a Dutch guerrilla unit under the command of a Lt Colonel Arudenne of the Dutch Army, which had operated in that area. Pieters confessed cooperation with the guerrillas, and furnished details on both the numbers and activities of the guerrilla unit. There is no indication of the methods by which the Japanese military police got him to make these statements.

His statement, written in Japanese, bears both his signature and his fingerprints. He stated that his main reason for cooperating with the guerrillas was to insure his pension from the Dutch Government, should they be restored to the Indies. It is stated that Arudenne died a natural death, and Pieters took control in the subsequent organization financing and arming of the guerrilla unit.

Pieters was questioned again on 13, 15 and 16 December. He was arrested on 2 February 1945, and remained in prison until 27 February. The Japanese prosecutor, Lt Colonel HARA, made formal request for court-martial proceedings to HARADA Yūkichi, Commander of the Sixteenth Army, on 17 February 1945.

Pieters was brought before the Court-Martial at 0905 hours on 27 February. The court consisted of Major MISAWA Seiji, presiding officer; 2d Lt ONIKURA Tsunemasa, prosecutor; Capts KIDA Kuranosuke and TAKEBAYASHI Shunsuke, board members; SHIMANO Hisasuke, clerk, Capt TAKEBAYASHI Shunsuke, board members and Sgts TOKADO Jusuke and TAKAEASHI Shunzo, of the Bandung MP Unit. The interpreter was HAKAMURA Shiro.

Pieters was given no opportunity to give evidence in his defense and no witnesses were called. Judged guilty of treason, he was sentenced to death and beheaded the next morning, 28 February 1945. The execution was witnessed by the prosecutor, Lt ONIKURA, and by 1st Lt TETSUKA Yoshitane, medical officer.

The summary procedure adopted by the Japanese in this case and the apparently prejudiced manner in which the accused was handled are typical of the methods by which the other defendants were tried and punished.
