~~by~~ extremely boosting of Customs <sup>(duties)</sup>,  
~~limitation~~ etc. by resorting to <sup>the</sup> claim-  
for-compensation principle, or an  
economic <sup>isolation</sup> boycott principle, etc.

These preventive ~~steps~~ measures are increasingly  
being taken especially against Japanese

In order to improve
