1. Hans HERRSCHAFT, a former SE-Untersturmfuhrer and Obersturn of the SD, is living at Aschau-Werk, Muhldorf/Thm. He is reported to have collaborated closely on the work undertaken by Dr. MARCUX in the R.S.W. (a pro-Soviet movement). He further is reported to be vice president of the Association of

2. At the end of the war, he is alleged to have registered at Munich as a displaced person. At that time, he is reported to have had at his disposal large sums of money acquired from his work for the Rumanian Seguranza. His wife, a Rumanian citizen, allegedly left her country in 1949 with a great deal of luggage containing considerable gold and jewels.

3. For a while, he reportedly worked with a certain BAUMSCHEN, who claims to be a professor and lives at Munich. Ismaningerstrasse, No. 102 (telephone 46.11.01) for an office of the C.I.D. in Munich. As a displaced person, he allegedly obtained, shortly thereafter, the direction of a brick factory located at Muhldorf/Inn. Reportedly, he profited from this position to acquire a certain standing among the displaced persons whom he represented. In this connection, he allegedly was received on several occasions by Professor HEUSS and by the president of the federal parliament Herr EHLER.

4. As the firm which he directed allegedly went bankrupt, Subject reportedly decided to return to his work for the Siguransa.

MGLA-10613 listed both HERIGOHAFF and MARKUS as contacts of HOFFMAN, but did not state these two were known to each other.

- 3. There is no information in headquarters' files indicating that HER .SCHAFT has been connected with the RSU nor is there any additional information about that "movement" itself.
- 4. In connection with the "Association of Germans of Rumania," it was reported in MUNI-6226 dated 27 December 1951 that Herwart SCHEINER's "Association of Germans from Rumania" had voted on 11 September 1951 in Munich to join the "League of Free Rumanians" which has strong Iron Guary orientation. Hans HERRSCHAFT was appointed by the Association one of four representatives to the League from Germany. According to the Rumanian Desk, the League is a loose organization in which member groups appear to have retained some of their identity, and it is plausible that HERRSCHAFT is lice-mesident of the "Association of Germans from Rumania" as reported by
- 5. While there is no evidence here to substantiate report that HERRISCHAFT is working or has worked for the Rumanian Siguranta, the possibility need not be ruled out. It has been reported that he has an unsavory reputation and has been involved in blackmarket activities.
- 6. Headquarters has no record of BAUNSCHEN nor any information indicating that HERRSCHAFT has been received by Professor HEUSS or by Herr EHLER. It is felt that Frankfurt might be able to furnish information concerning these contacts.
- 8. Headquarters feels that Frankfurt may be able to provide additional information concerning HERRSCHAFT. Should any evidence come to your attention supporting the allegation that he is presently working for the Siguranta (which has been incorporated into the SECU ITATE), headquarters would appreciate receiving this information.

1. The following information was provided by on a contact made by Hans HERRSCHAFT with Emmerich STOFFEL, Charge d'Affaires at the Rumanian Legation in Bern:
a. Sometime during the week of 3-9 June 1956, Hans HERRSCHAFT went to Bern to see the Rumanian Charge d'Affaires, Emmerich STOFFEL. His object was to obtain from the latter, a Swabian from the Banat, a (letter of) recommendation for the SORICE firm in Frankfurt in order to enable him to do business with this firm. Subject did not provide any information concerning the nature of his business.
b. According to Subject, the interview allegedly took place in the following manner: Without having written or telephoned in advance, he went to Bern, Schlosslistrasse 7, and requested permission at the Rumanian Legation Chancellery to see Emmerich STOFFEL. Following a five minute wait and after having provided his identity, Subject was led by a certain (fnu) ALEXIU into the Charge's office. The latter received HERRSCHAFT very courteously and asked,
"You are from Guttenbrunn?" "Yes, but how do you know?" "Through Mr. (fnu) GHELTZ and through the refugee press. Do you wish to repatriate?" "No, Mr. Minister. I have a situation in Germany and I am not thinking about repatriating. The object of my visit is of another character." (Subject then explained, half in German, half in Rumanian, the reasons for his arrival in Bern.)

- c. (In German) STOFFEL said, "You have come to the right place, for our commercial branch office in Frankfurt depends on me. We wish to activate our trade with the German Federal Republic and we need a lot of collaborators. We are thinking, first of all, about Germans, natives of Rumania, for they are more familiar with the particular circumstances of our country. We are thinking about using them with no discrimination of a political or social nature. I know your family in Rumania; it has accustomed itself to the new state of things, and I shall willingly recommend you to our friends in Frankfurt/Kain."
- d. After stating this, STOFFEL called in a certain Dr. BOGDAN, with whom Subject discussed in detail the nature of the commercial affairs which he wished to handle with the Frankfurt branch. Before leaving, STOFFEL suggested to HERRSCHAFT that the latter visit him any time he wished.
- e. On his return from Bern, Subject went to the branch office (SORICE) in Frankfurt. There he learned that STOFFEL had indeed intervened on his behalf, for the presumed chief of the firm, a certain IONESCU, was very courteous with him. Subject received from the latter assurance that he would be included on the list of those to whom orders would be passed first of all.
- 3. _____ is only a casual acquaintance of Subject. We feel that this might be a lead worth exploiting and will press him to obtain additional details on HERRSCHAFT. A separate dispatch requesting traces on Subject and his cousin, Filip CHELTZ, and containing any MOB-POB traces, will be forwarded.
- Please note that, as in reference A, STOFFEL once again expressed himself for German. We are uncertain as to how well HERRSCHAFT speaks Rumanian; however, if he speaks the language fluently, we also wonder at STOFFEL's choice of language. This may be worth looking into.

SUBJECT: HERRS CHAFT, Hans, born on 10 October 1919 in Guttenbrunn, Arad district, Rumania, residence: Schneeglosckchenstmass 73, Munich.

REFERENCE: Your letter dated 4 February 1955, and our letter dated 9 February 1955.

Prior to 1939 SUBJECT was the leader of the Volkedeutschen (ethnic Germans) in Rumania. In the late thirties he studied at the Berlin Hochschule fuer Politik for several semesters, was a member of the Waffen-SS and a cowerker of the SD (Sicherheitsdienst = Security Service).

In 1948 SUBJECT came to the Federal Republic as a refugee. Until 1955 he resided in Agchau, Emehldorf Landkreis; since 24 October 1955 he has been living in Emnich at various addresses. His present address is Schneeglosokohenstrasse no. 73.

From 1950 to 1952 SUBJECT was a member of the Verband der Deutschen aus Bessenien (Union of the Germans from Rumania) and a coworker of the monthly "Brusche mum Westen" (published by that Union). In 1954 he wrote for the leftist paper "Deutsche Mationalseitung".

Recently SUBJECT repeatedly participated in meetings held by the organisation "Deutsche Mational-Wersamalung" (VDM).

Presently he claims to be a co-worker of the neutralist periodical "News Politik". He was present at the trial of Dr., Hans KAPPINGER in Passau, alleged-ly at the request of Wolf SCHEMER, publisher of the "News Politik".

Available information indicates that SHBJECT is making efforts to establish contact with various functionaries of rightist groups, without himself becoming active in these organisations;

The Law requests to be furnished all information available in regard to SUBJECT, especially such concerning possible intelligence centacts.
