
As directed by law, the statements are grouped alphabetically with reference to each office, and arranged in the general order in which the candidates' names will appear upon the official ballots.


The pamphlet is mailed only to registered voters whose names have been furnished to the secretary of state by the county clerks of the several counties.




served as Treasurer and Manager in the successful campaign of the late United States Senator, Frederick W. Steiwer.



THOMAS E. DEWEY

Republican, Candidate for Nomination for President of the United States



DEWEY—AN AMERICAN LEADER

In every public office he has held, Thomas E. Dewey has given the kind of courageous leadership the American people crave today. As Governor of New York—the second most important administrative job in the nation—he has

been a leader in progressive government. His record of accomplishment is a story of getting things done.

TAX CUTS

One of Governor Dewey's most phenomenal contributions to good government has been his sound fiscal policy. He has been able to cut taxes, build up surpluses and at the same time render state services that make the New York government the most progressive in history.

In four years he reduced the New York State debt by \$136,000,000 or 27 per cent.

Under Governor Dewey taxpayers saved \$780,400,000 through reduction of regular state taxes, mostly since the war. The personal income tax was cut 40 per cent and business income taxes were cut 25 per cent.

A \$623,000,000 surplus was built up in four years and has since been appropriated to make up for ten years of neglect of hospitals, highways and other State obligations.

New York State's appropriations in the fiscal year 1947-1948 totaled \$746,000,000. Of this \$340,000,000 was for state purposes and \$406,000,000 was returned to the communities of the State in State aids.

State aid to local governments has been increased by almost two-thirds under Governor Dewey.

The State income tax was humanized under Dewey to allow for deductions for medical expenses and life insurance payments and to include college students over 18 as dependents.

The Dewey Administration has put the State on a pay-as-you-go basis in its construction program. No new indebtedness for construction will be incurred except for State loans to localities for low rent housing.

BUSINESS GROWTHS

Governor Dewey has made the economic climate of New York State increasingly favorable to business growth and job opportunity.

The corporation tax and the unincorporated business tax were cut 25 per cent, effecting a tax saving of \$80,000,000 in two years. A special campaign to aid small business resulted in an increase of

A special campaign to aid small business resulted in an increase of 130,000 in the number of business firms in the State since V-J Day. Governor Dewey set up a practical program of individual assistance to small businessmen and to men and women starting a business of their own.

HELPS TO LABOR

The Dewey record that established a good economic climate for business also helped labor.

Over a million more people are employed in New York State today than were employed in 1939. The work week is shorter than during the war, but average net weekly earnings are higher than wartime peak.

Of the 6,751 cases handled by the State Labor Relations Board in the years 1943-1947, a total of 5,718—or approximately 85 per cent—were settled without necessity of a formal hearing.

By laws enacted under Governor Dewey, workers are protected in their right to employment regardless of religious creed, race or national origin, and women workers in New York State are paid on an equal basis with men for equal work. Workers get increased benefits in workmen's compensation, unemployment insurance and minimum wages.

FARM LEADERSHIP

New York State is a leading agricultural area and ranks second in the nation in dairy products produced. Governor Dewey is convinced that "no program for American agriculture is workable or can be successful unless that program has the full benefit of the experience and know-how of actual farmers." Since Dewey became Governor, the State has adopted more than

90 per cent of the recommendations of the State Conference Board of Farm Organizations. On Governor Dewey's recommendation, the State assumed all costs of rights-of-way and snow removal for State highways, saving millions of dollars to rural taxpayers.

To meet the current food crisis, he created a Food Commission that is helping farmers to save grain while maintaining production.

Governor Dewey believes in abundant production and opposes what he calls the New Deal's policy of "collapsing the farmer" as a remedy for economic collapse.

VETERANS PROGRAM

Long before the end of the war, Governor Dewey was building up an extensive program to help the returning veterans. More than one million veterans have benefited from these services.

New York State has provided 8,581 apartments for veterans and their families, in addition to housing for veteran college students, numbering 20,000.

To provide for veterans' education, New York State established 4,800 new scholarships for veterans, each worth \$350 a year for four years. Because of the foresight of the Governor in a program worked out with 87 college presidents, New York State colleges and universities were able to increase their enrollment by 100 per cent over prewar figures. More than 11,800 veterans were accommodated in three G. I. colleges converted from military installations.

Governor Dewey's Small Business Expansion Plan has offered aid and counsel to veterans and war workers planning to start their own businesses.

HOUSING AND RENT CONTROL

New York is the most active of all the states in the field of slum clearance and public housing for families of low income. By December 1, 1947, the State had lent or contracted to lend \$237,322,700 for 38 public housing projects to provide homes for almost 160,000 persons. In addition, the State will make cash payments up to \$13,000,000 a year, to maintain rents in the public housing developments as low as \$7 to \$8.50 per room per month, including hot water, heat, electricity and gas.

Due to Dewey's leadership New York was the only state with state rent control when O. P. A. lapsed in the summer of 1946. While rents shot up in other parts of the country, New York held the line until Federal Rent Control was restored.

LEADERSHIP IN EDUCATION

In the last four years state aid for education in New York State has been increased by 80 per cent.

Recognizing that a good education system requires well-paid teachers, Governor Dewey sponsored raises in teachers' salaries and provided state funds for 83 per cent of the total increase.

Vast increases were made in state scholarship, and a Dewey-appointed commission is paving the way for the first State university in New York's history.

Five institutes for vocational training have been established offering two-year courses beyond high school.

Thomas E. Dewey's record as Governor of New York State is ample evidence of his ability to provide the kind of good government which the people of the United States need and which they will demand in November, 1948.

HAROLD E. STASSEN

HAROLD STASSEN'S WESTERN APPEAL: Harold Stassen comes from an environment that has wide appeal in the West. Born and reared on a farm, he came up the hard way, with deep interest in the men who work. Essentially a builder, he possesses an infinite faith in the future of America and its resources. With the outlook of a Westerner, as one paper has said, he has noted with appreciation the rapid development of Oregon and other states in this area in recent years, envisioned a greater progress for the future and committed himself to measures that will contribute to this growth.

OREGON'S FUTURE: Development of power and reclamation resources, reforestation, revision of federal land policies and other measures which are of so much concern to the people of Oregon as they face the coming years will have his sympathetic interest and support. Power and reclamation development, he will regard, not as a government expense, but an investment for the future in a new and expanding country, sure to return dividends in new jobs and opportunities.

WHY STASSEN FILED IN OREGON: Upon filing in Oregon's primary as a candidate for the Republican nomination for President, Harold Stassen made clear his position on major issues. He set forth as highlights of his campaign:

1. The development of the resources of the Pacific Northwest through reclamation, hydro-electric power, flood control, and reforestation should be carried forward rapidly and efficiently.

2. Two members of the next Republican Cabinet should come from the eleven Western states and one of these should be the new Secretary of the Interior.

3. Our American economy should be kept free, and alert action should be taken by government to avoid high price booms and depression busts, and a humanitarian concern for the welfare of the people should be fundamental in government policy.

4. So long as the rulers of Russia follow their present obstructionist tactics, shipments of machine tools and electrical machinery and apparatus to Russia should be stopped.

5. The United Nations should be strengthened through a charter amending convention.

STASSEN—AS FARMER AND STUDENT: Harold Stassen's father and mother were thrifty, hard-working pioneers, of Scandinavian, German and Czech descent, in a little farming community near St. Paul, typical of the sturdy stock that helped so much to build the West. Harold, growing up on the farm, did all the tasks of the usual farm boy and looked ahead and planned. Taking jobs nights as a grease boy in a bakery, sleeping car conductor, whatever he could get, he worked his way through the University and soon was county attorney of his county.

STASSEN—AS GOVERNOR OF MINNESOTA: In a few years he was Governor of Minnesota, dealing with new and complicated problems with such abilities that the nation's Governors twice chose him as their chairman. He abolished the old spoils system that had prevailed in Minnesota and, with the cooperation of the Legislature, placed state employees on a basis of merit. He put through an act providing for a business manager for the state, with wide powers to control spending and prevent deficits, and placed at its head, men who could run the state on a business basis. Under his administration:

State debt was cut \$39,445,000.

Expenditures of the state government were reduced \$13,459,000.

The state tax on farms, homes and other property went down 45%.

Yet, because of the economies effected, increased funds were made available for schools, welfare and other vital services.

STASSEN—AS LABOR MODERATOR: Stassen tackled the tough problem of labor disputes. Possessing an innate sense of fairness and an unusual ability to reconcile differences and get people to work together, Stassen induced the Legislature to pass a constructive labor peace law during his first term as Governor in 1939 and showed that the state can, with a good law and honest administration, promote the peaceful settlement of labor disputes. Instead of conflict and turmoil, representatives of management and labor found that they could sit down around a table, through the conciliation plan provided in this

act, and work out a solution of their disputes. Men going on strike in Minnesota dropped 70% after adoption of this plan while strike losses in the nation were going up 90%.

STASSEN—AS OVERSEAS VETERAN: Deeply concerned about the threat to liberties everywhere in the wars engulfing the globe, Stassen made a characteristic decision. He resigned the governorship of Minnesota a few months after starting his third term, so that he might join others of his generation at the front, and soon was in active service as an assistant to Admiral Halsey. His courage, calmness and capacity for leadership exhibited itself in this new role, as in civilian life, and he was cited repeatedly for outstanding performance during Pacific naval battles.

STASSEN—AS UNITED NATIONS DELEGATE: While still in active service with Halsey, Stassen was called back to this country to participate in one of the biggest tasks ever undertaken by men. As one of the five American delegates to the United Nations conference, he helped to write the charter upon which millions of peoples everywhere have pinned hope for a world of peace. Press correspondents, watching his work, voted him one of the two outstanding delegates at the conference.

STASSEN'S AIM—NO MORE HARD TIMES FOR FARMERS: One of the great needs facing the country, Stassen says, is to develop a sound farm program to meet the new conditions confronting farmers. He believes that the small, family sized farm is the great source of America's strength and that it must be preserved. Our aim in developing a new program, he says, should be to place a minimum or floor under the income of the farmer on the small, family-sized farm. Said he:

"We must never again permit farm families who are doing a good job of farming to be bankrupt, evicted and broken."

If we are to prevent booms and busts in America, if the country as a whole is to prosper, Stassen says, agriculture must be placed on a more steady basis. Looking ahead, he says: "I am confident that with sound general policies, not only with reference to agriculture but our economy as a whole, there need never again be an agricultural depression in America." Our job, he believes, is to provide an economy in which farmers can produce to the maximum and continue to do so with reasonable safety.

AMERICA CAN PROVIDE NEW OPPORTUNITIES: No pessimist looking backward, Stassen possesses equal faith in the resources of America to provide new and greater opportunities for workers and business men alike. The changes needed to meet new conditions can be made, he says, within the framework of the principles that have made America a land of opportunity. Our primary purpose, he points out, ought to be to create an environment in which private enterprise can secure the maximum production because: "Production gives us our high standard of living and production is the real basis of the nation's strength."

AID FOR SMALL BUSINESS: The government should take constructive steps to aid and encourage small business, Stassen has insisted. The nation needs to have small businesses, springing up contantly, furnishing new jobs and opportunities, he has pointed out, and government should raise its revenues so that it shall "to the least degree restrict and hamper the flow of idle money into the creation of new products and new jobs." With proper measures, intelligently and promptly administered, he says, "there is no basic reason why our marvelous productive machinery ever should have runaway booms or shocking crashes."

UNDERSTANDING BETWEEN WORKERS AND EMPLOYERS: Conflicts between employers and workers, he would seek to smooth away. Interests of workers and employers are bound up together, Stassen says. Employers should not seek to crush workers, he believes. "Labor is people, men and women, fellow citizens," he said once. Workers neither should seek to cripple or block the progress of their employers, he says. All groups, he feels, must advance together. What is needed most in America, he has said, is a unity of the people and a willingness to pull together and advance the common welfare. A President of the United States, if he is a man of ability, vision and leadership, can do much to promote that essential unity.



In addition to professional groups, Governor Hall is a member of various civic, fraternal, and veterans organizations.
