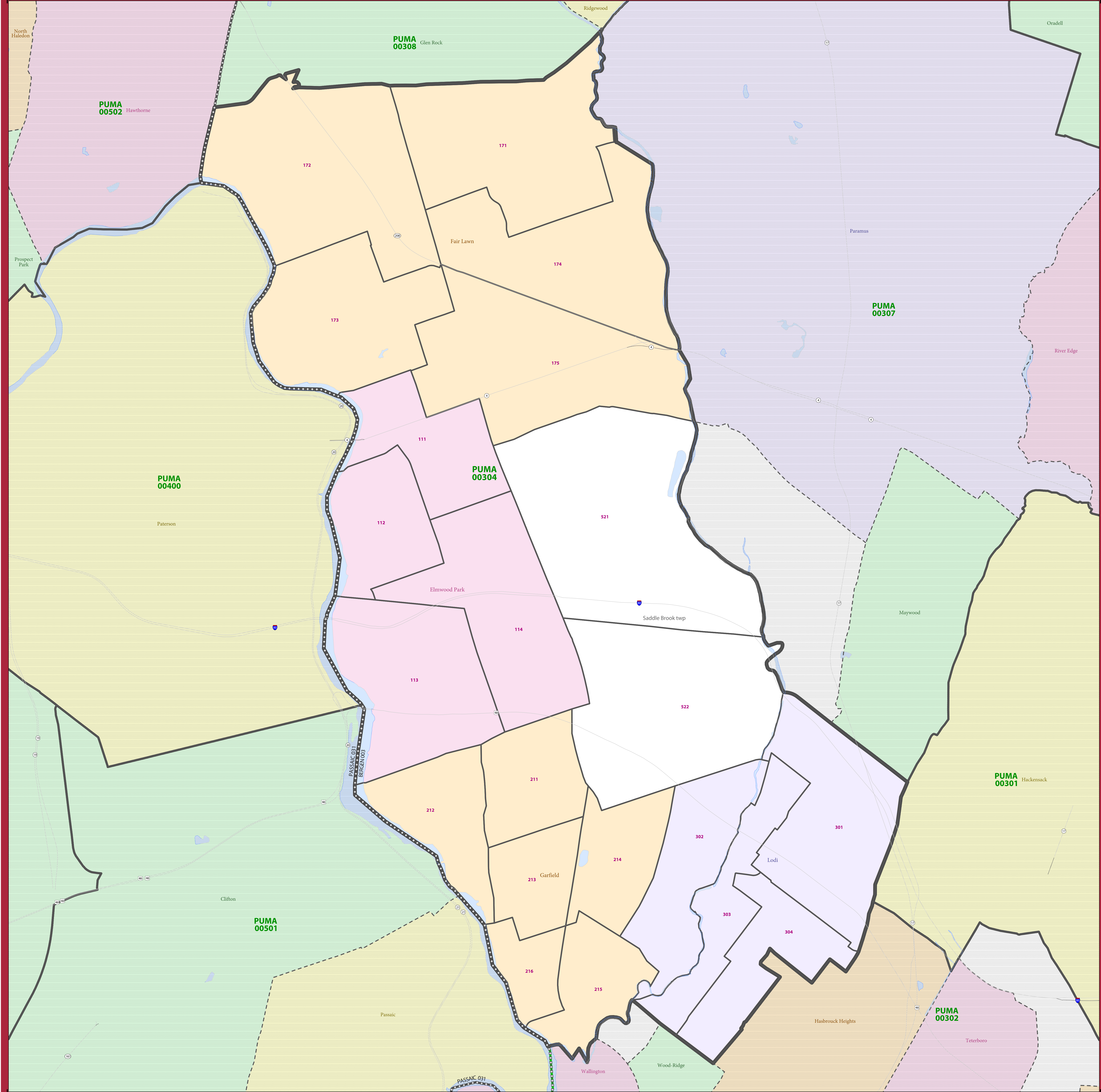


2010 CENSUS - PUMA REFERENCE MAP: Bergen County (West Central)-Fair Lawn Borough, Garfield City & Lodi Borough

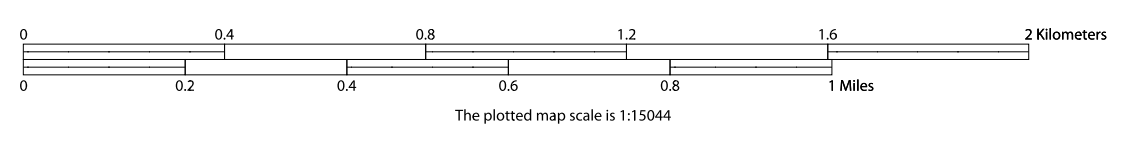
