ANGELO BRUNO, AKA, AR

REURAIRTEL JUNE FOUR SIXTYTHREE, IN CAPTIONED MATTER, INQUIRING AS TO THE POSSIBILITIES OF INSTALLING A MICROPHONE IN A PAY TELEPHONE INSTRUMENT SO THAT IT WILL NOT BE OBVIOUS TO TELEPHONE COMPANY CRAFTSMEN SERVICING THE PHONE.

IT IS THE LABORATORY'S OPINION THAT THE MERE PRESENCE OF EXTRA WIRES TERMINATING IN EQUIPMENT IN A PAY TELEPHONE INSTRUMENT WILL AROUSE THE SUSPICIONS OF TELEPHONE EMPLOYEES. HOWEVER, IF THE SOUND-TRAINED PERSONNEL IN YOUR OFFICE CAN HAVE FREE ACCESS TO THE TELEPHONE AND FURTHER IF THE WIRES SERVING THE TARGET INSTRUMENT PASS UP THROUGH A STANDARD BACKBOARD (BLACK MOUNTING BOARD) THERE IS A REMOTE POSSIBILITY THAT THE MISUR CONNECTION CAN BE MADE TO THE SPARE WIRES IN AN AREA BEHIND THE BACKBOARD AND THE ENDS OF EXTRA WIRES LEFT EXPOSED INSIDE OF THE INSTRUMENT. THIS APPROACH SHOULD MINIMIZE THE INQUISITIVENESS OF TELEPHONE EMPLOYEES. IT SHOULD BE POINTED OUT

THAT IF THIS TECHNIQUE IS PURSUED THE MICROPHONE MUST NOT BE

THE SPMT OFFERS ANOTHER POSSIBLE INSTALLATION TECHNIQUE. IT WILL
 BE NECESSARY FOR YOU TO FURNISH THE LABORATORY THE INSTRUMENT YOU
 PROPOSE TO INSTALL TOGETHER WITH THE TECHNICAL DETAILS OF THE CENTRAL
 OFFICE SWITCHING USED ON THE SUBSCRIBER'S LINE. THE INSTRUMENT WILL
 BE ALTERED AND RETURNED TO YOU ALONG WITH DETAILS FOR INSTALLATION.

IT IS NOT QUITE CLEAR, FROM THE REFERENCED AIRTEL, HOW YOU EXPECT
 THE MICROPHONE, LOCATED ON THE BACK WALL OF A RESTAURANT, TO COVER AN
 ADJOINING ROOM. IT WOULD APPEAR THAT, UNLESS YOUR SOUND-TRAINED AGENTS
 HAVE FREE ACCESS TO THE TELEPHONE EQUIPMENT LONG ENOUGH TO DIRECT THE
 MICROPHONE TOWARD THE TARGET ROOM, SOUNDS IN THE RESTAURANT WILL OVER-
 RIDE THE SOUNDS ORIGINATING IN THE TARGET ROOM.

YOUR SOUND-TRAINED AGENTS SHOULD CONSIDER THESE POINTS IN
 EVALUATING THE POTENTIAL COVERAGE IN THIS CASE.

NOTE: Philadelphia Sound-trained Agents have appointment with
 telephone company informants at noon Friday, to discuss gaining
 access to the target area. Therefore, this should be sent by
 urgent teletype to give Agents time to review and study Laboratory's
 views before the appointment.

Philadelphia proposes to install a microphone in a pay telephone
 located in a luncheonette operated by Frank "Sunffy" Iannarella, a
 member of La Causa Nostra. Angelo Bruno and other racket figures hold
 meetings in a back room of IANNARELLA's luncheonette. If installation
 appears possible, Philadelphia will request authorization to install.

FRANK "SNUFFY" IANNARELLA operates a luncheonette at 742 Christian Street, Philadelphia, Pa. IANNARELLA is known to be a member of La Causa Nostra. ANGELO BRUNO is known to be his superior in La Causa Nostra. ANGELO BRUNO's chief lieutenant, PHILIP TESTA, is known to frequent this luncheonette apparently in connection with the operation of ANGELO BRUNO's numbers racket. Since PH 623-C* has lost part of its potential as previously explained to the Bureau, ANGELO BRUNO and other racket figures hold meetings at 742 Christian Street, Philadelphia.

742 Christian Street has a public telephone on the rear wall of the luncheonette. Behind this wall is a small room where BRUNO has recently held a series of meetings. Through contact with the telephone company at the time the public telephone was installed at 742 Christian Street, an extra pair of wires was run and terminate inside of the telephone instrument. These wires are presently unconnected.

Philadelphia is considering the technical feasibility as follows:

Through contacts with the telephone company it has been ascertained that the company could cause the public telephone to not return money deposited in the event that a number called gives a busy signal. It is believed that after this has worked for a sufficient period of time, then

the subscriber will make an official complaint. The Philadelphia Division could be informed of this complaint. When the phone would need servicing, it is believed this would present a suitable pretext to exchange complete instruments whereby a misur could be installed utilizing the extra wires presently terminating in the telephone instrument.

It is requested that the Electronics Section advise the Philadelphia Division if they could alter a pay phone in such a fashion that it would not be obvious to a telephone company employee who might later service this phone. For information, it is to be noted that if the above is technically feasible, the installation will have to be made under pretext by sound trained Agent. Accordingly, complete instructions as to the method of making the installation would be needed. The Philadelphia Division believes they can obtain a public phone for the Bureau to alter in the event the alteration is possible.

The above is to obtain technical advice from the Laboratory and in the event it is proven to be feasible technically, the Philadelphia Division will submit appropriate request for the Bureau to make this installation. It should be noted that ANGELO BRUNO is a member of the Criminal Commission and has national prominence and this possible source would be extremely valuable particularly since the loss of the partial potential of PH 623-C*.

Sound Agents have an appointment for noon Friday with telephone company contact to pursue the above-described situation. In the event the Laboratory desires that specific information be obtained from this telephone company contact, it is requested that they notify the Philadelphia Division prior to date of the appointment.
