EXECUTIVE ORDER NO. 15
Series of 2020

ORGANIZING THE CORONAVIRUS DISEASE 2019 (COVID-19) PREVENTION AND CONTROL TASK FORCE IN THE MUNICIPALITY OF AGOO, LA UNION UNDER THE DISASTER PREPAREDNESS AND MANAGEMENT ACTION TEAM (DPMAT).

WHEREAS, as per provision of Republic Act No. 10121 or the Philippine Disaster and Risk Reduction Management Act of 2010, *"It is the policy of the state to uphold the people's constitutional rights to life and property by addressing the root causes of vulnerabilities to disasters, strengthening the country's institutional capacity for disaster risk reduction and management and building the resilience of local communities to disasters including climate change impacts;"*

WHEREAS, natural and human-induced disasters are becoming more frequent and climate change has further added to the unpredictability of these occurrences as well as their impact on society;

WHEREAS, the Philippine Government, through the NDRRMC, is therefore faced with the challenge to heighten its vigilance in ensuring that disaster risks are prevented or minimized and it is prepared to address the needs of affected population when disasters or emergencies occur;

WHEREAS, the National Disaster Risk Reduction and Management Council has issued Memorandum Circular No. 04-2012 for the Implementing Guidelines on the Use of Incident Command System (ICS) as an On-Scene Disaster Response and Management Mechanism under the Philippine Disaster Risk Reduction and Management System (PDRRMS);

WHEREAS, Executive Order No. 14-2018 reorganized the Municipal Incident Command System in the Municipality of Agoo, La Union;

WHEREAS, the DPMAT of Agoo, La Union was adopted by the Sangguniang Bayan;

WHEREAS, in consonance with Sec. 15, Article II of the 1987 Philippine Constitution and Section 16 (General Welfare Clause) of the Local Government Code, the Local Government Units (LGUs) are charged with the promotion of health and safety within their jurisdictions;

WHEREAS, reports would show the alarming cases and fatalities of COVID-19 worldwide;

WHEREAS, DILG Memorandum Circular No. 2020-018 (Guides to Action Against Coronavirus, series of DOH's Interim Guidelines for 2019 NCOV – Acute Respiratory Disease Response (significant to mention are: in Schools and HEIs, Communities, Hotels and Other

Similar Establishments, and Workplaces), and other directives from the various national agencies were issued in response to the growing concern of the fatal virus;

NOW THEREFORE, in view of the foregoing, and to fortify and in support to the implementation of the above-mentioned directives, **I, STEFANIE ANN Y. ERIGUEL, M.D.**, Municipal Mayor of Agoo, La Union, by the power vested in me by law, do hereby order:

SECTION 2. The COVID-19 Prevention Task Force shall assume and perform roles as:

1. Task Force Leader:
 - Shall be the overall in-charge of the actions and/or activities to be undertaken as part of the preventive measures on the spread of COVID-19; and
 - Shall facilitate and/or prescribe the meeting of the Task Force;
2. Information and Education Campaign Committee:
 - Shall be responsible in the development and crafting of IEC materials relative to the prevention and control of COVID-19; and

- Shall be responsible in the information dissemination thru proper posting and uploading of related materials in social media, and sharing important announcements, advisories, tips and relevant facts about COVID-19 to the constituency
- 3. Supplies Management Committee:
 - Shall be responsible in ensuring the availability of supplies and materials necessary for the prevention of COVID-19 within Agoo, La Union; and
 - Shall be responsible in the conduct of inventory and distribution of supplies within Agoo, La Union
- 4. Monitoring and Coordinating Committee:
 - Shall be responsible in the monitoring and reporting of the status of persons under monitoring (PUM) in coordination with the Barangay Health Emergency Response Teams (BHERTs); and
 - Shall be responsible in coordinating with the concerned agencies particularly with the Provincial Health Office, Department of Health and other line agencies

SECTION 3. This Executive Order shall take effect immediately.
