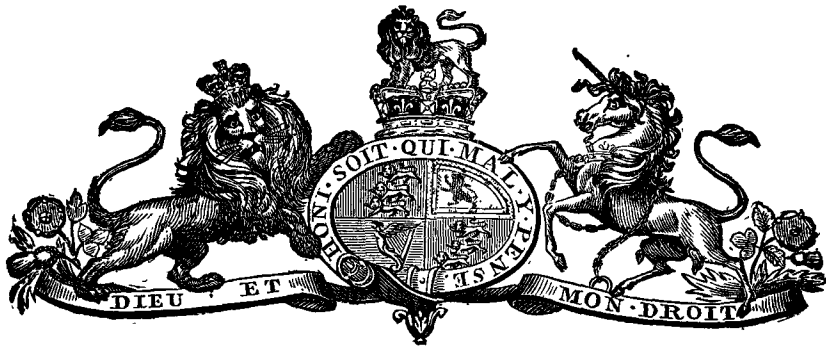

AN ACT to authorize the Sale pursuant to certain
Contracts in that behalf of certain Sections or
Blocks in the Province of Hawke's Bay.

[12th September 1870.]

WHEREAS on the purchase by the Government from certain
Aboriginal Natives of certain blocks of land in the Province
of Hawke's Bay it was part of the agreement for purchase that
certain persons occupying portions of such land under contracts entered
into before the extinguishment of the Native title should be enabled to
complete their titles to such land upon payment of certain specified
sums by way of purchase money and it is expedient to authorize the
sale as hereinafter mentioned of such parcels of land in pursuance of
the arrangements aforesaid

BE IT THEREFORE ENACTED by the General Assembly of New
Zealand in Parliament assembled and by the authority of the same as
follows—

1. The Short Title of this Act shall be "The Hawke's Bay Crown
Lands Sale Act 1870."

2. Notwithstanding anything to the contrary contained in the
provisions of any Act or Acts Laws or Regulations providing for or
regulating the sale disposal administration or management of Waste
Lands of the Crown in force in the Province of Hawke's Bay there
may be sold to the person and persons named in the Schedule hereto
the block or blocks section or sections of land whereof the number
and area are specified and set opposite to the name of such person or

persons respectively in the said Schedule at the price or prices also mentioned in the said Schedule and therein set opposite to the numbers and statement of the area of the said blocks and sections respectively and a Crown Grant for the same may be issued accordingly to the person or persons respectively named in the said Schedule.
