

March 2

Seitaro Uchida, deputy-mayor of Sakaide, visited this Section to report on the latest development of the dispute involved with the movement for Kanayama bloc to separate itself from Sakaide city.

The report may be summarized as follows:

In a conference held around the end of Feb. between members of the Municipal Assembly and representatives of the former village of Kanayama an agreement was reached that utmost efforts be made by the Municipal authorities to carry out as practicably as possible the "annexation terms" on which the former village had been annexed to the municipality.

However, when the latter filed a demand with the former that the Municipality lay ¥30,000,000 before the latter to guarantee the earliest realization of the promise, situations got worse again as the demand met with a flat rejection of the former until the dispute was as far from any solution as before.

In view of the fact that it is now the final tax-payment period for this fiscal year, this Section has given an urgent recommendation to the parties concerned that a reasonable compromise from a broader viewpoint of public interests be found by them as soon as possible.

March 2

A copy of the supplementary provisions of the By-law governing the payment of retirement allowances for city, town and village officials was distributed to each city, town and village throughout this prefecture.



- March 5            Announcement of the date for election of the head of Nagasumi-mura, Ayauta-gun was issued.
- March 9            Instruction was given to each city, town and village regarding the payment of retirement allowances for officers of municipal police.
- March 10           A consultation meeting on the election of Fisheries Adjustment Committee members under the Fisheries Law recently put into effect was held for all chiefs of city, town and village election management committees and of fisheries co-operative unions, in which special instruction was given them regarding procedures on proper investigations of eligible persons for the office.
- March 12           A short course on the revised Local Taxation system was given to all officials concerned of the three municipalities and of local offices (chiho jimusho).
- March 15           Investigation was commenced on financial situations of 'model cities, towns and villages' in relation to the state subsidies for balance of local finances.
- Announcement of the date of by-election to fill a vacancy in the Honjima Village Assembly, Honjima-mura, Nakatado-gun, was issued. (Honjima Village Election Management Committee)
- March 16           Tokujiro Iwasaki, head of Okada-mura, Ayauta-gun sent in his resignation on account of the charges of his having violated the Regulations on Temporary Measures for Security of Food.
- March 18           A copy of the draft of the Public Offices Election Law was distributed to each city, town and village election management committee.

March 20

This day was the deadline of the prolonged period for the application by foreign residents in this prefecture for re-issuance of Foreign Residents Registration certificates. The procedures were brought to completion satisfactorily with 100 per cent co-operation of all applying foreigners concerned, numbering 1,932 in total.

March 22

There was an informal verbal report of disorganization of the Kagawa Branch, the Democratic Party.

Instruction was given to each city, town and village regarding the management of the raffle: "Chiho Takara Kuji" (Local Treasure Lottery).

March 23

There was a report by telephone from the village authorities of Minami-mura, Nakatado-gun on the latest development of the internal conflict in the village in relation to the movement for its proposed annexation to Marugame city.

The summary of the report may be given as follows:

The movement which had been under way since March 8 by all groups involved led by Kuhara bloc opposing the proposal of annexing the village to Marugame city to oust Village Assembly Chairman Teruichi Fujisawa, leader of the radical party in favor of the annexation plan, from the village legislature took a decisive form when Setsuya Sato and several other representatives of the opposition group filed an application with the Village Election Management Committee for issuance of certificates for them to prove them to be legal representatives of those villagers exercising the right of recall against Chairman Fujisawa.



Thereupon, the head of the village and members of the Assembly did their best in a series of conferences to find a reasonable compromise to solve the internal conflict in a satisfactory manner, as the result of which, however, it was finally agreed that, the resignation of Chairman Fujisawa being inevitable in view of the situation as it stood, he should be advised to tender his resignation before he was forced to quit by vote of censure.

Meanwhile, the head of the village, holding himself responsible for the internal conflict in the village, sent in his resignation to the Village Assembly on March 13.

Under such circumstances, however, neutral members of the Village Assembly offered mediatorial efforts to solve the conflict by sponsoring a meeting several times from March 20 for members of the Village Assembly and representatives of the "Kuhara Party" to reconsider the question from a broader viewpoint.

As the result of these efforts on the part of the neutral party a compromise could be reached that the demand for quit-tance of Chairman Teruichi Fujisawa from the Village Assembly be withdrawn by the opposition groups on condition that he be degraded to an ordinary member of the legislative body, and also that, with the resignation of the village head turned down, he should be allowed to remain in office.

March 25

Election for the head Nagasumi-mura, Ayauta-gun was duly held.



## Remarks:


