TO : See Distribution

1. Authority: Letter, GHQ, SCAF, file AG 014.33 (20 Dec 48)GA, dated 20 December 1948, subject: "Repatriation of Korean Nationals."

2. GHQ, SCAF has approved the application for repatriation to Korea of the Korean Nationals listed in attached inclosure. The number of dependents authorized for repatriation is listed opposite the head of each family in the inclosure.

3. The Korean nationals are being informed of the approval of their applications by the Japanese Government. They are also being instructed that travel to Sasebo will be at their own expense and that travel from Sasebo to Korea may be made on Shipping Control Authority Japanese Merchant Marine repatriation vessels returning illegal Korean entrants to Korea.


4. Subject repatriates must report for repatriation shipping within ninety days of the date listed on the inclosure.

5. Korean repatriates are to be permitted to convert Japanese yen for Korean won not to exceed ¥ 1,000 per individual. Authorized accompanied baggage will not exceed 4,000 pounds per family unit of household items.

6. It is desired that routine supervision and surveillance be given this repatriation.

1. Authority: Letter, GHQ, SCAP file AG 014.33 (30 Dec 48) GA, dated 30 December 1948, subject: "Repatriation of Korean Nationals".

2. GHQ, SCAP has approved the application for repatriation to Korea of the Korean Nationals listed in attached inclosure. The number of dependents authorized for repatriation is listed opposite the head of each family in the inclosure.

3. The Korean nationals are being informed of the approval of their applications by the Japanese Government. They are also being instructed that travel to Sasebo will be at their own expense and that travel from Sasebo to Korea may be made on Shipping Control Authority Japanese Merchant Marine repatriation vessels returning illegal Korean entrants to Korea.

4. Subject repatriates must report for repatriation shipping within ninety days of the date listed on the inclosure.

5. Korean repatriates are to be permitted to convert Japanese yen for Korean won not to exceed ¥1,000 per individual. Authorized accompanied baggage will not exceed 4,000 pounds per family unit of household items.

6. It is desired that routine supervision and surveillance be given this repatriation.
