- 1. These Regulations may be cited as the Health Services (General Dental Services Fees) (Amendment) (No. 2) Regulations (Northern Ireland), 1957.
- 2. After Regulation 6 of the Health Services (General Dental Services Fees) Regulations (Northern Ireland), 1948(a) there shall be inserted the following Regulation:
 - "7. As respects any payment made to a dentist in pursuance of any advice of payment from the Board to a dentist, being an advice dated on or after the first day of May, 1957, there shall be paid by the Board to the dentist in addition to the fees payable to him in respect of general dental services provided by him, a sum equal to 2.6 per cent. of the amount of the fees determined under Regulations 3 and 4 in respect of those services."

EXPLANATORY NOTE

(This note is not part of the Regulations but is intended to indicate their general purport.)

These regulations provide for an increase in payments by the General Health Services Board to dentists, amounting to 2.6% of their gross income in respect of General Dental Services, which is the estimated equivalent of 5% of their net income (i.e., gross income less practice expenses).
