Informant also stated STONE and MILLER are continuing their bookmaking activities in Dallas, but only on a small scale. He stated they are handling this business strictly "hand to hand", meaning they are meeting their customers at various downtown Dallas restaurants and clubs where they furnish the customer the line they have by noon each day, and then immediately take the customer's bet. Informant stated they are not using any telephones in their business at the present time.

The above information was furnished to EDD HASKINS, IRS, Intelligence Section, Dallas, and Detective H. M. HART, Dallas PD, Intelligence Section, on 7/27/63.

RE: RUSSELL DOUGLAS MATTHEWS, aka. ITAR - GAMBLING (DL 166-102)

On 7/27/63, DL 185-C-TE advised that MATTHEWS was presently in possession of \$30,000 which he had obtained for "planting somebody", meaning murder for money. Informant had no further details concerning this, but stated he would attempt to ascertain same.

This information was immediately furnished to Detective H. M. HART on 7/27/63.

RE: JAMES WALTER CHERRY, aka. ITSP; ITSMV (DL 87-11447) (OO - KANSAS CITY)

On 7/26/63, it was ascertained at the Dallas County SO that a \$2,000 bond had been set on the local charges of narcotics possession pending against CHERRY. It had been set in Justice of Peace CHARLIE DAVIS' court. It was further determined that the detainer for the USM concerning ITSP charge outstanding at Baton Rouge, Louisiana, was still in effect, and CHERRY had been unable to make either the \$2,000 local bond or the \$10,000 recommended bond on the Federal charge.

Lt. FRANK CORNWALL, Dallas PD, was advised of above on 7/26/63 and he became quite irritated, noting that CHERRY is a three-time ex-convict, is charged with a matter which can result in a 30 to 40 year sentence and the small amount of bond would enable CHERRY to gain his freedom and immediately begin burglarizing again.
