MEMO FOR RECORD:

By IOM, 22 Aug 49, CI Div proposed to G-2 that ltr herewith reqsting DA approval of attached plan for microfilming CI Div files in order to reduce space requirements of such files and to facilitate future destruction or ready removal if such became necessary in an emergency. Ltr herewith approved by Gen Willoughby. According to Gen Willoughby's instructions, a copy of this letter is being furnished Mr. Aurell (CIA), requesting their Washington counterparts support of this program in view of their future interest in this matter. A copy of this ltr together with inclosures will be given to Gen Bolling, Director of Intelligence, DA, during his visit to FEC in Sep 49.

CONFIDENTIAL**Proposed Plan for Microfilming Essential G-2
FEC and SCAP Intelligence Documents****1. Purpose:**

a. The purpose of the following plan is to microfilm approximately Two Million Five Hundred Thousand (2,500,000) pages of intelligence documents presently in the files of the Assistant Chief of Staff, G-2, SCAP. (Central Files, CI Division).

2. The Plan:

a. Upon receipt of initial shipment of the film requested below, one camera will be used to start filming documents which are processed. These documents are, in the following priority:

(1)	201 Files -----	1,300,000	pages
(2)	Basic Intelligence Directives--	480,000	"
(3)	441st CIC Detachment Cases-----	110,000	"
(4)	Organizational Files-----	420,000	"
(5)	Dewey Decimal Files-----	40,000	"
(6)	G-2 Historical Files-----	100,000	"
(7)	MISD Files-----	50,000	"

Total 2,500,000

b. This operation is expected to take approximately one hundred and four (104) forty (40) hour weeks to complete.

c. The film will be developed by G-2 Photo Lab, SCAP.

d. Two enlisted men are presently being trained by a qualified Micro instructor to photograph, index and file Micro films.

3. Advantages:

a. Because of the recent man power cut it is necessary to reduce the size of our files so they can be more efficiently handled by fewer personnel. (Micro-filming the files mentioned in Paragraph 2b would reduce these files to approximately 1/16th of their present size and weight.

b. In case of emergency these files could more easily be destroyed or evacuated.

4. Remarks:

a. Until recently the supply of micro film used here has come from deactivated Air Force Units, however, this source is completely exhausted.

b. Our present supply of micro film is a very limited amount which was procured for us by the 71st Signal Battalion.

5. Recommendations:

a. Recommend approval of the plan outlined in Paragraph 2.

b. Recommend that DA direct the appropriate agency to make available to the Assistant Chief of Staff, G-2, SCAP, Three Thousand Four Hundred and Sixty-six (3,466), 100 ft. rolls of Kodak Microfile Safety Film, non-perforated, without opaque backing, for accomplishment of this plan.

c. Recommend that this agency also be directed to issue an additional Seven Hundred (700) rolls of film, described above, per annum to the Assistant Chief of Staff, G-2, SCAP for the accomplishment of routine work, which in the past has been possible due to the availability of micro film from sources that have become exhausted. This work consists of filming the following:

- (1) Foreign National Registration Cards.
- (2) Soviet Citizens and Mission personnel Registration Cards.
- (3) Japanese Intelligence and Police Records.
- (4) G-2, FEC, History.
