Eliminate current designation of U.S. 91 Business at Blackfoot and U.S. 91 Business at Idaho Falls. Both business routes overlap proposed relocation of U.S. 91.

Beginning at the intersection of U.S. 61 and a newly constructed facility south of Maquoketa, thence north over a newly constructed facility to the intersection of present U.S. Route 61 in Hurtsville.

Beginning at the intersection of U.S. 151 and a newly constructed facility southwest of Dubuque, thence over the newly constructed facility in a northeasterly direction to the intersection of U.S. 61 south of Dubuque, thence north overlapping U.S. 61 to the intersection of present U.S. 151 in Dubuque.

Beginning at the intersection of U.S. 218 and U.S. 34 and a newly constructed facility in Mt. Pleasant. Thence north over the newly constructed facility to the intersection of present U.S. 218 north of Mt. Pleasant.

Eliminate as a U.S. route number designation U.S. 227 from Carrollton to the intersection of I-75 north of Richmond. Entire route falls entirely within one State.

Beginning at the intersection of presently designated U.S. 20 in Springfield, thence northerly over Pasco Road to the intersection of Page Boule vard, thence westerly over Page Blvd. to the intersection of I-291, thence southeasterly over I-291 to the intersection of preeont U.S. 20 at Athol Junction. The numbering of U.S. Route 20 Alternate over Pasco Road and Page Blvd. to be discontinued.

U.S. Route 54 Relocation and Recognition of a Business Route

Beginning at the intersection of present U.S. 54 and newly constructed facility northeast of Eldon; thence in a southwesterly direction overlapping the newly constructed facility to the intersection of U.S. 54 and State Route 52 south of Eldon, existing U.S. 54, and U.3. 60 in Cabool.

Beginning at the Intersection of 11.S. 395 and a new facility north of Reno, thence over a new facility in a southerly direction to the intersection of present U.S. 395 south of Reno. Presently designated U.S. 395 to be redesignated U.S. 395 Business.

Discontinue present designation of U.S. 64 from Taos to Espanola and Santa Fe . Extend the U.S. 64 designation from Taos overlapping S.R. 3 and 111 to Tres Piedras, thence over S.R. 553 to Tierra Anarilla, thence overlapping S.R. 17 and U.S. 84 to the intersection of U.S. 550 in Farmington.

Beginning at the intersection of present U.S. 60 and S.R. 123, thence south over S.R. 123 to the intersection of Adams Blvd. in Bartlesville, then east over Adams Blvd. to the intersection of present U.S. 60 and U.S. 75 in Bartlesville.

Beginning at the intersection of present U.S. 62 and new facility west of Snyder, thence easterly over the newly constructed facility to the intersection of present U.S. 62 east of Snyder. Presently designated U.S. 62 through Snyder to be redesignated as D.S. 62 Business.

Eliminate the current U.S. Route number designation of 191 from Brigham City, Utah to the intersection of D.S. 26 in Idaho Falls, Idaho.

Eliminate the current designation of U.S. 30 from the intersection of Granger Junction, Wyoming, to Burley. Idaho. This route is generally concurvent with I-80 and I-80N.

Redesignate as I-380 the route presently designated as I-81E from Mt. Pocono to Scranton and extend the terminus of I-84 from the present intersection of I-81E to the intersection of I-81 in Scranton. This section to overlap the designation of I-380.
