It has been noted that most of the cars driven by LA ROCCA are registered under the name of his wife, MARY S. LA ROCCA, or the North Star Cement Block Company at Pittsburgh, Pa. A Thunderbird driven by his adopted son may be registered in the name JOHN S. LA ROCCA.

Philadelphia at Harrisburg is requested to advise whether a search under the name of the subject and all known aliases, as well as for his adopted son, his wife and the North Star Cement Block Company for 1961-1962, would be feasible so that the Intelligence Unit of the Internal Revenue Service may be advised. It should be noted that prosecution against LA ROCCA is being sought for the early portion of the year, 1964.
